

## EXTENDED ABSORPTION OF LIOTHYRONINE FROM POLY-ZINC-LIOTHYRONINE (PZL) IN HUMANS

## Abstract

**Background:** Liothyronine (LT3) has been increasingly used in combination with levothyroxine (LT4) in the treatment of hypothyroidism. A metal coordinated form of LT3, known as poly-zinc-liothyronine (PZL), avoided in rats the typical T3 peak seen after oral administration of LT3.

**Objectives:** To evaluate in healthy volunteers (i) the pharmacokinetics of PZL-derived T3 after a single dose, (ii) the pharmacodynamics of PZL-derived T3, (iii) monitoring for the adverse events; (iv) exploratory analysis of the sleep patterns after LT3, PZL or placebo administration.

**Methods:** 12 healthy volunteers 18 to 50 years of age were recruited for a Phase 1, double-blind, randomized, single-dose placebo-controlled, cross-over study to compare PZL against LT3 or placebo. Subjects were admitted three separate times to receive a randomly assigned capsule containing placebo, 50-mcg LT3, or 50-mcg-PZL, and were observed for 48h. A 2-week washout period separated each admission.

**Results:** LT3-derived serum T3 levels exhibited the expected profile, with a  $T_{max}$  at 2h and return to basal levels by 24-36h. PZL-derived serum T3 levels exhibited a ~30% lower  $C_{max}$  that was 1 h delayed and extended into a plateau that lasted up to 6h. This was followed by a lower but much longer plateau; by 24 hours serum T3 levels still exceeded  $\frac{1}{2}$  of  $C_{max}$ . TSH levels were similarly reduced indistinguishably in both groups.

**Conclusion:** PZL possesses the necessary properties to achieve a much improved T3 pharmacokinetic. Drug product development of PZL should improve the delivery of T3 even further. PZL is on track to provide hypothyroid patients with stable levels of serum T3.

## Introduction

For decades, hypothyroidism was treated with desiccated extracts of porcine thyroid glands, which contain T4 and T3 (1)(2). With the development of TSH radioimmunoassay and the discovery that humans activate T4 to T3 (3), treatment with levothyroxine (LT4) became the standard of care (4)(5). Nonetheless, deiodination of T4 to T3 may not be sufficient to account for the normal thyroidal secretion of T3. First noticed around 1974 (6), subsequent studies revealed that LT4-treated patients maintain a ~10% lower serum T3 levels (7,8).

Some LT4-treated patients complain of residual symptoms of hypothyroidism, such as poor quality of life, impaired cognition, difficulty with weight management, and fatigue, despite maintaining normal TSH levels (9-11). LT4-treated patients do weigh ~10 pounds more (7), have a slower rate of energy expenditure (12), show slightly higher serum cholesterol levels (13), and are more likely to be on therapy to lower cholesterol levels (14). The extent of which these lower T3 levels contribute to the residual symptoms is unknown. In LT4-treated thyroidectomized rats, tissue euthyroidism only occurs after normalization of serum T3 (15). Such clear cut evidence is not available for LT4-treated patients. Nonetheless, the available data prompted professional task forces to recommend the development of a sustained-release T3 preparations (4,16).

Liothyronine (LT3) has been commercially available since 1956, but a lack of long-term safety data has limited its use (4). The pharmacokinetics (PK) of current LT3 products also raises potential concerns (17-19). A tablet of LT3 causes a T3 peak 2-3h after dosing, which sometimes is associated with palpitations, depending on the dose of LT3. Notwithstanding, little evidence exists of adverse reactions (AR) to appropriate doses of LT3 and a growing number of endocrinologists are prescribing LT4 plus LT3 to treat hypothyroidism. The analysis of ~1,000 hypothyroid patients on combination therapy for up to 1 year did not reveal an increased frequency of AR when compared to LT4-treated patients (2). A retrospective analysis of 400 patients on LT3 for several years also did not reveal concerning trends (20). Thus, professional medical societies have become more accepting of combination therapy (4,16).

In pre-clinical studies we tested a new technology that employs metal coordination chemistry to produce a slow-release form of LT3. Coordinating T3 with metals under specific conditions yields a polymeric complex that adheres to the intestinal mucosal lining, creating a depot from which T3 is slowly released and absorbed over time. Studies in rats validated these concepts using oral administration of PolyZincLiothyronine (PZL) (21).

PZL is a prodrug that contains T3, which acts as a tridentate ligand binding to zinc via the participation of the amino acid group and the phenol group. When the phenol group is deprotonated, it acts as an additional zinc-binding site, thereby expanding coordination mode and favoring the formation of supramolecular structures. Extension of the intestinal transit time results from the inherent mucoadhesive properties of supramolecular metal coordinated (MC) complexes and the slow release of T3 from the MC complexes via ligand exchange (e.g. hydrolysis). The released T3 is absorbed into the bloodstream as T3 would normally (22). MC molecules adhere to the mucosa by mechanisms that include coordinate covalent bonding, hydrogen bonding, halogen bonding, metal-halogen bonding, and electrostatic interactions (23).

Here we report the first double-blinded placebo-controlled cross-over study of PZL in volunteers, that investigates the PK and pharmacodynamics (PD) of PZL-derived T3 in humans.

## Material and Methods

This clinical trial was conducted under the Food and Drug Administration (FDA) exploratory investigational new drug (IND) application (IND-137796), and approved by the University of Chicago IRB and Clinical Research Center (CRC) committees (IRB20-1341).

### **Objectives:**

- (i) To evaluate the PK of PZL-derived T3 after a single dose of PZL by repetitive measurements of serum T3 levels.
- (ii) To evaluate PD of PZL-derived T3 through monitoring of serum TSH and free T4 levels, as well as heart rate and blood pressure.
- (iii) To evaluate the occurrence of AR or adverse events (AE) to a single dose of PZL through clinical interview and examination, metabolic panels, electrocardiogram.
- (iv) Exploratory analysis of the sleep patterns.

**Investigational Plan:** This is a Phase 1, double-blind, randomized, single-dose placebo-controlled, cross-over study to test PZL in healthy volunteers.

**Recruitment and screening:** Healthy men and women volunteers 18 to 50 years of age, who self-report sleeping at least 7-hrs/night but no more than 9-hrs/night, between 22:00 and 08:00, were recruited from the community through advertisement. BMI <30 was an initial inclusion criterion, however as it became difficult to identify females not taking oral contraceptives, a female with BMI 33 was included to have enough female representation in the study.

Initial screening involved a telephone questionnaire. Exclusion criteria included the use of steroids or any medications known to affect thyroid hormone (TH) absorption or metabolism, or thyroxine-binding globulin, dietary utilization of kelp, soy, and/or biotin, pregnancy, lactation, use of oral contraceptives, previous diagnosis of sleep disorders (including obstructive sleep apnea (OSA)), prediabetes or diabetes, history of endocrine dysfunction or psychiatric, cardiovascular, or eating disorders, gastrointestinal disease that could affect the absorption of T3, drug or nicotine use, habitual alcohol use of >2 drinks per day, caffeine intake of >500 mg per day, history of bariatric surgery, weigh >100Kg, dietary restrictions, night shifts, or crossed any time zones in the month before the study.

Subjects who passed the initial screening visited the CRC, where they consented to the study. To qualify, individuals were determined to be in good health based on the medical history, physical examination. They underwent a 12-lead electrocardiogram (ECG), complete blood count (CBC), complete metabolic panel (CMP), and thyroid function tests (TFTs), i.e. serum TSH, FT4, total T3, and thyroid antibodies to thyroperoxidase and thyroglobulin. Women underwent a screening pregnancy test. Participants were eligible if ECG, CBC, CMP, and TFTs were normal.

**Investigational product, dosage, and delivery system:** Identical, off-white, size-0 capsules (Capsugel® Vcaps®, Lonza CHI) coated for duodenal delivery of contents were prepared by Catalent Inc (San Diego, CA). They contained current good manufacturing practice (CGMP) grade placebo (sterile excipient powder mixed with CGMP grade zinc chloride), PZL (56-mcg), or Na-T3 (53-mcg) prepared by Synthomics, Inc. (Blacksburg, VA); the amounts of PZL and Na-T3 were calculated to contain 50-mcg LT3, based on previous clinical experience with LT3 (17)

and recommended dietary allowance (RDA) of zinc (10 mg/day). Capsules were labeled using 3 different alpha-numerical codes, and delivered to the Investigational Drug Service Pharmacy at the University of Chicago (kept at 4°C until use).

Admission to the CRC: Each volunteer was assigned (blindly and randomly) to a pre-defined sequence of treatment arms. In the morning of the trial (overnight fasting), subjects were admitted to the CRC, received their treatment, and were observed for 48h in the CRC. Subjects had timed blood draws and were monitored 3 times a day for AR through vital signs and physical exam (including neurological screening); an ECG was obtained previous to discharge. After discharge, these individuals returned to the CRC for a 7-day follow-up visit, for physical examination, ECG, CBC, CMP. After a 2-week washout period, volunteers were readmitted to one of the remaining treatment arms and the cycle was repeated. Thus, all individuals completed the three treatment arms, separated by 2-week washout periods.

Pharmacokinetics: An intravenous catheter was inserted into a forearm vein and left in place for serial blood sampling collected at specified times post-treatment and sent to the central laboratory for T3, FT4 and TSH levels using standard clinical bioanalytical methods. A total of 13 blood samples were drawn: -30 min, -15 min, 1h, 2h, 3h, 4h, 6h, 8h, 12h, 18h, 24h, 36h, and 46h.

Pharmacodynamics: Systolic and diastolic arterial blood pressure, as well as pulse, were measured at 30-minute intervals during the first inpatient day from the non-dominant arm using ambulatory monitoring equipment (Oscar II, SunTech Medical Instruments).

Sleep timing, duration, and fragmentation were assessed using wrist actigraphy monitors (Actiwatch Spectrum, Philips Respironics, Bend OR, USA) (32). Actiwatches were worn during the 2-day inpatient sessions and for the subsequent 4 outpatient days for a total of 6 days. Our primary measure of habitual sleep timing was at the midpoint of sleep, but we also calculated nocturnal sleep duration and indicators of sleep quality (sleep efficiency, sleep fragmentation). For screening, the Pittsburgh Sleep Quality Index (PSQI) was administered to assess sleep quality (24) and the Horne-Ostberg questionnaire to assess chronotype (25). Participants also completed a set of four validated computerized visual analog scales (0 to 10 cm) to assess hunger, appetite, mood, affect, sleepiness, and impulsivity throughout the in laboratory sessions, as we have previously reported (26) (27).

ARs and AEs: An independent safety monitor (Dr. Richard Abrams, Rush University Medical Center, Chicago IL) accessed all data and knew the treatment assignment of each volunteer. Based on clinical experience with the use of LT3 (28-31), he conferenced with Dr. Dumitrescu after each study arm was completed and, in all cases, recommended the continuation of the studies.

Statistical methods: For the sample size calculation, we used summary statistics (mean, SD, and inter-quartile range) for  $C_{max}$  and  $T_{max}$  from a previous study for LT3 (17). Based on pre-clinical data, we expect PZL-derived T3 to exhibit a decrease of 30% in  $C_{max}$  (mean = 242) and an increase in  $T_{max}$  of ~6h (mean = 8.5). Assuming an SD of 100 for  $C_{max}$ , we found that a sample of 12 individuals can detect a 30% decrease or higher in the mean  $C_{max}$  with a power of 90%. We further found that this sample of 12 individuals can detect an increase of 1h or more in the mean  $T_{max}$  with a power of 90%. Data analysis was conducted using statistical software R, and mixed-effects regression models were fit using the R package lme4 (33).

## Results

13 individuals were screened and 12 ultimately consented and were enrolled in the trial (Table 1). They were  $31.6 \pm 9.9$  years old; 4 were females. 11 individuals completed the trial as planned, given that one individual missed a study arm and was excluded.

### T3 pharmacokinetics

#### *Descriptive statistics and two-way ANOVA*

In the LT3-arm, T3 serum levels increased from a baseline of  $\sim 110$  ng/dl to a  $C_{\max}$  of  $\sim 300$  ng/dl between 2-3h ( $2.4 \pm 0.53$ ) after dose delivery (Table 2; Fig. 1A). T3 levels decreased from  $\sim 300$  to 150 ng/dl by 12h, and then much less (dropping to 130 ng/dl) for the next 12h (Table 2; Fig. 1A). It took  $\sim 8$ h for the serum T3 levels to decrease to  $\frac{1}{2}$  of  $C_{\max}$  (Table 2; Fig. 1A). These two distinct phases of elimination are compatible with a two-compartment model for this experimental system (17)(19). T3 levels returned to baseline between 36-46h (Table 2). Two individuals exhibited atypical T3 profiles ( $C_{\max}$  delayed by 6-24h) for no identifiable reasons and were excluded from further analyses.

In the PZL-arm, T3 serum levels increased from a baseline of  $\sim 110$  ng/dl to a  $C_{\max}$  of  $\sim 220$  ng/dl between 2-8h ( $4.7 \pm 2.3$ ) after dose delivery (Table 2; Fig. 1A).  $T_{\max}$  was delayed in the PZL-arm by 1h (Table 2; Fig. 1A). T3 levels decreased slowly from  $\sim 220$  to 170 ng/dl up until 12h and then slowed down further, dropping to 150 ng/dl for the next 12h (Table 2; Fig. 1A). By 24h serum T3 levels still exceeded  $\frac{1}{2}$  of  $C_{\max}$ . T3 levels returned to baseline by 46h (Table 2).

In the placebo arm, T3 levels ranged from a baseline of  $\sim 115$  ng/dl to 100 ng/dl by end of the study (Table 2; Fig. 1A).

#### *Mixed-effects models*

We next fitted mixed-effects models for T3 levels under each time point considering patients as random effects to incorporate the repeated measures into the model. This model is suitable for individually randomized trials with longitudinal continuous outcomes. The analysis confirms that the T3 levels in the LT3-arm have a steeper slope and reach higher levels during the first 3h followed by a faster decrease when compared to the PZL-arm. In addition, starting at the 12h time-point, T3 levels were modeled at higher levels in the PZL-arm (Table 3).

To study the integrated T3 levels, we calculated the area under each curve (AUC) for multiple time segments. It is clear that between 0-3h, the integrated T3 levels are higher in the LT3-arm, whereas from 12-48h they are higher in the PZL-arm (Table 3).

We next used the piecewise mixed-effects model with change points at 1h, 2h, 3h, 4h, and 12h, with average levels at -30 min and -15 min as a covariate and with random intercept and random slopes across the patients within each group. This model is useful when analyzing longitudinal data sets to model segmented change over time. It predicted a clear difference between the LT3 and PZL curves between 3-46h (Table 3).

### T3 pharmacodynamics

#### *TSH and T4 levels*

In the placebo-arm, serum TSH and T4 exhibited a reciprocal variation that reflects their normal circadian rhythmicity (Fig. 1B-C). Serum TSH dropped by ~30% by 6h into the study only to return to baseline values by 18h, which was then followed by another ~30% drop by 24h (Fig. 1B). At the same time, serum T4 levels varied much less, ~10%, with reciprocal peaks and valleys (Fig. 1C). The elevation in serum T3 levels observed in the LT3-arm and PZL-arm provoked a similar reduction in serum TSH levels in both groups that reached ~40% by 9h, and ~70% by 24h, with disruption of the circadian rhythmicity (Fig. 1B).

### *Heart rate*

There was a tendency for heart rate to increase during the day to a maximum around 4 PM, and then slowly return to baseline (Fig. 2), with no differences observed among treatment arms (Table 4).

### *Blood Pressure*

Systolic and diastolic blood pressures, as well as mean arterial pressure, remained stable throughout the day (Fig. 2), with no differences observed among treatment arms (Table 5).

### ARs or AEs

There were no deaths, no AR or serious AE. All AE were mild and resolved without complications; all were definitively not linked to LT3 or PZL treatment, as they were evenly distributed among arms (7 AE per arm). In the placebo-arm: anxiety, tiredness, faint episode, dizziness, back pain, knee pain, neck stiffness; in the LT3-arm: cold upper extremity, headache, blurry vision, nausea, nosebleed, low-grade fever, dizziness; and in the PZL-arm: dizziness, tiredness, low-grade fever, loose stools, sluggishness, headache (2x), sore throat. One woman had a delayed period during the trial with subsequent periods being on time, and another woman reported a heavier period in the month after the completion of the trial. No pregnancy occurred for any of the volunteers for the duration of the trial or during the 1 month afterwards.

All CBCs, CMPs, and ECGs obtained before, during, and 1 week after each admission arm were unremarkable (exceptions below). One volunteer had positive thyroid autoantibodies in presence of normal TFTs. One volunteer had slight elevation in total bilirubin of 1.2 mg/dL (0.1 – 1.0) at screening and ranged from 0.9 – 2.5 mg/dL during the trial, with the higher level of 2.5 obtained during the placebo-arm. Three women had low normal RBC at screening,  $4.49 \times 10^6/\mu\text{L}$ ,  $4.82 \times 10^6/\mu\text{L}$  and  $4.84 \times 10^6/\mu\text{L}$  (normal:  $4.47\text{--}5.91 \times 10^6$ ) and developed lower RBC during the trial,  $3.98 \times 10^6/\mu\text{L}$ ,  $4.09 \times 10^6/\mu\text{L}$  and  $4.38 \times 10^6/\mu\text{L}$ , respectively. A fourth woman and one man had low RBC at screening  $4.23 \times 10^6/\mu\text{L}$  and  $4.41 \times 10^6/\mu\text{L}$ , respectively, both reaching a lower level of  $3.97 \times 10^6/\mu\text{L}$  during the trial. While the four women maintained a hemoglobin level in the normal range, the man with low RBC reached a lower hemoglobin level of 12.6 g/dL (normal range > 13.5 g/dL).

### Exploratory analysis of the sleep patterns

For all sleep outcomes, mean data was calculated for each participant from all days of collection, with a maximum of 6 contributing days within an arm. 10 participants completed actigraphy during the PZL-arm, of which 7 individuals had scorable data for all 6 days, 2 participants had 5 days, and 1 had 4 days contribute to the calculated means. 9 individuals completed actigraphy and had scorable data over all 6 days during the LT3-arm. For the Placebo-arm, 10 individuals

completed actigraphy of which 9 had 6 six days of data and 1 participant had 3 days. No differences were observed in mean sleep outcomes including sleep onset, sleep offset, time in bed, sleep efficiency, and fragmentation among the groups (Table 6).



## Discussion

Here we report the results of a phase-1 clinical trial in which a new polymeric metal-coordinated T3 molecule (PZL) was tested as a slow-release T3 formulation. In a double-blinded cross-over placebo-controlled trial, healthy volunteers were studied for 48h after they received capsules of placebo or equimolar amounts of T3 from LT3 or PZL.

Whereas the serum T3 profile observed after the LT3 dose was typical and consistent with previous studies, the serum T3 profile obtained after the PZL dose was substantially different. There was a 6h plateau in T3 levels around the  $C_{max}$  that was ~30% lower when compared with LT3, which reflects the delayed but continued intestinal absorption of T3. At the same time, T3 levels in the circulation remained above  $\frac{1}{2}C_{max}$  for more than 24h, which was in contrast with the large swing in serum T3 levels observed after LT3 administration. This was confirmed with a mixed-effect and piecewise mixed-effects models, as well as sectional AUCs. The 6-hour plateau combined with the relative stability of T3 levels during the first 24h, set up an optimistic scenario for achieving more stable T3 levels during repeated administrations of PZL capsules at 24-hour intervals.

It is remarkable that despite the differences in PK, the reduction in serum TSH was similar in both LT3 and PZL-treatment arms. Serum T4 levels were only minimally affected in both cases. This is an indication that the prolonged and constrained elevation in serum T3 levels associated with PZL administration triggered similar cumulative PD effects, despite the absence of the marked peak of T3 levels in the circulation. Accordingly, the total AUC for serum T3 was similar for LT3 and PZL.

The volunteers were closely monitored before, during, and after each arm. Only minor AEs were observed, which were similar in frequency and intensity in all study arms. Even though the individuals were given 50 mcg LT3 (or the equivalent dose in PZL), and serum T3 levels increased substantially, no ARs were reported; no significant changes in heart rate or blood pressure were observed.

Professional medical associations have called for the development of slow-release formulations of LT3 (4) and for future trials to be performed with these new drugs (16). This is because the available studies on LT3 were not comprehensive, and in most cases were not designed to detect long-term ARs. Multiple strategies have been developed to answer those calls (34), including the oral administration of T3 sulfate (35,36).

The present study shows that a copolymer of T3 and zinc possesses the necessary properties to achieve a much improved T3 PK. This was a proof-of-principle study required by the FDA regulatory process. It is expected that even more consistent delivery of T3 will be achieved in the final steps of the drug product development, which includes refinement of the formulation with appropriate excipients and delivery method (i.e. coated tablets instead of enteric capsules). The successful development of PZL adds to the arsenal of new strategies and molecules that are being developed to provide stable replacement levels of T3 for patients that suffer from hypothyroidism.

## LEGENDS TO THE FIGURES.

**Figure 1.** T3, T4, and TSH kinetics in volunteers after taking a capsule of PZL, LT3, or placebo. (A) Serum T3 values during the first 24 hours after treatments; T3 levels are stable between 2-3 hours after LT3 ( $p>0.05$ ) but after PZL, T3 levels are stable for a longer time, between 2-8 hours ( $p>0.05$ ); T3 concentrations at 2 and 3 hours are significantly different (two-way ANOVA followed by Bonferroni post-test); (B) Serum TSH values; \* $p<0.05$  for both PZL and LT3 vs. placebo; \*\* $p<0.001$  for both PZL and LT3 vs. placebo; all statistics by two-way ANOVA followed by Bonferroni post-test; (C) Serum T4 levels.

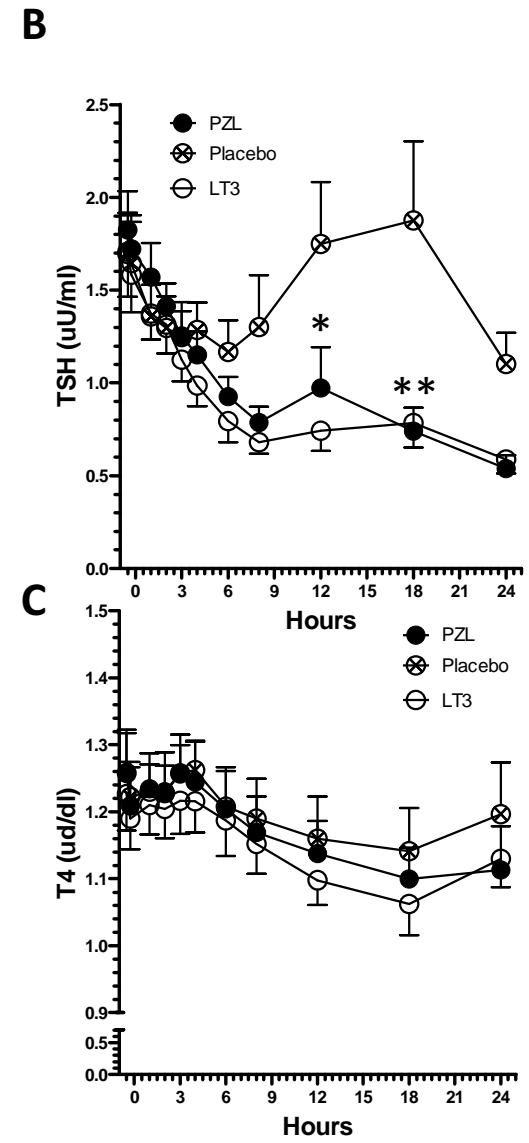
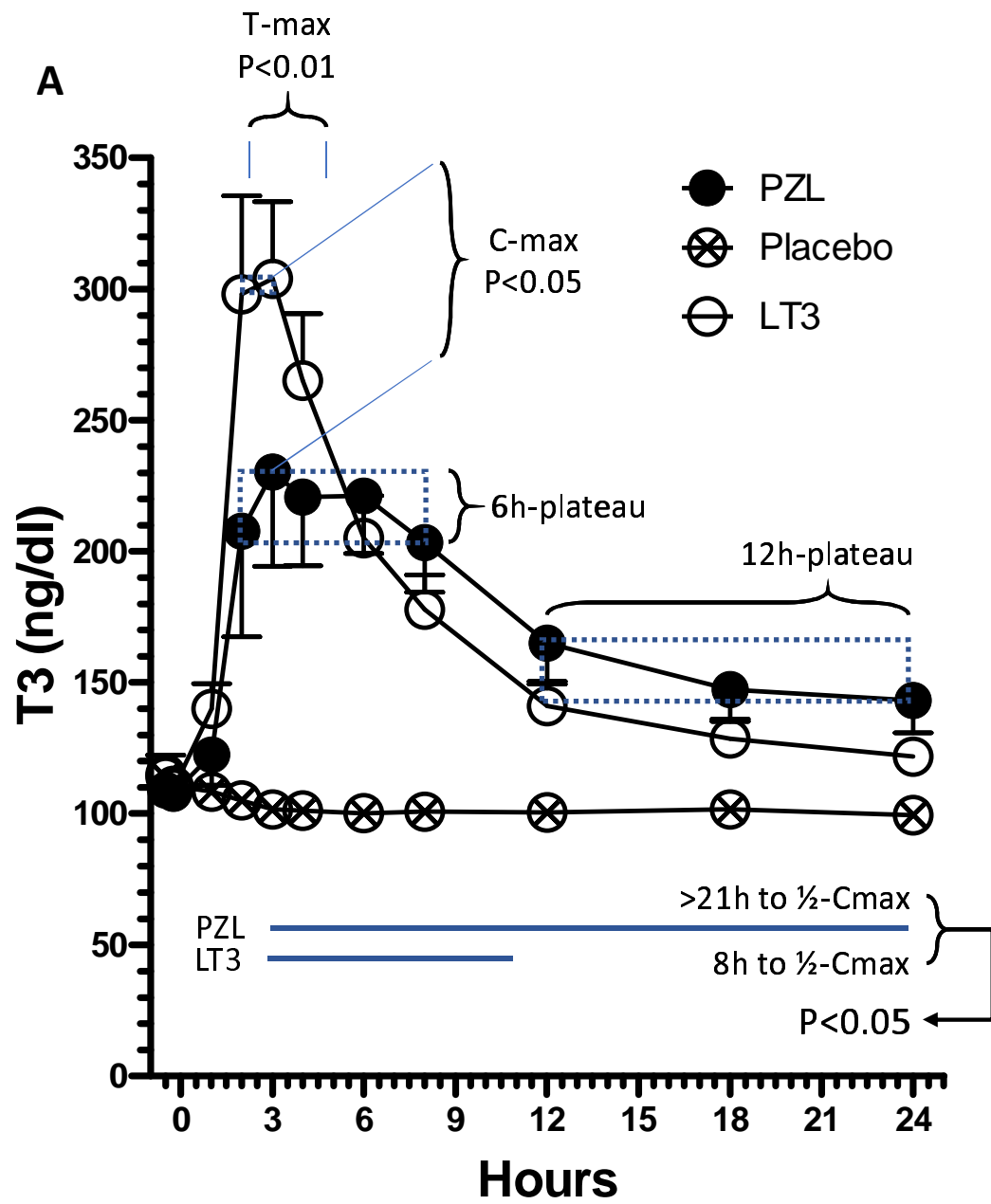

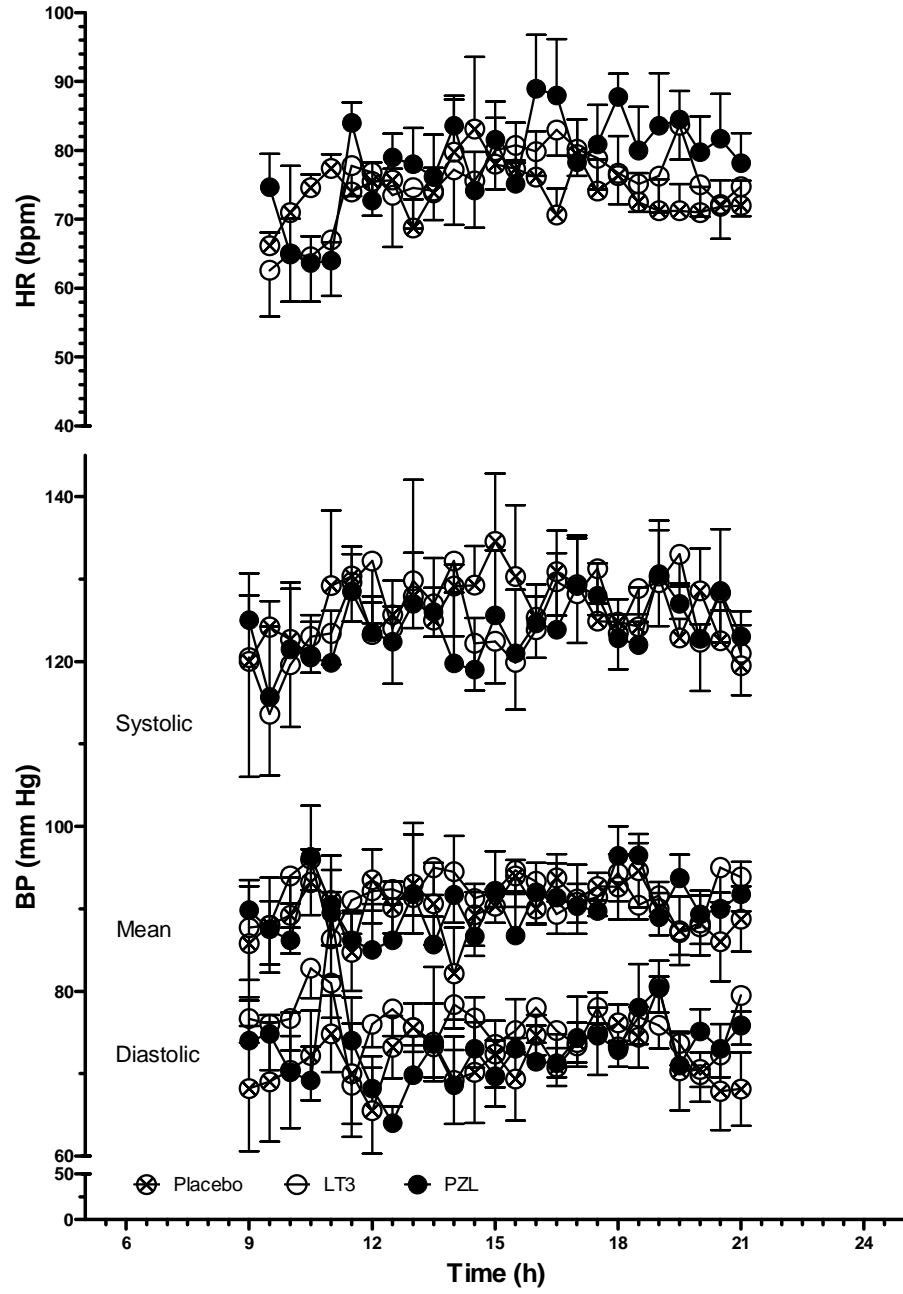
