Abstract

Whether paternal epigenetic information of nutrition might be inherited by their offspring
remained unknown. evaluate the relationship between preconception paternal body
weight and their offspring's birth weight in 1,810 Chinese mother-father-baby trios.
Information on paternal and maternal preconception body weight and height was
collected via a self-reported questionnaire. Birth weight was collected from medical
records. Paternal preconception body weight was associated with offspring's birth weight
(p trend=0.02) after multivariable adjustment. Each standard deviation increment of
paternal body mass index was associated with an additional 29.6 g increase of birth
weight (95% confident interval: 5.7g, 53.5g). The association was more pronounced in
male neonates, and neonates with overweight mothers, and with mothers who gained
excessive gestational weight, compared to their counterparts (all p interaction<0.05).
Sensitivity analyses showed similar pattern to that of the main analysis. Paternal
preconception body weight was associated with birth weight of their offspring.

What is already known on this subject? More efforts have previously been put on the maternal contribution to birth weight, however, it is uncertain whether paternal pre-conceptional body weight, an indicator for epigenetic information, might be inherited by their offspring. What do the results of this study add? In the current study that included 1,810 Chinese mother-father-baby trios, a small but significant association was observed between paternal preconception body weight and offspring's birth weight (p trend=0.02). What are the implications of these findings for clinical practice and/or further research? Paternal epigenetic information of nutrition could be inherited by their offspring.

Introduction

61	Most of the previous studies have been focused on birth weight dependent on maternal
62	body weight. They found that both under- and overnutrition before conception was
63	associated with unfavorable birth outcomes (Sebire et al., 2001, Black et al., 2013).
64	These include the development of chronic diseases later in life - in particular obesity,
65	diabetes, and cardiovascular diseases (Wahlqvist et al., 2015, Haire-Joshu and Tabak,
66	2016, Lowensohn et al., 2016). However, less is known about paternal contribution to
67	weight status in the offspring. An animal study proved that male rats fed by a high-fat
68	diet exhibited glucose intolerance. This nutritional influence on epigenetics could result
69	in β -cell dysfunction of their female offspring, leading to similar phenomenon of glucose
70	intolerance in their adulthood (Ng et al., 2010). Till now, there is a lack of human
71	evidence to support this hypothesis (Abbasi, 2017). One cohort study reported that
72	paternal body mass index (BMI) were associated with offspring BMI in both childhood
73	and mid-adulthood, and the strength of the association did not reduce when offspring
74	grew older (Cooper et al., 2010). However, potential environmental confounders were
75	not controlled in these studies. In a small prospective study on this topic (n=372),
76	paternal preconception BMI was associated with a non-significant increasing trend of
77	birth weight (Moss and Harris, 2015). On the contrary, a cohort study including 2,947
78	singleton children in Netherland found that paternal BMI was associated with birthweight
79	by univariate analysis, though no significant difference was evident following the
80	adjustment of maternal factors (L'Abee et al., 2011). Another study performed in 889
81	Chinese mother-father-child triplet confirmed the association of paternal BMI with
82	birthweight in sons, but not in daughters (Chen et al., 2012). Of note, many of these

studies were limited by the absence of information on relevant factors during pregnancy (Kominiarek and Peaceman, 2017) and failure to exclude non-biological fathers in the analyses (Moss and Harris, 2015). A newly published review suggested that increased paternal BMI could negatively affect pregnancy and child health outcomes, while the association between parental BMI and birthweight cannot be established (Campbell and McPherson, 2019). Therefore, we conducted the current study to examine the relationship between paternal preconception body weight (assessed by BMI) and their children's birth weight in a large Chinese population. We hypothesized that paternal preconception body weight, which was considered as the epigenetic information, was associated with his children's birth weight, independent of major maternal factors.

104 **Study population** 105 All the participants were recruited from the Department of Obstetrics, Ren Ji Hospital, School of Medicine, Shanghai Jiao Tong University, from 1st January to 31st December in 106 2015. The parent's self-reported body weight and height before conception were obtained, 107 108 as well as the newborns' birth weight. The details of participant recruitment/exclusion were shown in **Supplemental Figure 1**. Finally, we included 1,810 trios of father, 109 mother and their newborns in the current analysis. The study was approved by the Ethics 110 111 Committee of Ren Ji Hospital, School of Medicine, Shanghai Jiao Tong University. This was a re-identified study based on a cohort study to evaluate maternal lipid profile and 112 birth weight (Ref No. 2014QDQ10) and informed consent was given by both parent 113 during their induction visit. 114 Assessment of exposure (paternal/maternal body weight and height) and outcome 115 116 (birth weight) At the first prenatal checkup (~15th -16th gestational weeks), we asked paternal and 117 maternal preconception body weight and height in the past 6 months. Body mass index 118 119 (BMI) was calculated as the body weight (in kilogram) divided by the height squared (in meters). Body weight status was used as both continuous and categorical variable. 120 121 According to the Working Group of Obesity in China (WGOC) criteria for adults, participants' weight status was classified as: 'normal' (BMI < 24.0 kg/m²), 'overweight' 122

 $(24 \text{ kg/m}^2 \le \text{BMI} < 28.0 \text{ kg/m}^2)$, and 'obese' $(\text{BMI} \ge 28.0 \text{ kg/m}^2)$ (Zhou and Coorperative

Meta-Analysis Group Of Working Group On Obesity In, 2002). As only 57 fathers (3.5%)

had BMI categories as 'underweight', they were hence merged into 'normal' group for analysis. After birth delivery, we collected information on offspring's birth weight from their medical records. Briefly, measurement of birth weight was completed within 1 hour of birth. This parameter was measured using a digital scale (Seca 757, Seca China, China) by a trained nurse in delivery room. Macrosomia is defined as birth weight is equal or more than 4000 g (Rossi *et al.*, 2013).

Information on maternal age, education level, history of major chronic diseases (e.g., thyroid diseases, immune diseases, heart diseases, and psychiatric disorders), and family history of metabolic diseases (obese, pre-diabetes/diabetes, hypertension, dyslipidemia, nonalcoholic fatty liver diseases, and hyperuricemia/gout) were collected via a selfreported questionnaire by trained medical staffs. Data on parity, conception mode, and gestational weight gain (GWG) were obtained from medical records. All the mothers were categorized into three groups based on preconception BMI and GWG: inadequate GWC (below the lower cutoff point of IOM recommendation (Anon, 2009), optimal GWG (within the recommendation), and excessive GWG (above the upper cutoff point). The optimal GWG is 12.5-18.0 kg for underweight mother, 11.5-16.0 kg for normal weight mother, 7.0-11.5 kg for overweight mother, and 5.0-9.0 kg for obese mother. Data on hemoglobin, fasting plasma glucose, systolic blood pressure, diastolic blood pressure, plasma level of triglyceride, total cholesterol, low density lipoprotein cholesterol and high-density lipoprotein cholesterol at the first prenatal check-up were also obtained from medical record. Dyslipidemia was diagnosed if any of the following criterion was addressed: triglyceride≥1.7 mmol/L, total cholesterol≥5.72mmol/L, low

density lipoprotein cholesterol≥3.4mmol/L, and high-density lipoprotein cholesterol<1.0 mmol/L)(Srikanth and Deedwania, 2016).

150 Statistical analyses 151 All statistical analyses were conducted by SAS version 9.4 (SAS Institute, Inc, Cary, NC). Formal hypothesis testing was 2-sided with a significant level of 0.05. 152 153 We used PROC CORR to test parental BMI and offspring's birthweight separately in 154 boys and girls, adjusting for delivery gestational week (week), maternal age, GWG (kg), education (less than or equal to high school or college or above), parity (primipara or 155 156 non-primipara), family history of diseases ('yes' or 'no'), hemoglobin (g/L), systolic 157 blood pressure (mmHg), diastolic blood pressure (mmHg), dyslipidemia ('yes' or 'no'), 158 and fasting plasma glucose (mmol/L) at the first prenatal check-up. 159 We used the **PROC GLM** to evaluate the relationship between parental body weight and offspring's birthweight. Further, we used **PROC LOGISTIC** to evaluate the relationship 160 between parental body weight and the risk of developing macrosomia. We considered 161 many potential confounders for inclusion in each model. Model 1 was adjusted for 162 offspring's sex and delivery gestational week. Model 2 was adjusted for variables in 163 model 1 and further adjusted for maternal age, GWG (kg), preconception BMI (kg/m²), 164 education (less than or equal to high school or college or above), family history of 165 166 disease ('yes' or 'no') and parity (primipara or non-primipara). Model 3 was adjusted for 167 variables in *model 2* and further adjusted for hemoglobin (g/L), systolic blood pressure 168 (mmHg), diastolic blood pressure (mmHg), dyslipidemia ('yes' or 'no'), and fasting

plasma glucose (mmol/L) at the first prenatal check-up.

170	Because offspring's sex, maternal preconception BMI, and GWG might modify the
171	association between paternal body weight and offspring's birth weight, we tested relevant
172	interaction and subgroup analyses based on these three variables, adjusting for
173	aforementioned covariates.
174	To test the robustness of the results obtained from the main analysis, we conducted four
175	sensitivity analyses: 1) we adjusted birth weight by delivery gestational week; 2) we
176	adjusted birth weight by birth length as outcome; 3) we excluded mother aged 35 years
177	old or more during pregnancy; and 4) excluding father whose BMI was less than 18.5
178	kg/m^2 .

Results

There were 1,810 full-term healthy newborns (946 boys and 864 girls). The average birth weight was 3,415±395 g in boys and 3,314±376 g in girls. The average birth length was 50.1±1.4 cm and 49.9±1.0 cm for boys and girls respectively. The average gestational age at delivery was 39.0±1.1 weeks. Paternal body weight was associated with advanced maternal age, higher maternal preconception BMI and education level, higher prevalence of family history of metabolic diseases, and greater offspring's birth weight (**Table 1**). Paternal preconception body weight was associated with offspring's birth weight, after adjustment for potential confounders (Table 2, model 2). Further adjustment for hemoglobin, blood pressure, plasma lipids profiles, and fasting plasma glucose (mmol/L) at the first prenatal check-up attenuated the association; however, the difference between the two extreme groups remained significant. Each standard deviation (SD) increment of paternal BMI ($\approx 3.27 \text{ kg/m}^2$) was associated with an additional 29.6 g increase of birth weight [95% confident interval (CI): 5.7, 53.5 g, p trend=0.02] (**Table 2, model 3**). When considering paternal preconception BMI as a continuous variable, one-unit increase in BMI (1.0 kg/m²) was associated with a 9.6 g increase of offspring birth weight (95% CI: 2.3g, 17.0g, p=0.01). Paternal body weight was not associated with the risk of macrosomia (Table 3, model 3). The association between paternal preconception body weight and offspring's birth weight appeared to be only present in male neonates, neonates with overweight mothers and mothers with excessive GWG, compared to their counterparts (p interaction <0.05 for all,

212	Figure 1). Paternal preconception BMI was significantly associated with their sons' birth
213	weight while maternal preconception BMI was significantly associated with both sons
214	and daughters' birth weight (all p<0.01, Table S 1).
215	We found similar results in the sensitive analysis with gestational week adjusted weight,
216	or birth length adjusted weight, as well as those excluding mothers aged 35 years or more
217	or fathers with underweight (BMI<18.5 kg/m ²) during pregnancy (Table S 2-5).

Discussion

In this prospective study including 1,810 Chinese mother-father-baby trios, we found that paternal preconception body weight was associated with offspring's birth weight, after adjustment for several potential confounders such as maternal preconception body weight. Our findings confirmed the theory that paternal BMI before pregnancy was possibly a risk factor for the gain of birth weight and thus might increase the future risk of developing obesity and related metabolic diseases. Hence, it is equally important to target paternal pre-pregnancy body weight as maternal body weight during preconception health advice. Mothers have long been the focus of preconception care. Women of reproductive age are recommended to take folic acid, calcium, vitamin supplements, to taper off alcohol and smoking, reduce coffee consumption, and maintain healthy body weight (Abbasi, 2017). Although mothers take more responsibilities than fathers in conceiving a healthy baby, the influence of paternal pre-conception BMI on birth weight cannot be neglected (Campbell and McPherson, 2019). Paternal preconception environmental exposures also closely related to offspring's birth weight (Shea and Little, 1997, Moss and Harris, 2015), and future health (Kaati et al., 2002, Yen et al., 2016) of their offspring. Detailed mechanism of transgenerational effects has not been elucidated yet, but was thought to be associated with spermatozoan coding RNAs (Krawetz, 2005), DNA methylation imprinted in sperm (Soubry et al., 2016), and identified features specific to sex chromosomes that related to epigenetic information (Pembrey et al., 2006, Navratilova et al., 2017). Consistently, we observed that preconception paternal body weight was

associated with offspring's birth weight. The potential role of paternal exposure on offspring heath status was supported by Shea and Little's finding which had a group of fathers exposed to x-ray examinations within one year prior to conception. They found that the x-ray exposure had a marginally significant influence on birth weight, compared with those without it (3,358 g vs. 3,437 g; p = 0.055). (Shea and Little, 1997). Likewise, in a longitudinal study (n=372) based on the National Longitudinal Study of Adolescent Health, preconception paternal BMI was associated with offspring's birth weight (relative to father with normal weight, mean difference in birth weight was 35.6 g for overweight father, and 76.8 g for obese father) (Moss and Harris, 2015). The non-significant results of this study could be explained, at least in part, by its modest sample size (372 fathermother-infant trios) and crude estimation of biological relationship between father and children. Two previous cohort studies have been performed in 2,947 Netherland and 1,041 Australian children, respectively (L'Abee et al., 2011, Pomeroy et al., 2015). In accordance with the present study, no significant difference between paternal BMI and birthweight was evident. However, pre-term babies (<37 gestational weeks) were included in the analysis (L'Abee et al., 2011). Another possible explanation for the discrepancy between our results and previous studies might be due to the inclusion of multipara mothers in the analysis (L'Abee et al., 2011, Moss and Harris, 2015, Pomeroy et al., 2015). In subgroup analysis, male neonates, neonates with overweight mothers, or with mothers who experienced excessive GWG were more likely to get greater birth weight, compared to their counterparts. Paternal epigenetic information seems to transfer to male offspring in sex-specific rule. In the current study, paternal BMI only correlated with

their son's, but not with their daughter's birth weight. Our results were consistent with Chen's study (Chen et al., 2012). In addition, Similar sex-specific transgenerational responses were also observed in Swedish population (Pembrey et al., 2006). Paternal smoking was associated with greater BMI at year 9 in sons, but not in daughters. Further, paternal grandfather's food supply was only linked to the mortality of grandsons (Pembrey et al., 2006). A possible explanation for this is that paternal epigenetic information might leave marks on Y chromosome, hence is transferred only to male offspring (Pembrey et al., 2006, Navratilova et al., 2017). It is well recognized that maternal preconception obesity and higher gestational weight gain were associated with larger birth size (Strutz et al., 2012, Secher et al., 2014, Catalano and Shankar, 2017). Paternal effects on birth weight of their offspring were more pronounced only in neonates with overweight mother, or with mother who gained excessive weight in pregnancy. These results suggest that paternal effects could be modified by maternal factors during pregnancy. Strengths of the current study included its longitudinal design, a large sample size, and precise assessment of the biological relationship between father and their children. Our study had several limitations. Firstly, both paternal and maternal body weight before pregnancy was self-reported, which might result in misclassification. However, selfreported weight is generally accurate and had high correlation with measured weight (Stunkard and Albaum, 1981, Leary et al., 2010). Secondly, residual confounding is of concern because paternal demographic information, such as age (Sharma et al., 2015), smoking (Han et al., 2015, Yen et al., 2016), and occupation (Friberg et al., 2015) were not collected and these missing data could be associated with offspring's future health

(Cheng et al., 2016). Finally, the macrosomia is considered as a more reliable parameter to predict the risk of future obesity and cardiovascular diseases compared to birth weight (Szostak-Wegierek, 2014, Woo Baidal et al., 2016). However, being limited to a lack of macrosomia cases (114/1810), the statistical power of the current study was low to explore the relationship between paternal body weight and risk of macrosomia, though positive association between the preconception paternal body weight and birth weight was confirmed.

In conclusion, paternal preconception body weight was associated with birth weight of their offspring. Future studies with detailed information on preconception paternal demographics are warranted to confirm our findings.
