

Supplementary Figure S1. Forest plot of differences in mean Euclidean distance from residential address to crash location and associated 95% confidence intervals (CI) among crash-involved drivers in New Jersey with and without the clinical conditions, ages 68 years and older, 2007-2017. Each difference in mean was found by subtracting the mean Euclidean distance of the group without the clinical condition from the group with it.
