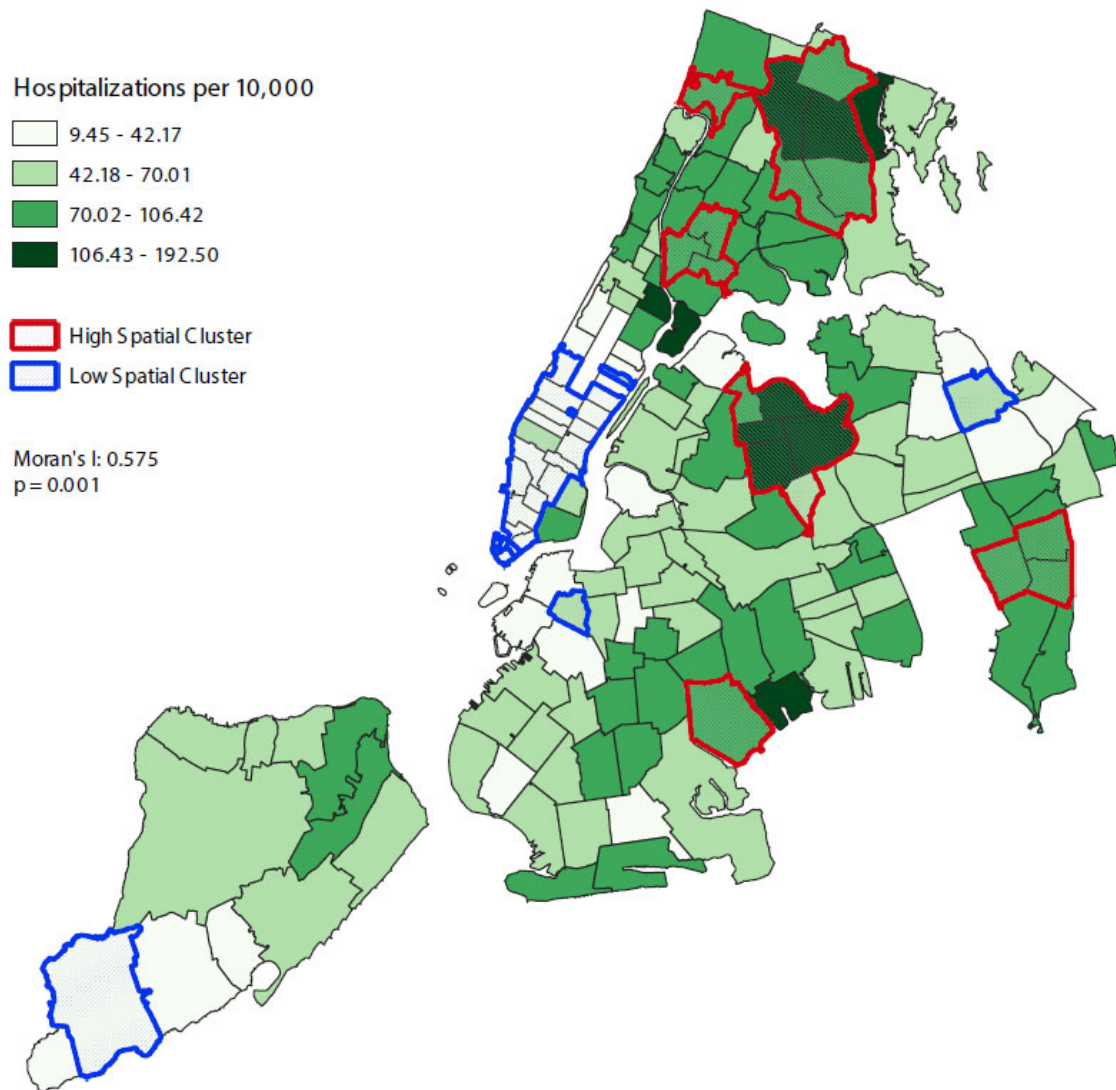
eFigure 1: COVID-19 hospitalizations by ZIP Code Tabulation Area, cumulative from February 23 to May 23, 2020

eFigure 2: Model specification for primary analysis

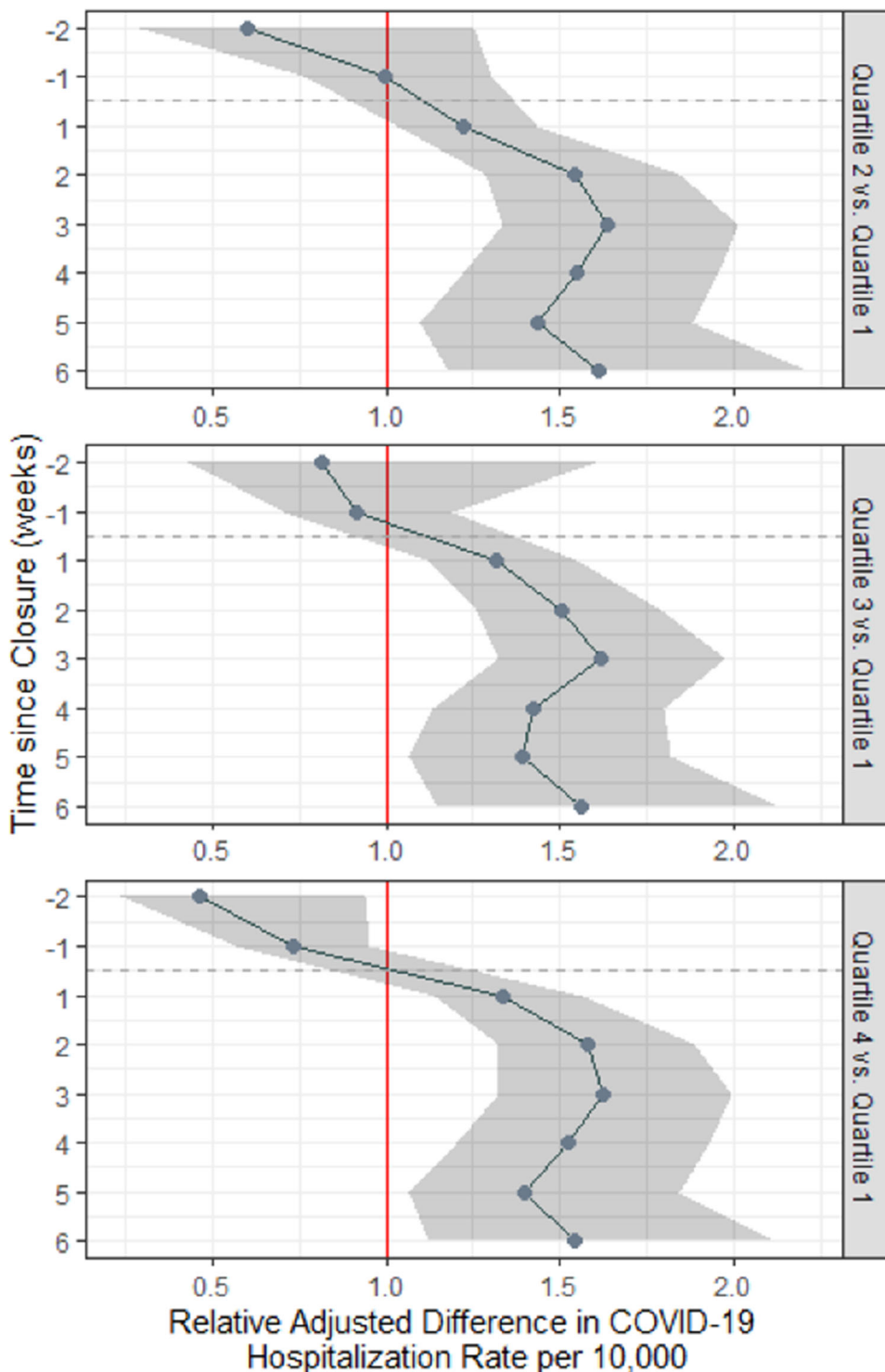
The generalized linear model we employed for the mean hospitalization count in each ZCTA in each week is of the following form:

$$E\left(\log\left(10,000 \times \frac{Y_{it}}{\text{Population}_i}\right)\right) = \beta_0 + \sum_{j=-2}^6 \beta_{j, \text{MG}_i} (\text{Time}_j \times \text{MG}_i) + \mu_i + v_i + \theta_t + \varepsilon_{ijt}$$

where:

- Y_{it} denotes the number of hospitalizations in ZCTA i in week t , where t ranges from -2 (two weeks before school closure) to 6 (six weeks after school closure). The date of school closure is March 16, 2020. The $t = -2$ count aggregates hospitalizations from the weeks of February 23, 2020 and March 1, 2020.
- Time_j is a binary variable indicating whether or not $j = t$. Time $t = 0$ (the week of lockdown and school closures) is treated as the reference level.
- MG_i is a categorical variable indicating which quartile of multigenerational housing ZCTA falls into (Q1, Q2, Q3, Q4). Quartile 1 is treated as the reference level.
- The quartile-specific coefficients β_{j, MG_i} are plotted in Figures 2 and 3. These coefficients can be interpreted as the difference in log hospitalization counts between quartile MG_i and quartile 1 at time j , relative to time 0. When exponentiated, they are interpreted as multiplicative factors rather than differences.
- μ_i denotes ZCTA-level fixed effects, including the effect of the ZCTA's median income, percentage of residents who are white, and percentage of residents below the federal poverty threshold.
- v_i denotes a spatial random effect term for ZCTA i . In particular, it is a conditionally autoregressive term with a Besag-York-Mollié specification; this means that conditioned on the spatial random effect terms for all other ZCTAs, v_i is modeled as normally-distributed with mean $\frac{1}{|N_i|} \sum_{j \in N_i} v_j$, where N_i are the indices of the immediately-neighboring ZCTAs.
- θ_t denotes a weekly time fixed effect that captures trends in the outcome not explained by the other terms in the model.
- Population_i is the population of ZCTA i .

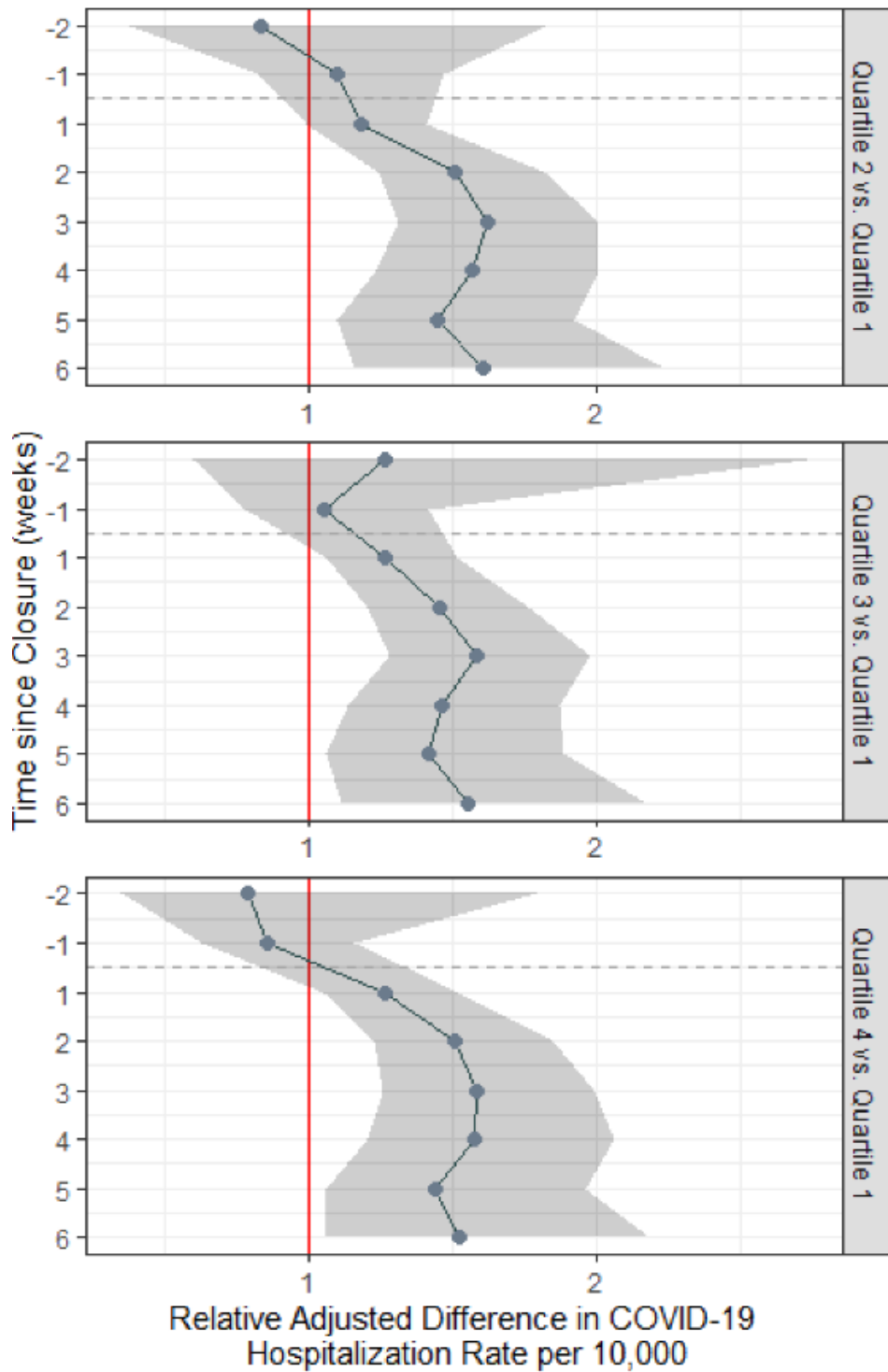
¹ This model controlled for the following covariates: ZCTA-level prevalence (in percentage) of obese adults (defined as body mass index [BMI] ≥ 30 kg/m²), adults who smoke, and adults with coronary heart disease, hypertension, diabetes, asthma, or chronic obstructive pulmonary disease (COPD) – taken from the CDC 500 Cities Dataset; and additional socioeconomic factors: ZCTA-level estimates of total population, percentage of patients living below the federal poverty line (FPL), median income ,

percentage of White residents, and percentage of overcrowded households (defined as estimated number of housing units with more than one occupant per room, divided by the number of occupied housing units) - all taken from the ACS 5-year estimates 2018 - , and percentage of essential workers by ZCTA, identified from service-oriented non-public roles using Census Industrial Classification Codes in the following categories: 1) public transit workers; 2) grocery, convenience and drug store workers; 3) trucking, warehouse and postal service workers; 4) healthcare workers; 5) childcare, homeless, food and family service workers; and 6) building cleaning service workers – we replicated the same methodology as employed by the New York City Office of the Comptroller (Scott S [2020] New York City's Frontline Workers. New York City: City of New York, Office of the Comptroller).

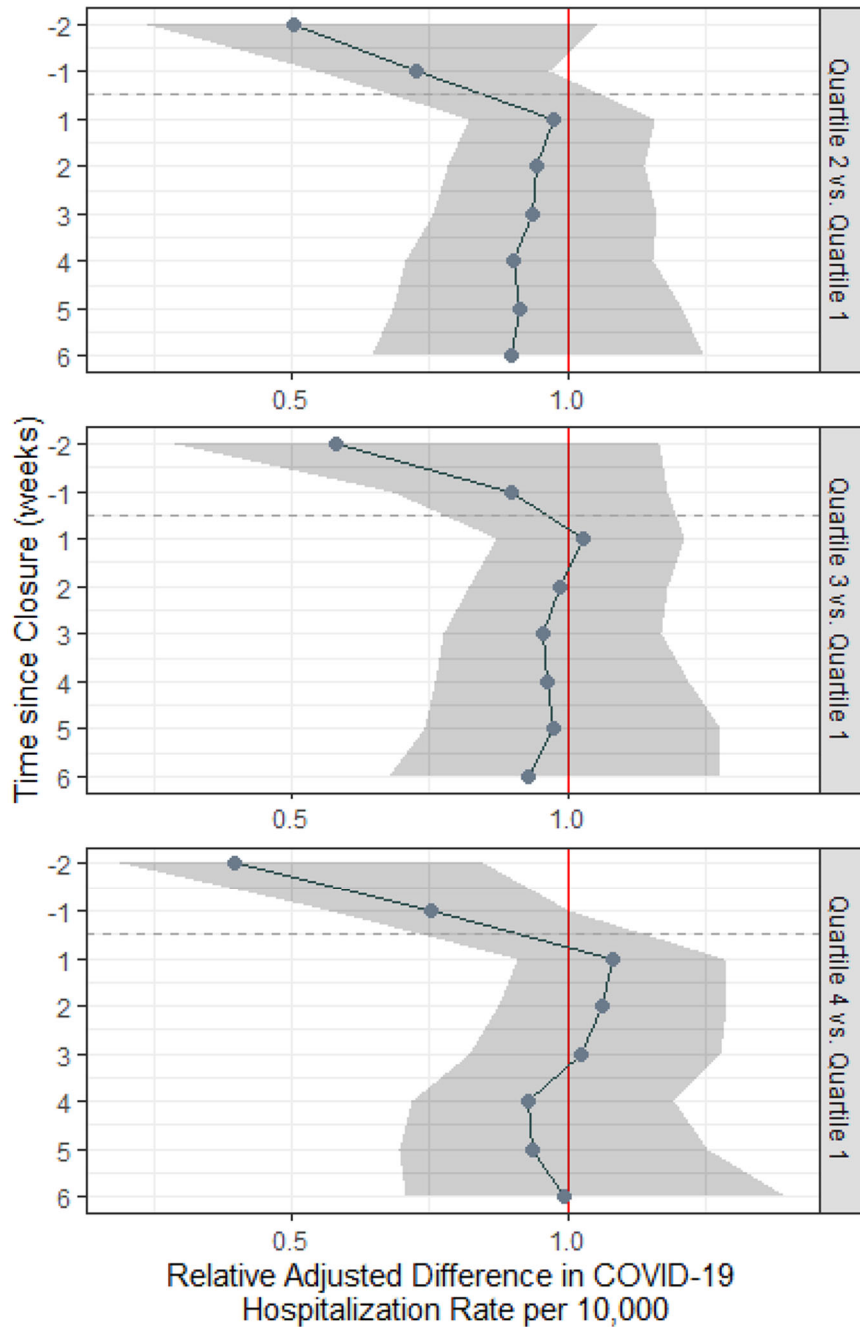
