Sensitivity analysis of waning immunity

All results given in the paper are based on the assumption that waning immunity from natural infection starts at 8 months post infection. The following plots show results from all the parameter combinations used in the paper repeated for four different estimates of time until waning immunity from natural infection (6,7,8,9 months).

Without importation of infection from the community


























