We will assure equitable selection of subjects by enrolling participants from the eligible applicants to reflect demographics of the local community.
2. Inclusion criteria will include: -age 18-64 years; -body mass index (BMI) >28 kg/m²; -not currently pregnant or lactating; -have Wi-Fi at home, a working email, and a smartphoneno self-reported severe metabolic, cardiovascular or musculoskeletal disease; -not using insulin injection; -able to attend the 22 (1 hour) diet improvement sessions.

- -willing to lose 20 lb. or more during 6 months and maintain a healthy weight for one year.
- -keep weighing their weight for one and a half year.
- -fluent in reading and writing English.

Exclusion criteria will include:

- -age <18 or >64 years;
- -body mass index of <28 kg/m²;
- -currently pregnant;
- -currently lactating;
- -self-reported with sever metabolic, cardiovascular or musculoskeletal disease;
- -use insulin injection:
- -not able to attend the 22 (1 hour) diet improvement sessions for 1 year;
- -failed to set up Wi-Fi scale;
- -failed to submit food frequency questionnaire
- 3. Measures and protocols used to screen applicants will include:
 - -Medical History Form (included with screening forms);
 - -Food Frequency Questionnaire (FFQ, included with screening forms);
 - -Anthropometric measurement at an individual meeting to confirm BMI > 28
- 4. Prospective participants will self-assess eligibility based on inclusion/exclusion criteria sent to them. Upon return of screening materials and forms, participants will be assessed for full eligibility by the study investigators. No special training or expertise is required to evaluate screening responses and/or data. Regarding all forms and documents that ineligibility participants have provided to the investigators will be destroyed immediately after they have been notified of ineligibility.

Screening: Interested individuals will contact investigators via electronic mail to obtain a general description of the study. The participants who want to be in the study will send an email indicating their continued interest after they read the general description of the study. Then, the investigators will send the Consent Form without the signature line and the Medical History Form to the participants, and they will read the consent form carefully without signing it out and fill out the medical history form and send the forms to investigators via mail to 463 Bevier Hall, 905 S. Goodwin Avenue, Urbana, IL 61801. The sealed envelope will not be provided so; It will cost approximately 1.50 -2 \$ each participant. Once the investigators receive the forms, they will analyze and review the forms. Eligible participants will be informed via email to schedule an individual meeting appointment. The participants, who are on the waiting list, will be notified and set up an individual meeting in future when the study will be expanded. Regarding the ineligible participants, all their forms will be destroyed immediately after they have been informed of ineligibility.

Individual meeting: At the Individual meeting, to be held in Bevier Hall on the University of Illinois, Urbana-Champaign campus, the investigators will explain the purpose, requirements, expectations, risks and benefits of the 1.5-year study. Also, the investigators will take body measurements, including: height, weight, waist, hip circumference, and blood pressure. The investigators will review the Informed Consent Form and ask the participants to fill out the food frequency questionnaire (FFQ). Also, the investigators will setup the Wi-Fi scale for each participant and address any questions or concerns expressed by participants. This session will last approximately 1 hour. All participants will receive a schedule of meeting dates. Enrolled participants will return their signed Informed Consent Forms in the individual meeting.

Eligible participants will then be in an intervention group (n \sim 30) led by a registered dietitian, or the wait-list group (n \sim 30). The wait-list group will be enrolled in the program 6 months later. This enrollment pattern will be repeated every 6 months for 3 years. Each participant will be assigned a 3-digit ID code number. Additional anthropometry sessions will be scheduled for each participant at months 6, 12 and 18 months.

<u>Intervention groups:</u> During a 12-month period, participants will attend total of 22 diet improvement sessions, each of which will last approximately 1 hour. Twelve sessions will be held in the first 5 months, and will be focused on safe and

efficient weight loss. The participants will learn to create personalized weight loss diet from their kitchen based on their diet practice and food preference. The next 10 sessions will be held in the last 7 months, and will be focused on weight maintenance and healthy eating. The participants will build skills to select foods and create meals that prevent them from overeating.

<u>Data collection:</u> The daily body weight will be automatically collected using a Wi-Fi scale. Anthropometric and blood pressure measurements will be collected at baseline (week 0), 6, 12 and 18 months at individual meetings, which will take 15 minutes to 1 hour each. In addition to FFQ at the beginning, participants will complete one or more 24-hour food records at home, and bring these to the next session for diet analysis as needed.

Safety and efficacy measure of dietary intervention:

The efficacy of the program will be constantly monitored by the daily body weight data obtained via Wi-Fi scale. Safety of the participants during weight loss will be maintained by daily weight monitoring, 24-hour food records and individual advising.

Dietary intake assessment:

Participants will be taught to accurately complete FFQ to have a clear picture about the dietary habits of the participants. The investigators will analyze the FFQ and provide the participants with individualized advice and options for improvement of diet. Then, the participants will make a decision for changing their diet. The FFQ will be administered 3 times during the study at 0, 6, and 12 month to monitor the diet changes of participants.

Also, the participants will be taught to accurately complete 24-hour food records using a food record form and handouts that contain examples of standard serving sizes of different foods and beverages. Investigators use the 24-hour record to check adequacy of their diet and to troubleshoot if a participant is not losing weight effectively. Participants will receive an individualized advice based on 24-hour food record analysis.

Anthropometric and blood pressure measurements:

Standing height (cm) will be measured using a calibrated scale-mounted stadiometer (Seca 700, Hanover, MD) to the nearest 0.1 cm. Body weight will be measured on a calibrated balance beam scale (Seca 700, Hanover, MD) to the nearest 0.1 kg. Body mass index (kg/m²) will be calculated based on height and body weight measurements. Waist and hip circumference (cm) will be measured and recorded to the nearest 0.1 cm using a retractable tape measure (Gulik II, Gay Mills, WI) and will be used to calculate waist:hip ratio.

Seated systolic and diastolic blood pressure (mm Hg) will be measured by a standard sphygmomanometer (Baumanometer® Desk Model, Copiague, NY) after a 5-min rest period. Two measurements will be taken with a 2- to 3-min rest period between readings. The two systolic arterial pressure values will be averaged, and the two diastolic arterial pressure values will be averaged; these means will be used in data analyses. Measurements will be completed by a trained study investigator, who will be blinded to the intervention assignment.

Daily body weight will be automatically collected using a Weight Gurus Wi-Fi Smart Scale model No. 0385 (Greater Goods, St Louis, MO). The investigators have access to each participant to tracking their daily weight changes throughout the weight gurus website.

Participants are to be available for the full duration of this 18-month intervention; however, participants are permitted to take vacations and continue their schedules as usual. Absences and vacations will be expected and accommodated with attention given to scheduling of data collection sessions as well as educational sessions in order to minimize participant burden. Make-up sessions will be offered and educational materials will be mailed to participants if necessary.

Confidentiality of data collected will be maintained by assigning each participant a 3-digit ID code which will be used to enter all data in an electronic database. ID codes will be used on all documents and materials as the only form of identification; no names will be used. All files and participant documentation will be stored in locked filing cabinets, and only the graduate researcher will have access to the key. Electronic documents, forms and data will be stored on a password protected computer. Only the primary investigator, co-investigator, and research team will have access to stored data. Any data collected via email will be completed using ID codes and deleted and emptied from trash following data collection. Only the primary investigator will have access to the ID code sheet.

All hard copies of completed forms, documents and other study materials will be kept in locked filing cabinets in the laboratory space. Electronic data will be stored on a password protected computer. Only the principal investigator, coinvestigator and research team will have access to stored data.

18D. STAFF TRAINING Describe the training and experience of all persons who will collect or have access to the data.

Nakamura, Manabu, PhD, is an Associate Professor in Department of Food Science and Human Nutrition (FSHN), and will serve as the Responsible Project Investigator and will be responsible for overseeing the development, coordination and administration of the project. He will supervise graduate students and will oversee participant recruitment, screening and intervention sessions. Additionally, he will supervise other individuals of the research team. He will facilitate and aid in preparation of scientific abstracts, manuscripts, presentations and progress reports. His area of expertise is biochemistry and physiology of adaptive response of our body to weight gain and weight loss.

Applegate, Catherine C, MS, RDN, is a graduate research assistant and will primarily facilitate curriculum development under the supervision of the principal investigator, will teach the group sessions, and provide individual counseling throughout the program. She will serve as the in-person research representative and educator during each group and individual session and will discuss progress reports with individuals. She has undergone an accredited didactics internship program and has received the certificate for training of weight management through the Commission on Dietetic Registration in addition to her completed Masters in Human Nutrition degree and current progress towards a doctoral degree in Nutritional Sciences.

Emamaddin, Abrar, BS, is a graduate student in the department of Food Science & Human Nutrition and will have primary responsibilities for participant recruitment, screening, enrollment and retention. She will serve as the primary point of contact for participants and will be in charge of scheduling all appointments, data collection sessions and educational sessions. She will administer and manage study forms, documents and materials, including dietary intake questionnaires, for the duration of the trial. She will participate in all data collection sessions and management of data. She will be involved in the preparation and submission of progress reports. Her research interests include weight loss and maintenance across the weight management spectrum. She has served as the lead investigator for a qualitative study on weight-loss maintenance and has participated in data analyses and preparation of manuscripts. She completed her undergraduate degree in clinical nutrition.

Additional staff trained in laboratory procedures and data management and analyses will be used as necessary. Once these individuals have been identified, an IRB amendment will be submitted adding these project staff members.

All unidentified staff members will complete CITI training before participation in any component of this research.
