# Modelling steps for the study of associations in relation to the physical environment, activities and behaviours and home injuries

## Step 0

- Identify the main exposures of interest and confounding factors

 $E = \{E_1, ..., E_p\}$  are the set of exposures of interest: the physical environment, activities and behaviours that can potentially be associated with home injuries.

 $D = \{D_1, D_2, D_3, D_4, D_5\}$  are the confounding factors forced into the models: gender, age, history of previous injury, self-perceived physical and mental health status.

 $C = \{C_1, ..., C_q\}$  are other confounding factors identified through *Directed Acyclic Graphs*.

### General model definition

 $log(\mu_{ijk}) = log(t_{ijk}) + D_{ijk1}\alpha_1 + D_{ijk2}\alpha_2 + D_{ijk3}\alpha_3 + D_{ijk3}\alpha_3 + D_{ijk4}\alpha_4 + C_{ijk1}\gamma_1 + \ldots + C_{ijkq}\gamma_q + E_{ijk1}\beta_1 + E_{ijkq}\beta_q + b_k + b_{jk},$ 

where  $\mu_{ijk}$  is the expectation of the home injury incidence of multiple measurements of each of the households where the same individual has lived *i*, the individual *j*, belonging to the same household *k*,  $b_k$  the random intercept of the household *k*,  $b_{jk}$  the nested random intercept of individuals in the household,  $log(t_{jk})$  is the term offset.

- Estimation of models for each factor: gender, age, history of previous injury, self-perceived physical and mental health status

- Estimation of p models containing a single exposure of interest without adjustment

- Estimation of q models containing a single factor without adjustment

#### Step 1

- Estimation of q models containing a single confounder adjusted for gender, age, history of previous injury, self-perceived physical and mental health status

$$log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + C_1 + b,$$

$$\vdots \\ log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + C_q + b.$$

- Selection of significant potential  $q^*$  confounders after Benjamini and Hochberg (BH) correction (P < 0.1) adjusted for gender, age and history of previous injury.

- Estimation of a model containing  $q^*$  retained confounders adjusted for gender, age and history of previous injury, self-perceived physical and mental health status:

$$log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + C_1 + \dots + C_{q^*}.$$

- Parameter Estimation, Confidence Intervals (CI), P-value

- Estimation of p models containing a single exposure of interest adjusted for gender, age and history of previous injury

$$log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + E_1 + b,$$

 $log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + E_p + b.$ 

- Selection of  $p^*$  significant potential confounders after BH correction (P < 0.1) adjusted for gender, age, history of previous injury, self-perceived physical and mental health status.

Step 2

- Estimation of  $p^*$  models containing 1 single exposure adjusted for gender, age, history of previous injury, and the selected  $q^*$  confounders:

$$log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + C_1 + \dots + C_{q*} + E_1 + b,$$

 $\vdots \\ log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + C_1 + \dots + C_{q*} + E_{p^*} + b.$ 

- Selection of  $p^{**}$  significant BH-corrected exposures (P < 0.1) adjusted for gender, age, history of previous injury, self-perceived physical and mental health status of the q\* confounders retained.

- Parameter estimates, CIs, adjusted P-value BH

### Step 3

- Estimation of a model containing  $p^{**}$  exposures adjusted for gender, age, history of previous injury and the selected  $q^*$  confounders:

$$log(\mu) = log(t) + D_1 + D_2 + D_3 + D_4 + D_5 + C_1 + \dots + C_{q*} + E_1 + \dots + E_{p^{**}} + b.$$
(6)

- Parameter estimate, CI, P-value< 0.1, Attributable fraction

In all models, in order to simplify the notations, when selecting for example the  $p^*$  factors from E1, ... Ep, the exposures are reordered in such a way that the selected  $p^*$  exposures are placed first:  $E1, ... E_{p^*}$ .
