1	Assessment of Environmental Factors Associated with Antibiotic
2	Resistance Genes (ARGs) in the Yangtze Delta, China

#### 32 Abstract

33 The emergence of antimicrobial resistance (AMR) is an urgent and complex public 34 health challenge worldwide. As a sub-problem of AMR, antibacterial resistance 35 (ABR) is of particular concern due to inadequacy of alternative medication. Earlier 36 studies have shown that ABR is not only impacted by antibiotics, but also affected by 37 the interactions between bacteria and their environments. Therefore, to combat ABR 38 in a specific region, local environmental conditions must be investigated to 39 comprehensively understand which environmental factors might contribute to ABR 40 and propose more tailored solutions. This study surveyed environmental contributors 41 of antibiotic resistance genes (ARGs), the parameter for measuring ABR, in the 42 Yangtze Delta. A high abundance of ARGs was detected, despite low antibiotic and 43 heavy metal concentrations. Phosphorus, chromium, manganese, calcium, and 44 strontium were identified as potential key contributors of ARGs. Suppression of 45 ARGs could be realized through decreasing the concentration of phosphorus in 46 surface water. Group 2A light metals (e.g., magnesium and calcium) could be 47 developed as eco-friendly reagents for controlling antibiotic resistance in the future. 48 **Keywords:** antimicrobial resistance, antibiotic resistance genes, antibiotic residues, 49

# 52 **1. Introduction**

53 Antimicrobial resistance (AMR) refers to the process by which bacteria, parasites. viruses, and fungi evolve mechanisms that protect them from drugs [1]. Due to the 54 55 increasing prevalence, health effects, and economic impact of AMR, World Health 56 Organization has characterized AMR as "a complex global public health challenge" 57 (p. XIX) that requires urgent action [1]. Among the concerns about AMR, 58 countermeasures against antibacterial resistance (ABR) are of particular urgency 59 because of severe inadequacy of alternative therapeutic options [1]. In 2019, it is 60 estimated that 4.95 million deaths were associated with ABR, and 1.27 million 61 deaths were attributable to ABR [2]. In a recent study that estimates the economic 62 burden of ABR in China, 27.45% of inpatient bacterial infection were antibiotic 63 resistant, which is estimated to have caused a 1.5% increase in inpatient mortality 64 rates and cost \$77 billion in related societal expenses in 2017 [3]. What is worse, bacteria are even capable of spreading ABR at a high rate through exchanging 65 66 ARGs in horizontal gene transfer (HGT) [4]. ARGs are a group of genes that encode 67 the proteins responsible for resisting antibiotics and are frequently carried on mobile 68 genetic elements (MGEs) like plasmids, transposons and integrons [4]. In HGT, one 69 bacterial cell transfer its MGEs to other bacterial cells, facilitating environmental 70 dispersal of the ARGs [4]. Thus, ARG has also been recognized as a new 71 environmental pollutant that poses a threat to human health [4]. 72 Earlier studies have attempted to suppress ABR by reducing antibiotic use to 73 allow non-resistant bacteria to outcompete resistant bacteria [5-7], but reversibility 74 only occurs at a slow rate. Later studies demonstrate a strong association between 75 ABR and environmental factors [8]. In particular, heavy metals are reported to have a 76 co-selection effect on ARGs [9-11]. Because bacteria resist antibiotics and heavy

77 metals through similar strategies (e.g., reduction in permeability, efflux,

78 sequestration, etc.), heavy metals may also pose a selective pressure on ARGs.

79 Furthermore, antibiotic resistant communities in urban lakes have also been

80 identified to be more competitive than non-resistant communities at higher

81 temperatures, but less competitive at higher concentration of magnesium or salinity

82 [8].

83 Therefore, to effectively understand and mitigate ABR in a specific region, local
84 environmental conditions must be investigated.

85 The Yangtze Delta is one of the most economically developed regions in China. It 86 consists of 26 cities including Shanghai City, southern part of Zheijang Province, and 87 northern part of Jiangsu province [12]. In 2018, 154 million people were reported to 88 permanently resides in this area at a high population density of 720 persons/square 89 kilometre [12]. The hygiene of drinking water source in this area (e.g., Yangcheng 90 Lake in Suzhou and Huangpu River in Shanghai) is of vital importance since the 91 water sources provide drinking water for over 150 million residents. Due to its 92 economic and environmental importance, previous studies have investigated the 93 prevalence of ARGs and patterns of antibiotic use in the area.

94 In 2020, 64 out of 69 types of antibiotics monitored in the surface water in China 95 can be detected in Shanghai, indicating the widespread of antibiotics in the surface 96 water of Shanghai, with concentrations ranging from a few pg L<sup>-1</sup> to hundreds ng L-1 97 [13-15]. While confirming the widespread distribution and persistence of antibiotics, 98 these studies estimate low environmental risks for most types of antibiotics [14, 16] 99 by calculating their hazard guotients[17]. However, the environmental risks of 100 enrofloxacin, amoxicillin and oxytetracyclines to aquatic organisms, represented by 101 the risk quotient method [18, 19], are distinctly higher than those in other countries

102 [14]. As for ARGs, tetracycline resistance genes (tet) and sulfonamide resistance 103 genes (sul) exist in most waterbodies in Yangtze Delta, and  $\beta$ -lactam resistance 104 genes also exist in some regions [20, 21]. For sul and tet genes, the detection 105 frequency of sull, sull, tetA, tetG, tetM and tetO were significantly higher than sulli, 106 which was still significantly higher than *tet*C [21]. It was observed that samples with 107 more *sul* genes tend to contain higher levels of total sulfonamides, and the same 108 relationship can be applied to tet genes [20]. 109 While these studies focus on the link between ARGs and antibiotic detection. 110 Limited studies have investigated how ARGs are influenced by environmental 111 factors. In this study, we tested surface water samples for ARGs, antibiotics, and 112 dissolved elements to better understand what environmental factors might contribute 113 to the prevalence of ARGs in main water bodies in the Yangtze Delta.

#### 115 **2. Methods**

# 116 2.1 Sampling Sites and Sample Collection

117 In 2021, surface water samples were collected from sampling sites located along 118 a watershed starting at Yangcheng Lake in Suzhou, running along the Wusong 119 River, passing Dianshan Lake in Shanghai, running along the Huangpu River in 120 Shanghai, and ending at an estuary at the Shanghai coastal area. The watershed 121 connects most of the main water bodies in Suzhou and Shanghai. The sampling 122 area contained four subregions: Dianshan Lake (Qingpu District, Shanghai), 123 Huangpu River (Songjiang District, Shanghai), estuary (Jinshan District, Shanghai), 124 and Kunshan (Suzhou). 125 Surface water samples were collected using brown HDPE bottles (NINGKE,

126 China) that were dipped into the top 10cm of the water body with the goal of

127 collecting 1000ml of water. Water temperature, salinity, and pH of the collected

samples were immediately measured and recorded using a salinity and pH meter
(BANTE, China) according to the manufacturer's instructions. Sample bottles were
transported on wet ice within 3 hours to Duke Kunshan University where 650ml of
each sample was filtered through a 0.45 µm glass microfiber filter membranes (Titan,
China). The filtrate and filter membranes were stored stored at a -80°C freezer.

### 134 2.2 Measurement of ARGs

135 Cells gathered on the filter membrane were first released in 10ml of ultrapure 136 water. A TaKaRa MiniBEST Bacteria Genomic DNA Extraction Kit was used to 137 extract 240µl of DNA from 10ml of stored sample, according to the manufacturer's 138 instructions. Quantitative PCR was used to screen extracts for ARGs using the 139 SYBR Green Real-Time PCR assay (TaKaRa Co. Dalian, China) on a Mic gPCR 140 Cycler (BioMolecular Systems, El Cajon, CA), according to the manufacturer's 141 instructions. One sample was randomly selected from each of the four subregions. A 142 total of 26 primers for ARGs were used to screen the four samples. The ARGs 143 include 15 tetracycline resistance genes (tetA, tetC, tetE, tetK, tetL, tetA/P, tetG, 144 tetM, tetO, tetQ, tetS, tetT, tetW, tetBP, and tetX), 4  $\beta$ -lactam resistance genes 145 (blacTX-M, blaTEM, blaSHV, and blaampC), 3 sulfonamide resistance genes (sull, sull, 146 and sullII), 3 macrolides resistance genes (ereA, ereB, and mphA), and 1 beta-147 lactam resistance gene. Primer sequences and cycling conditions for the quantitative 148 PCR experiments are listed in Table S1. Cultured environmental samples were used 149 as positive controls.

# Based on the ARG screening results (Figure S1a and Figure S1b), the three most abundant ARGs were selected for further quantitative PCR experiments: *tetBP*,

152 *ampr, tetO.* Each gene was commercially synthesized and used as an internal

153 standard to determine absolute abundance.

154

155 2.3 Measurement of Dissolved Elements Concentrations

After filtration, approximately 150ml of stored filtrate was acidified to pH < 2 by (1+1) nitric acid and preserved at -80 °C freezer. The samples were sent to the Nanjing Institute of Geography & Limnology, Chinese Academy of Sciences and measured for Ca, K, Mg, Na, Si, Ag, Hg, TI, Al, As, B, Ba, Be, Cd, Co, Cr, Cu, Fe, Mn, Mo, Ni, P, Pb, Sb, Se, Sn, Sr, Ti, V, and Zn by ICP-MS 7900 (Agilent, US), as described in [22].

# 163 2.4 Measurement of Antibiotic Concentration

164 Concentrations of amoxicillin and tetracycline were measured using 500 mL of 165 stored filtrate using the Amoxicillin ELISA kit (Shenzhen Lvshiyuan Biotechnology 166 Co., Ltd, China) and Tetracycline ELISA kit (Shenzhen Lyshiyuan Biotechnology Co., 167 Ltd, China), according to the manufacturer's instructions. The procedures of the two 168 kits were technically the same. Briefly, samples and standard solutions with known 169 antigen (amoxicillin/tetracycline) concentration were separately mixed with 170 corresponding enzyme conjugates (enzyme-labelled antibodies) on a micro-well 171 plate where micro-well strips were pre-coated with coupling antigens. The antigens 172 in the sample and the coupling antigens would compete for the enzyme conjugates. 173 After removing the mixed solution and adding TMB substrate for coloration, the 174 enzyme conjugates bound with sample antigens were removed and only those 175 bound with pre-coated antigens remained, which led to higher optical density (OD) 176 value in the sample with lower antigen concentration. The OD values of the solutions

177	generated from samples and standard solutions were measured with the wavelength
178	of 450nm. All procedures above were performed in duplicate for each sample and
179	standard solution. A standard curve of absorption versus antigen concentration was
180	generated with the OD values from the standard solutions, and the OD values from
181	the samples were compared to the standard curve to get the antigen concentration.
182	
183	2.5 Environmental Risk Assessment of Antibiotics
184	To assess the potential risk of antibiotics in the environment, a hazard quotient
185	(HQ) was used, which is the ratio between the measured environmental
186	concentration (MEC) of the antibiotic and the predicted no-effect concentration
187	(PNEC) [17]. HQ values >1.0 indicate a potential risk to the aquatic system [23]. This
188	study adopts PNEC values proposed by Bengtsson-Palme and Larsson, 2016 (0.25
189	μg/L for amoxicillin and 1 μg/L for tetracycline) [24].
190	
191	2.6 Statistical Method
192	ARG screening data was calculated to relative abundance using the median Cq
193	value of <i>tetE</i> in Sample S7 as a reference with the following formula:
194	
195	Relative Abundance = $2^{(Cq_{reference} - Cq)}$

197	TetBP, ampr, and tetO qPCR data was calculated to absolute abundance using a
198	standard curve derived by serially diluting (10-fold) synthetic genes at a range of 10 <sup>12</sup>
199	copies/mL to 10 <sup>2</sup> copies/mL.
200	Concentrations of amoxicillin and tetracycline were calculated using a standard
201	curve derived from standard solutions provided in the commercial kits.

202 All figures were generated using R (version 4.0 and 4.1). Figure 1(a) used 203 country border data and river data from the rnaturalearth package. Population 204 density data was collected by the Ministry of Civil Affairs of the People's Republic of 205 China [25] and Statistical Bureau of Republic of China [26]. Figure 1(b) adopted the 206 Stamen map through the ggmap package. 207 Phosphorus, chromium, manganese, calcium, and strontium were used to predict 208 tetBP, ampr, and tetO abundance through ridge regression. Ridge regression is an 209 algorithm that produces stable estimation of the least-squares coefficients of 210 multiple-regression models with the condition of high collinearity [27]. Because tetBP

211 contained an outlier with an abundance several magnitudes higher than the others,

212 *tetBP* was re-scaled through the calculation of log<sub>10</sub>(Abd+1).

# 214 3. Results

215 3.1 Abundance of Antibiotic Resistance Genes

216 The spatial distribution of the samples and absolute abundance of total ARG

(sum of *tetBP*, *ampr*, *tetO*) are shown in Figure 1. Notably, an ARG hotspot (S10)

218 was found in Yangcheng Lake, Kunshan. The hotspot contains an elevated amount

219 of *tetBP* (Figure S1).

220 The mean absolute abundance and composition of ARGs in the four regions are

shown in Figure 2. The ARG *ampr* accounts for the majority of detected

222 concentrations in all the regions. However, all the results shown a large standard

223 deviation, indicating high variability within each region.

224

225 3.2 Dissolved Elements & Water Quality

226 In general, all of the samples had a very low heavy metal concentration as shown 227 in Table 1 (according to the Environmental Quality Standard for Surface Water of 228 People's Republic of China [28]). However, Sample S8 collected from drinking water 229 reserve in Songjiang District, Shanghai had an iron concentration of 417.436 µg/L 230 that exceeds the standard limit of 300 µg/L (Table 2). Moreover, though the 231 concentration of phosphorus in many samples was relatively high (Table 1), the 232 values were still under the standard limits. One exception again was the Songjiang 233 sample (237.872 µg/L) which exceeds the phosphorus limit of 200 µg/L for drinking 234 water (Table 1). 235 236 3.3 Measurement of Antibiotic Concentration and Risk Assessment 237 Antibiotic concentrations are shown in Table 3. Unexpectedly, except for the 238 sample from Jinshan contains 0.13 µg/L of tetracycline, antibiotics were not detected 239 in any other samples. Also, the HQ value tetracycline concentration in Jinshan is 240 0.13, indicating no risk. 241 242 3.4 Correlation of ARGs and Environmental Risk Factors 243 Figure 3 shows the correlation of ARGs with salinity, temperature, and dissolved 244 elements. Water temperature and salinity show weak to little correlation with ARGs.

pH appears to have a weak negative correlation with *tetO* and *ampr* (r = -0.58, -

246 0.55). Interestingly, phosphorus, chromium, and manganese exhibit a strong positive

correlation with *tetO* (r = 0.79, 0.64, 0.63). Calcium has a strong negative correlation

with *ampr* (r = -0.70). And strontium has strong negative correlation with both *tetO* 

and *ampr* (r = -0.71, -0.70). Linear regression of *tetO* and *ampr* with phosphorus,

chromium, manganese, calcium, and strontium is shown in Figure 4. These five

elements explain 71.2% variability of *ampr*, 79.1% variability of *tetO*, and 36.0%
variability of log-scaled *tetBP*, in a ridge regression model.

# 254 **4. Discussion**

This study aims to understand what environmental factors might contribute to the prevalence of ARGs in main water bodies in the Yangtze Delta. In summary, a high abundance of ARGs was detected and several dissolved elements (phosphorus, chromium, manganese, calcium, and strontium) were potentially key contributors of ARGs.

# 261 4.0 Interpretation of the abundance of ARGs

262 As shown in Figure 1 and Figure 2, a high abundance of ARGs was detected. 263 Compared with historical data of Huangpu River collected in July 2013 [29], the 264 ARGs abundance in Huangpu River detected in this study was several magnitudes 265 higher. Specifically, historical data shows that the abundance of tetracycline-resistant 266 genes was at the magnitude of 10 to 10<sup>4</sup> copies/mL [29], but in this study tetO abundance in Huangpu River reached up to 10<sup>6</sup> copies/mL (Figure 2). The hotspot 267 268 sample from Yangcheng Lake, Kunshan, contained *tetBP* at the magnitude of 10<sup>8</sup> 269 copies/mL (Figure 1). This finding suggests there could have been a surge of 270 antibiotic resistant bacteria in the Yangtze Delta during the past decade. 271 What is more, the hotspot and large standard deviations of ARG concentrations 272 imply that there might be point sources of ARG pollution, which elevated ARG 273 concentrations locally (e.g., hotspot of Sample S10), but could not disperse over a 274 wide area.

275

#### 276 *4.1 ARGs and Antibiotics*

In contrast with the detection of ARGs, antibiotic measurement results indicate
that antibiotic persistence in the environment was limited, with ELISA results
showing that all samples contained less than 1 µg/L of amoxicillin and tetracycline
(Table 3). This finding is consistent with other studies that show antibiotic
concentrations in surface water in Shanghai is at the magnitude of ng/L [13-15, 2931]. This indicates, despite low antibiotic risk, ARGs remain persistent in the aquatic
system.

284 Notably, persistence of tetracycline resistance was also reported in coastal 285 regions of Southeast China, which is geologically close to this study's sampling 286 region [32]. Though other mechanisms may also contribute to persistence of 287 tetracycline resistance (e.g., compensatory evolution), existing evidence supports 288 co-selection between resistance genes is the most likely cause of persistence of 289 tetracycline resistance [6], which will be discussed in following parts. 290 Additionally, it is worth noting that overall antibiotic levels in the Yangtze Delta 291 were observed to vary in accordance to seasons, with the number of detected 292 antibiotics and their detection frequencies being significantly lower in summer than in 293 winter [14, 15, 33, 34], except for tetracyclines [34]. The high flow conditions in

summer might dilute the concentration of antibiotics in the surface water [35], and

faster degradation of antibiotics in summer could also contribute to the low

concentration of antibiotics detected [34, 36]. The results of this study do not

297 guarantee a risk of antibiotics during the winter.

Though the correlation coefficient of ARGs and antibiotics cannot be calculated, considering the low level of antibiotic concentrations, it might be more prudent to

focus on direct remediation strategies for removing ARGs, instead of focusing only
on decreasing antibiotic contamination in surface water of the Yangtze Delta.

# 303 4.2 ARGs and Nonmetal Elements

304 As shown in Figure 3 and Figure 4, phosphorus exhibits a strong positive 305 correlation with tetO. One possible explanation for this correlation is that 306 phosphorus, as an essential biological element, enriches bacterial growth in 307 freshwater [37, 38]. The abundance of ARGs proliferate as the quantity of bacterial 308 cells increases. This positive connection between phosphorus and ARGs is also 309 reported by other studies in eutrophic environment [39, 40]. Though additional 310 assessment is needed to better understand the relationship between phosphorous 311 concentrations and ARG, the findings seem to suggest that regulating phosphorous 312 eutrophication could be a practical approach to manage ARG development in 313 surface water. One similar proposal is also given by Wang et al. 2020 [40].

314

#### 315 4.3 ARGs and Heavy Metals

316 As shown in Figure 3 and Figure 4, chromium and manganese exhibit a strong 317 positive correlation with tetO. The positive correlation of chromium could be a result 318 of co-selection between tetracycline-resistant genes and chromium-resistant genes 319 though co-resistance mechanism. Co-resistance describes the spatial association of 320 HMRGs and ARGs when they are located on the same genetic elements, such as 321 plasmids and transposons. This association means either heavy metals or antibiotics 322 can be the selection pressure for both resistance genes. A previous study cured 323 plasmids from Salmonella abortus equi strains and found the plasmids were resistant 324 to ampicillin, arsenic, chromium, cadmium and mercury simultaneously [41].

However, co-selection of manganese and ARGs is rarely reported. Further research is needed to confirm whether manganese truly has co-selective pressure on ARGs.

# 328 4.4 ARGs and Light Metals

A negative correlation was found between *ampr* and calcium, and strontium had a strong negative correlation with both *tetO* and *ampr* (Figure 3 & Figure 4). Interestingly, as noted, a previous study reported magnesium (Mg) could suppress resistant bacterial community [8]. Magnesium, calcium, and strontium all belong to

333 Group 2A on the periodic table. This means the three elements have similar

334 chemical properties, so it is possible that the three elements have a potential

inhibition effect on ARG through similar mechanisms.

336 Although negative correlation of strontium may be explained by its cytotoxicity on 337 bacteria [42, 43], molecular biology studies have reported selective inhibition effects of magnesium and calcium on antibiotic-resistant bacteria. Magnesium and calcium 338 339 may involve directly in the destabilization of the Staphylococcus aureus cell 340 membrane [44]. Calcium and magnesium can form a complex with Cardiolipin (CL), 341 one major component of the bacterial cell membrane, thus destabilizing the cell 342 membrane and eventually causing cell death [44]. In addition, calcium could 343 suppress bacterial growth through inhibiting peptidoglycan-layer (PG-layer) synthesis or destabilizing the cell membrane. PG-layer synthesis involves transpeptidase (TP) 344 345 enzymes, including D,D-TP and L,D-TP. These TP enzymes are the target of many 346 antibiotic  $\beta$ -lactams [45]. Calcium hinders the binding of L,D-TP to PG-stem by 347 inducing the formation of L,D-TP dimer [45]. 348 This finding reveals the possibility of developing Group 2A light metals as

349 reagents to control ABR. For example, as one of the major elements in nature,

350 calcium salts are of low toxicity and eco-friendly. Calcium-based reagent might be

351 capable of suppressing antibiotic resistant bacteria in natural environment if added to

352 natural surface water (e.g., exposure recreational water).

353

354 4.5 Limitations

355 Considering the reported seasonal variance in antibiotic concentrations [14, 15, 356 33, 34], the findings on antibiotic concentrations can only be generalizable to surface 357 water of the Yangtze Delta in summer. Also, impacted by the outbreak of COVID-19 358 Delta strain in China in 2021 Summer, the sampling stage of this study was 359 emergently terminated, ahead of schedule. The unexpected termination led to a 360 small sample size (15 samples). The small sample size decreases statistical power 361 and increases potential error in the results. Finally, ARG concentrations were of 362 large standard deviations in all four subregions. Though this could be explained as 363 indication of point sources of ARG pollution, one alternative explanation is there was 364 degradation of DNA during the experiments.

# 366 **5.** Conclusion

367 This study detected a high abundance of ARGs in surface water samples 368 collected from the Yangtze Delta, despite corresponding low antibiotic and low heavy 369 metal concentration. Phosphorus, chromium, manganese, calcium, and strontium 370 were identified as potential key contributors of ARGs in the Yangtze Delta. Reduction 371 of ARG abundance could be realized through decreasing the concentration of 372 phosphorus in surface water. In addition, Group 2A light metals (e.g., magnesium and calcium) were identified to have a potential ARG suppression effect, though 373 374 future studies are still needed to further evaluate this association.
