

1 **Exploring the use of social media and online methods to engage knowledge users in creating research agendas: Lessons from a pediatric**
2 **cancer research priority-setting partnership**

18 ABSTRACT

19 While social media is increasingly leveraged to engage knowledge users in research priority-setting, there remains sparse explicit descriptions on how to
20 implement it to build knowledge user-led research agendas. The aim of this study was to review a case study where social media was utilized to engage
21 Canadians within the pediatric cancer community in a research priority-setting exercise; specifically highlighting the social media-based recruitment process,
22 including recommendations on how to optimally engage key potential participants. A priority-setting partnership was launched to develop a stakeholder-driven
23 research agenda in pediatric cancer in Canada. Social –media-based strategies were implemented for participant recruitment, developing a website, launching
24 graphics and advertisements, and engaging internal and external stakeholders. These strategies incorporated the use of various social media platforms. We used
25 descriptive statistics to analyze the data, in addition to the analytics provided by the platforms mentioned. Throughout the duration of the PSP, we garnered 870
26 Instagram followers, 450 Twitter followers, 69 Facebook page likes, 27 TikTok followers, 20 LinkedIn followers and 789 unique visitors to our website. Our
27 Facebook page reached 28,641 people, while our Instagram profile reached 2,954 people. This social media campaign resulted in 330 individuals completing the
28 initial survey of the PSP, and 197 individuals completing the interim prioritization survey. Social media is a novel approach to engage stakeholders in the
29 development of a research agenda. Our study identified the following strategies as effective in increasing participation in our PSP: (1) creating a unified brand,
30 (2) prioritizing accessibility (e.g., providing alternative text for all images), (3) ensuring social media campaign is reflective of the target audience by diversifying
31 platforms and intermittently tailoring content to specific populations, (4) optimizing campaign’s reach via paid advertisements and circulating promotional
32 material to partner organizations and individuals for them to subsequently share with their networks.

35 **AUTHOR SUMMARY (250 words max)**

36 Our study evaluated the usage of social media to engage pediatric cancer patients, survivors, their family caregivers, and healthcare providers in setting research
37 priorities for the field of pediatric oncology. As a resource for other research teams, we offer a description of the traction gained by our social media campaign
38 and factors contributing to an increased engagement in the priority-setting process. Social media-based strategies were utilized for participant recruitment; this
39 included developing a website, launching graphics and advertisements, and engaging various stakeholders. Throughout the study duration, we gained 870
40 Instagram followers, 450 Twitter followers, 69 Facebook page likes, 27 TikTok followers, 20 LinkedIn followers, and 789 unique visitors to the study website.
41 Social media is a relatively new approach to engage individuals for research priority-setting. Our study identified the following strategies as effective methods to
42 increase engagement: (1) creating a unified branding, (2) prioritizing accessibility (e.g., providing alternative text for all images), (3) using various platforms and
43 tailoring content to specific populations, and (4) optimizing campaign reach through paid advertisements and by circulating promotional material to partner
44 organizations and individuals to share within their networks. Further investigation of the privacy implications of social media use for priority-setting research is
45 needed.

47 **BACKGROUND**

48 In recent years social media has gained an important role in healthcare, including engaging key healthcare knowledge users in research (1,2). Researchers are
49 increasingly utilizing Facebook, Twitter, and YouTube to enable participant recruitment into research studies (3,4,5) and to disseminate research findings (6).
50 Social media-based methods have also been increasingly used to enable the engagement of individuals with lived healthcare experiences (i.e., patients, family
51 members, clinicians, and other advocates) in setting research priority agendas (7). Historically, such agendas have been set with little reference to, or input from,
52 those with lived experience—limiting the capacity to effectively translate research findings into practice and policy (8,9,10). Consequently, there is a risk that
53 without the active engagement of patients, families, healthcare professionals and other advocates in research priority determination, researchers may face an
54 unfortunate cycle of producing underutilized evidence, with a resulting loss of public and professional trust and limited impact on patient outcomes.

55

56 In light of the critical need to engage those with lived experience in research agenda building and the potential opportunities to support such work through online
57 methods, our research team utilized social media, amongst other online tools, as a key method enabling knowledge user engagement in our pan-Canadian
58 pediatric cancer research priority setting partnership (PSP). In brief, through our PSP we surveyed the Canadian childhood cancer community to elicit their
59 research questions, and subsequently engaged the group in a priority setting activity to identify an inclusive childhood cancer research agenda. To create such an
60 inclusive agenda, we aimed to engage a diverse group of child patients, pediatric cancer survivors, as well as their family members and healthcare professionals.
61 This recruitment occurred within the bilingual (English and French).

62

63 While social media is more routinely leveraged to engage knowledge users in research priority-setting, there remains sparse explicit descriptions of the
64 methodology and how best to implement it to effectively build knowledge user-led research agendas (7). Here we review a specific case study where social
65 media and other online modalities were leveraged to engage Canadians within the pediatric cancer community in a research priority-setting exercise. As a
66 resource for other research teams, we offer a description of our social media-based recruitment process, engagement with our social media campaign, and factors
67 associated with increased engagement in our priority-setting process. We also discuss the limitations of our efforts and make recommendations on the specifics of
68 social media use to engage key knowledge users in PSP.

70 **METHODS**

71 Overview of Pediatric Priority Setting Partnership

72 We followed the James Lind Alliance process for the development of stakeholder-engaged research agendas (11). At the onset of our PSP, a steering group,
73 comprised of childhood cancer survivors, family members, and pediatric oncology clinicians was established. This steering group guided all operational

74 decisions of our project. The first step of our approach involved launching a national bilingual (French and English) online survey in the Winter of 2020 to
75 collect research questions from the Canadian pediatric cancer community. Collected questions were collapsed and collated into summary questions, which were
76 checked against the extant scientific literature. Adequately addressed questions were removed from the question roster and a second national, bilingual online
77 survey was launched in the Winter of 2021 requesting children with cancer, survivors, family members and health professionals to prioritize the unanswered
78 research questions. A shortlist of these questions was then taken to a pan-Canadian consensus-building workshop conducted in March 2022, where the top ten
79 research priorities in Canadian pediatric oncology were established. A full description of methods and results for this PSP is reported elsewhere. Social media
80 and other online tools were utilized to promote both of our online surveys.

81 Preparatory Activities for Social Media Campaign

82 *Scoping review*

83 Prior to launching our social media campaign, a scoping review was conducted to describe (1) the existing literature on social media-based strategies used to
84 enhance knowledge user participation in health research priority setting, (2) the recommendations for social media-based research priority-setting campaigns, (3)
85 the benefits and limitations of the method, and (4) the recommendations for future campaigns (7). We identified a total of 23 papers reporting on 22 unique
86 studies. Our central findings included identification of the social media platforms and online tools used to engage with health research stakeholders, the related
87 online engagement strategies utilized, methods to assess social media campaign effectiveness, and novel suggestions to enhance engagement in priority-setting.
88 The results of this review informed the social media strategies implemented in this study.

89 *Creation of social media content*

90 An initial branding package was created in Adobe Photoshop (CC 2017; Adobe, San Jose, CA). Two trained graphic designers created this package using brand-
91 unifying fonts, colour palette, and vector graphics. During the development of these graphics, the designers utilized WebAim

92 (<https://webaim.org/resources/contrastchecker/>) to ensure all graphics fulfilled the minimum colour contrast requirements for web and mobile accessibility. This
93 package was then reviewed by the PSP steering group to ensure the content and design was appropriate for the targeted audience of patient-, survivor-, family-,
94 and clinician-knowledge users. Steering group suggestions were used to modify and finalize the branding package. This branding scheme was then used as the
95 basis of a hub of static graphics and videos that would be utilized in the social media campaign. The corresponding text for social media posts, calling for
96 engagement in the PSP, was created by a researcher trained in marketing, in both English and French.

97 *Establishing analytic tools*

98 Dedicated social media accounts were created on Facebook (www.facebook.com), Twitter (www.twitter.com), Instagram (www.instagram.com), LinkedIn
99 (www.linkedin.com), YouTube (www.youtube.com), and TikTok (www.tiktok.com), ensuring that whenever applicable, accounts were registered under the
100 “business/professional” account types. This registration type enabled the option of viewing social media analytics, which included overviews of the demographic
101 characteristics of those engaging with our social media content (i.e., age, gender, education levels, job titles, location, language) and page insights (i.e., likes,
102 comments, shares, page views, page traffic and activities- including the length of time of individual sessions). We also created a Hootsuite account (Hootsuite
103 Inc), which provides access to aggregated analytics of all user profiles within various networks, as well as additional analytics (i.e., most common times of day
104 during which followers interact with social media accounts/pages). The Hootsuite platform also enabled the research team to schedule posts, and provided a
105 single point to launch posts across various social media platforms.

106 Social Media Engagement

107 *Initial launch of social media campaign*

108 A series of introduction posts were generated with the intention of establishing credibility related to our campaign. The first post identified the research project
109 members, including the research team and the steering group, and subsequent posts introduced the concept of a PSP. At the initial launch of our social media

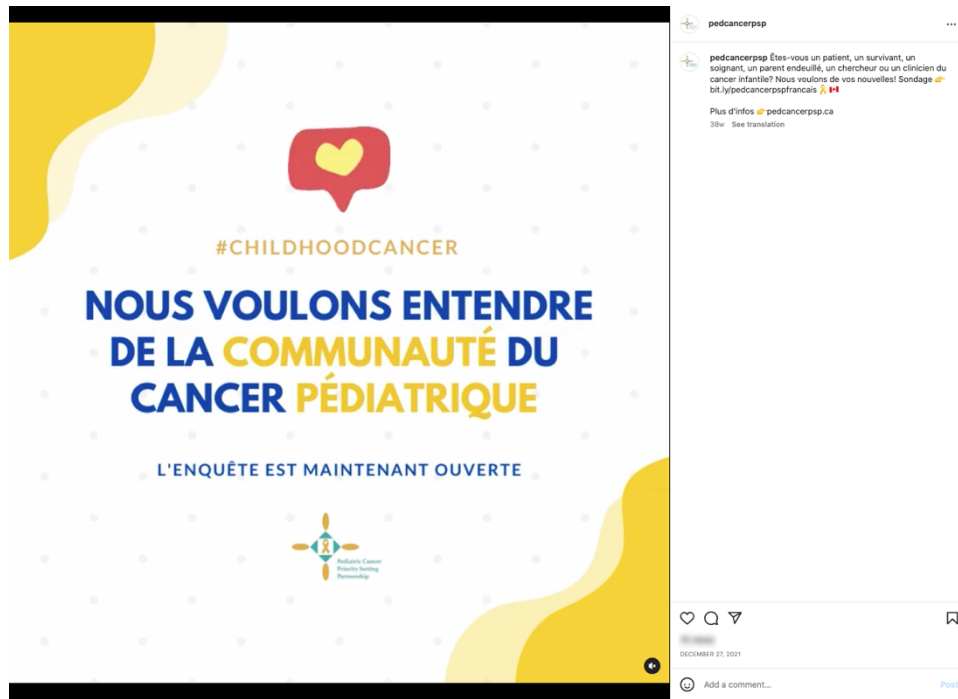
110 accounts, we contacted key childhood cancer organizations and social media users through direct messaging to introduce the PSP. We further began following
111 these users in an effort to increase the number of users interacting with the established social media accounts.

112 *Social media campaign*

113 The content of the social media posts included reviews of the goals of the PSPs, the key personnel involved, calls for action (i.e., encouraging users to complete
114 each survey), and, intermittently, posts relevant to the pediatric oncology community (e.g., recognizing childhood cancer awareness month). Posts typically
115 included graphics in the form of photos, videos, and graphics interchange format (GIFs), and associated text included hashtags, links (i.e., to the project website
116 or the survey), tags, and various relevant emojis. Sample graphics are shown in Figure 1a and 1b. Throughout the social media campaign, we monitored (1)
117 social media analytics to identify gaps in interaction with campaign and (2) demographics self-reported by survey participants to identify gaps in communities of
118 individuals completing each of the surveys. The identification of these gaps subsequently informed the content of future social media posts. For example, during
119 the campaign, these metrics helped the research team identify a decreased response rate from certain populations, including Black, Indigenous, People of Colour
120 (BIPOC), French-speaking individuals, and male-respondents, and efforts were made to target graphics towards these populations. We also monitored social
121 media analytics, which provided optimal timing for posts (i.e., the times at which the majority of our audience was online and interacting with our posts). Posting
122 schedule was continuously adjusted to reflect these optimal times. Sample targeted graphics are shown in Figure 2a and 2b.

129 *Paid advertisements*

130 During the social media campaign, we periodically implemented paid advertisements on Facebook, Instagram and Twitter. Our team closely monitored
 131 advertisement associated analytics to identify ways to augment the campaign. For example, we identified that video posts were more cost-effective than image-
 132 based posts, and all future advertisements were then solely accompanied with videos. Each social media platform required specifications on ad delivery, ad
 133 content, design language, targeted audience, including location, and dates of deployment. We also targeted paid advertisements towards the aforementioned
 134 underrepresented groups, by augmenting the “target population” options within the advertisement settings (e.g., to target French-speaking individuals, we
 135 restricted advertisements to be shown to Quebec residents only).

136 Additional Online Engagement Strategies

137 *Website*

138 Prior to launching our social media accounts, a website for the research project was created (www.pedcancerpsp.ca). This website was created using Wix
139 (Wix.com Ltd). During the development of the website, accessibility needs were optimized by ensuring alternative text was available for all graphics. The
140 website was also developed within the desktop and mobile version to ensure all devices could access our website. Finally, utilizing Wix's search engine
141 optimization (SEO) checklist, the website was set up to ensure it could be found via search phrases on various search engines. The SEO checklist included the
142 following components: (1) set the homepage's title for search results, (2) add the homepage's description for search results, (3) update the text on website's
143 homepage, (4) make website's homepage visible in search results, (5) optimize website for mobile devices, (6) connect website to a custom domain, and (6)
144 connect your site to a google search console. The website provided a centralized location for prospective participants to learn more about the project, the James
145 Lind Alliance methodology, the research team, and registration to our mailing list.

146 *Engagement via internal and external stakeholders*

147 Throughout the social media campaign, we contacted external stakeholders, including Canadian childhood cancer organizations, advocacy groups with prominent
148 social media accounts, and non-governmental organizations affiliated with pediatric cancer, and subsequently requested their assistance in promoting the project.
149 Contact methods included email correspondence, as well as direct messaging via social media platforms. When such individuals and organizations agreed to help
150 with survey promotion, we provided them with a template package, which included tailored graphics, pre-written messaging, sample newsletter graphics, and
151 draft emails that they may send to their contact lists. A similar methodology was implemented when engaging with internal members (i.e., members of the
152 research team and members of the steering committee).

153 Data Analysis

154 Facebook, Instagram, and Twitter provide analytics to page administrators, allowing for monitoring and assessment of the usage of a page; a similar tool is
155 available on Wix. These analytics allowed the research team to measure user engagement within each online platform. For Instagram, Facebook, and Twitter, we
156 monitored reach, impressions, and clicks. For our website, we monitored unique visitors, site sessions, and page views. We also collected demographic
157 information from our survey. Overall, we used descriptive statistics to analyze the data.

158 **RESULTS**

159 *Initial research priority-setting survey*

160 The initial research question gathering survey was available for completion from December 7, 2020, to March 3, 2021. A total of 330 individuals responded to
161 our initial survey, of which 80 (23.9%) were childhood cancer patients and survivors, 179 (53.4%) were family members and friends of children who have or had
162 cancer, and 76 were healthcare professionals (22.7%). The majority of family members/friends identified as mothers (n=161; 89.9%), followed by fathers (n=13;
163 7.3%), then friends (n=2; 1.1%). A range of multidisciplinary professionals responded, including registered nurses (n=32, 42.1%), oncologists (n=22, 28.9%),
164 physical therapists (n=3, 3.9%), and psychologists (n=3, 3.9%). Majority of responded lived in Ontario (n=160, 47.8%), with the second largest group living in
165 British Columbia (n=54;16.1%). There was representation from all of Canada's provinces, though there were no response from territory residents.

166

167 *Interim prioritization survey*

168 The interim research question prioritization survey was available for completion from January 10, 2022, to February 19, 2022. A total of 197 individuals
169 responded to our interim prioritization survey, of which 49 (24.5%) were children or survivors of childhood cancer, 102 (51.0%) were family members or friends
170 of a child that was diagnosed with cancer, and 49 (24.5%) were healthcare professionals who take care of children with cancer or survivors or do work in
171 research related to pediatric cancer or survivorship. More nurses (n=24, 49.0%) responded than medical doctors (n=10, 20.4%); and there were 6 (12.2%)
172 respondents that were research personnel and 6 (12.2%) selected 'Other.' The majority of survey respondents were once again Ontario residents (n=84, 42.0%),

173 followed by Quebec (n=59, 29.5%) and Alberta (n=16, 8%). Similar to the initial survey, there was representation from all the provinces, though there were no
 174 respondents from the Northern territories.

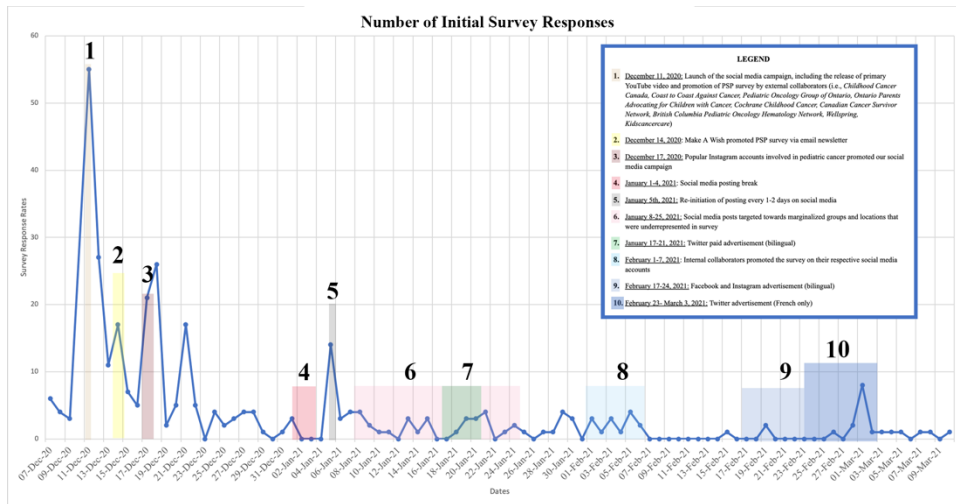

176 *Social media campaign overview:*

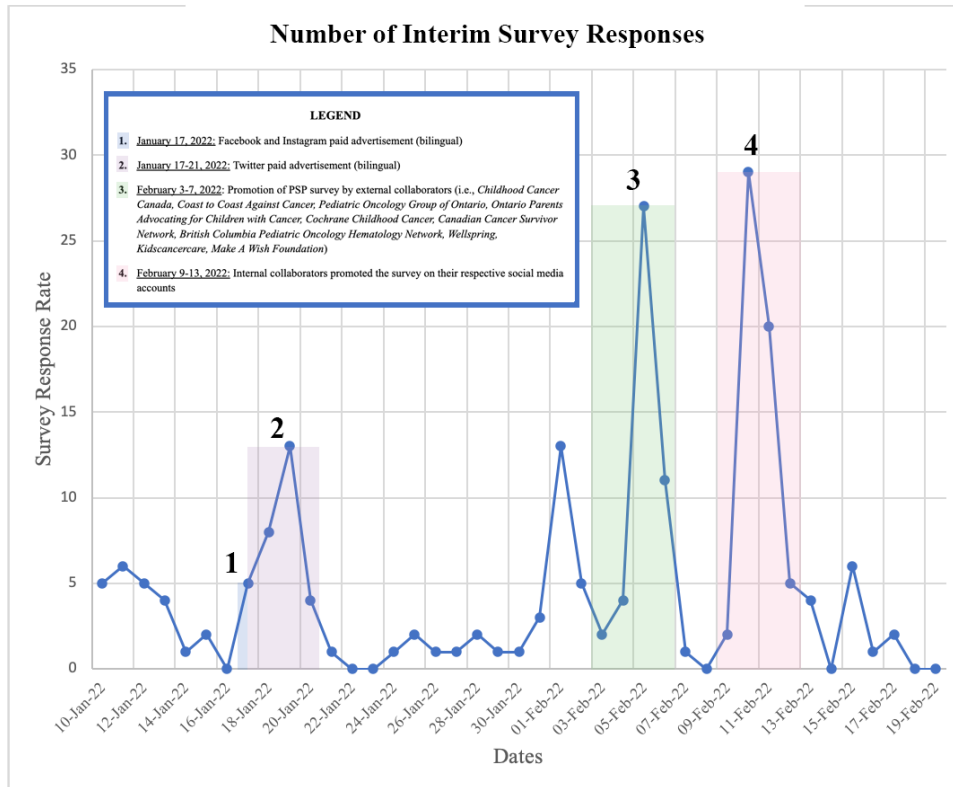
177 Over the course of our entire PSP—from April 2020 to September 2022—we garnered 870 Instagram followers, 450 Twitter followers, 69 Facebook page likes,
 178 27 TikTok followers, and 20 LinkedIn followers. Social media campaigning efforts were prioritized on Facebook, Twitter, Instagram, as well as our study
 179 website. Figures 3a and 3b provide an overview of how survey response rates correspond to key timepoints and efforts during the social media campaign period.

185 *Study website engagement*

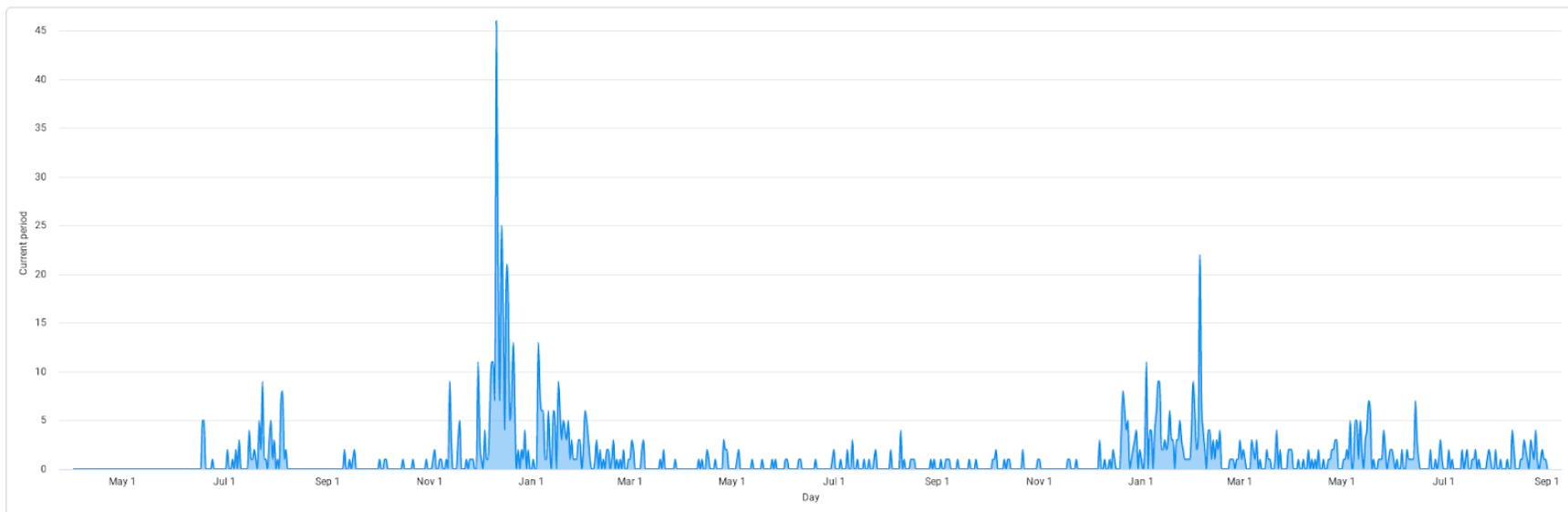
186 The study website received 1029 site sessions (visits ended after 30 minutes of inactivity), with 53% of users (n=547) accessing the site via desktop, 46% via a
 187 mobile device (n=470), and 1% via tablet (n=12). Figure 4 depicts the site session trend over time. Peak site sessions occurred between December 2020 to March
 188 2021, as well as January 2022 to March 2022—time periods that corresponded to the interval during which each survey was open.

189

190 The website garnered a total of 789 unique visitors, with most users accessing the website from Canada (n=622, 78.8%), followed by the United States (n=73,
 191 9.3%). Figure 5 depicts a map with the traffic by location. The majority of unique visitors were from social media (n=148, 32.7%), followed by direct referrals
 192 (n= 146, 32.2%), organic searches (n= 105, 23.1%), and referrals (n= 54, 11.9%). Direct referrals are defined as visitors that typed our site address directly into
 193 their browser, without clicking any link. Organic searches are defined as visitors that clicked an organic search result from a search engine, such as google.
 194 Referrals are defined as visitors that clicked a link placed on another website that is not a search engine or a social media platform. Table 1 provides more
 195 information on the specifics of the traffic source.

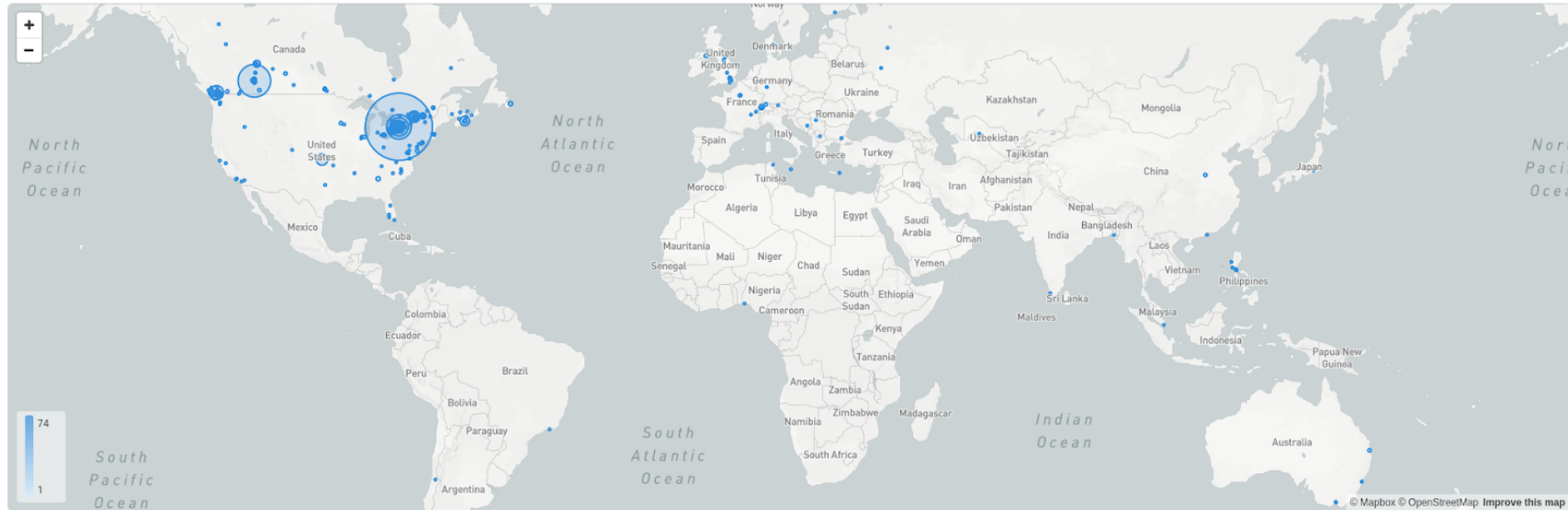

203 *Facebook, Instagram and Twitter-focused campaign engagement*

204 Over the course of the project, we made 152 posts on Facebook and 148 posts on Instagram. Our Facebook page was visited 426 times, while our Instagram
205 profile had 1,893 visits. The reach of our Facebook page, or the number of individuals seeing any content from or about the page (including from others who
206 interact with the page), was 28,641 people and our Instagram profile reach was 2,954 people, as seen in Figure 6. Considering activity related to our paid

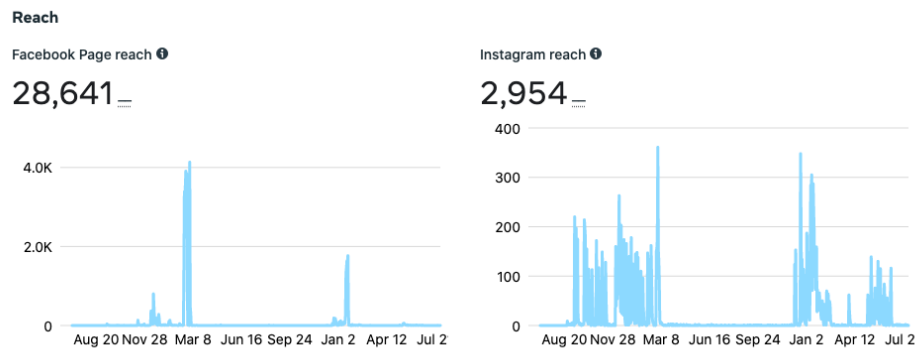
207 advertisements, over both Instagram and Facebook, our social media campaign’s paid content reach amounted to 24,137, while paid impressions (which may
 208 include multiple views of a post by the same individual) corresponded to 40,721. Paid reach compared to amount spent can be viewed in Figure 7.

209

210 Our Twitter page garnered 452 followers. The greatest number of impressions, defined as the number of times an individual viewed a tweet, during a 90-day
 211 period occurred in January to March 2021—a time period within which both organic posts and paid advertisements were implemented. Table 2 provides the
 212 number of impressions during 90-day time periods, the number of daily impressions, and details of the trend of impressions over the time period.

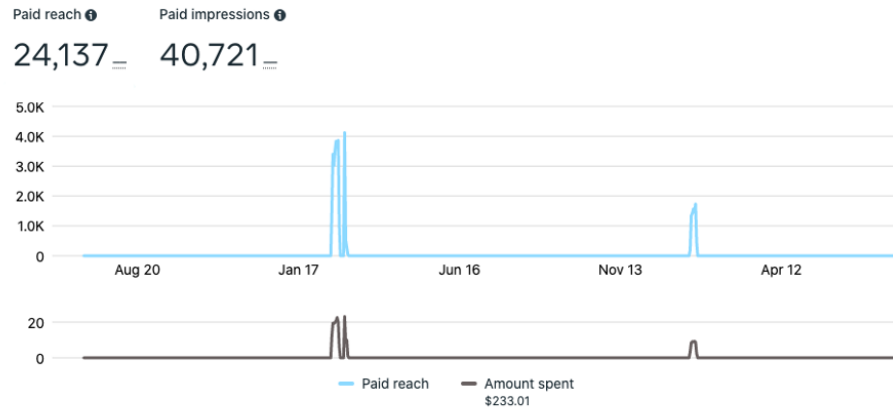
214 Figure 6. Facebook and Instagram reach

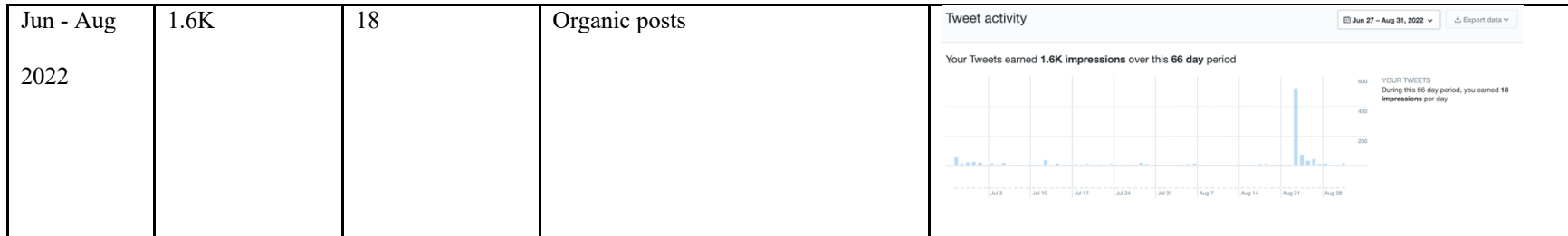

220 *Content and impact of individual social media posts*

221 Throughout the PSP, the top reaching post was a French-language advertisement (Figure 8). This post explicitly asked for knowledge user participation in

222 priority-setting, included related hashtags, and had an embedded link to the French language research prioritization. This advertised post reached 13,393 users,

223 resulting in 200 clicks on the survey link, with approximately a cost of 0.69 Canadian dollars per click. The top “organic” post was an English-language

224 Facebook post that reached 5,415 users, and resulted in 47 link clicks. Organic posts are defined as posts for which did not have paid advertisements applied.

225 From the top 10 posts across both Facebook and Instagram, the majority of the posts were video-based (n=9, 90%) as opposed to picture-based. Table 3 provides


226 an overview of the top five posts, from both Facebook and Instagram, including both paid and organic posts.



232 **DISCUSSION**233 *Principal Findings*

234 Social media represents a promising set of tools to support health research, including the engagement of knowledge users in research priority-setting. Our

235 research team successfully used a multi-pronged strategy leveraging social media and other online modalities to engage individuals with lived experience with

236 childhood cancer in our pan-Canadian pediatric oncology PSP. Overall, our results demonstrate the strong utility of social media as a means to engage

237 widespread and diverse knowledge users in PSP.

238

239 Our study website amassed 1,029 site visits, most of whom were directed to the page from our social media platforms (n=148, 32.7%). With website visitors
240 originating from various parts of Canada (n=622, 78.8%) and the United States (n=73, 9.3%), social media campaigning has allowed us to achieve a Pan-
241 Canadian survey by eliminating the traditional geographic barriers associated with such projects. Our campaigns on Facebook and Instagram had substantial
242 success in reaching knowledge users, 28,641 and 2,954 people respectively across both surveys. In a similarly Pan-Canadian PSP conducted by Brockway et al.,
243 most participants were recruited through social media campaigning (n=337, 70.2%), reflecting similar effectiveness as our initial survey dissemination, which
244 collected responses from 330 unique respondents (12). While our PSP survey recruitment was strictly limited to social media- and electronic network-based
245 promotions, Brockway et al. integrated an in-person component where participants were informed of the study then provided with a device to record their
246 responses (12). Though this in-person recruitment approach was inaccessible for our PSP due to the restrictions posed by the ongoing COVID-19 pandemic, the
247 limited number of survey respondents recruited by Brockway et al. through in-person sessions (n=143; 29.8%), minimizes the potential of sampling bias in our
248 study (12).

249
250 Furthermore, targeted paid advertising on social media platforms proved effective in increasing the reach of our social media campaign. Our posts which
251 received a paid boost reached more users than organic posts. In fact, we received the greatest number of Facebook and Instagram impressions when paid
252 advertisements were implemented and each paid advertisement period was accompanied by a peak in the number of survey responses collected by our team. The
253 apparent success in terms of knowledge user engagement resulting from the use of paid advertisements is in agreement with previous research (13,14,15). Several
254 studies demonstrate that this promotional effort results in reaching significantly more users (13,14,16). Based on our social media engagement analytics, video
255 posts tended to reach a broader audience than image-based posts (17). Given this insight, our paid advertisements were mainly used for our video contents to
256 optimize its effectiveness.

257

258 In addition to paid advertisements, we created social media content specifically targeting under-represented groups to encourage their participation. Throughout
259 the social media campaign, the research team monitored social media analytics and the diversity of survey responses to identify gaps in the social media
260 campaign and subsequently inform the content of future posts. When the research team identified lower survey response rates from people identifying with
261 certain demographic characteristics, targeted posts calling for the involvement of these populations were made. These efforts appeared successful and correlated
262 with an increased number of survey submissions from these groups. Additionally, to encourage pan-Canadian participation and representation from Francophone
263 Canadians, our entire social media campaign was bilingual with both French and English language posts made. In these ways, we employed a tailored approach
264 to reach specific populations on social media and avoided utilizing a “one-size-fits-all” dissemination technique. In similar studies assessing the application of
265 social media in health research, tailoring social media content to specific populations have shown to enhance engagement and users’ experience (18). Reflecting
266 the findings of our study, targeting content to particular groups has also been identified as an effective means to fill gaps in the reach of priority setting
267 partnership survey promotions (19,20).

268

269 We also collaborated with relevant organizations to promote our social media campaign. This strategy is embedded in the James Lind Alliance methodology and
270 was a key factor for success in research priority-setting as identified in our previous scoping review (7). In health research, there are challenges associated with
271 approaching members of the general public due to the inherent power dynamic that exists with healthcare providers (21). Thus, partnering with external
272 organizations and communities that are known and trusted by a social media target audience can help to build campaign credibility, overcome historical
273 challenges to research participation (22), and thereby increase the number of survey responses. Although, in principle, the possibility of content spreading widely
274 and organically via social media exists, this is difficult without an established and well-connected social media presence (16). Given that our project involved
275 building and utilizing new social media channels with no prior following, it was particularly important to leverage relationships with external organizations and
276 communities to promote our research prioritization surveys via their established networks. Our findings show that involving external individuals and
277 organizations in promotion directly translated to a surge in the survey response rate during the course of both the initial and interim surveys. External

278 organizations were more inclined to help with promotion when provided with a template package, including tailored graphics, pre-written messaging, sample
 279 newsletter graphics, and draft emails. Contacting organizational partners before the study start date, sending regular, brief reminders throughout the study period,
 280 and providing some degree of mutual benefit (e.g., study progress updates, providing a summary of study results) to encourage their support have proven
 281 beneficial in leveraging partnerships and furthering our outreach. Table 4 provides an overview of the specific recommendations derived from our social media
 282 campaign.

286 *Limitations*

287 There were limitations of this study and the corresponding social media campaign. We observed a substantial gap between the number of visitors to our social
288 media platforms and those that proceeded to open and complete the survey. This is a commonly cited limitation in PSP, where the social media campaign reach is
289 disproportionately greater than the survey response rates (16). Although the platform analytics (i.e., number of follows, comments, and likes on posts) were often
290 used as an indication of our survey engagement, these social media insights were not representative of the sample that proceeded to open the survey link and
291 complete the survey. While clear instructions on accessing and completing the survey were provided in each social media post, potential contributors to the low
292 response rate may have stemmed from uncertainty about eligibility or possible difficulties faced within the actual survey. Elaborating on these details and
293 improving within survey navigation may have yielded greater response rates from those interacting with our social media posts.

294

295 Another limitation of social media usage in priority-setting research includes the uncertainty of who is being captured through the posts (23). Social media-based
296 methods may unexpectedly include or exclude the research priority perspectives of certain groups (7). For our survey, the team ensured that social media posts
297 were accompanied with a clear definition of the survey respondent eligibility criteria. Additionally, the survey was prefaced by a screening question intended to
298 filter out ineligible respondents. Despite these efforts, we recognize that the widespread reach of social media contents inherently limits the control we have over
299 the survey respondents. Individuals that do not fit our PSP eligibility criteria were still able to complete the survey on their own accord. As such, social media-
300 based recruitment for PSPs constraints researchers' abilities to appropriately screen survey respondents. This is largely due to the limited control over who sees
301 the social media content once posted (24).

302

303 Despite our attempts to achieve a pan-Canadian survey, we experienced difficulty engaging certain geographic regions. Particularly, it was challenging during the
304 initial survey term to reach Francophones situated in Quebec. While we employed targeted posts and paid advertisements towards this population, these efforts
305 proved futile, as evidenced by the low respondent rate from Quebec residents in the initial survey (n=24, 7.3%). Similarly, across both surveys, there were

306 significantly more female respondents than male (n=441 and n=82, respectively). Thus, to promote a more diverse respondent demographic, we connected with
307 external groups (i.e., Quebec-based cancer organizations and private Facebook parent groups). This reinforces the importance of supplementing social media
308 posts with additional engagement strategies, including actively connecting with external stakeholders to promote the content.

309

310 Although social media campaigning efforts were prioritized on Facebook, Twitter, Instagram, and the study website, we expanded our outreach to YouTube and
311 TikTok—some of the most utilized social media platforms among young people (25,26). Given that our target audience included patients of childhood cancer, we
312 believed that availing to platforms that are more popular among the younger demographic (i.e., 0-18 years of age) would help better engage this population.
313 Despite our efforts to attract the younger age groups, we had limited data on the impact of these strategies. Specifically, given the short duration in which our
314 YouTube and TikTok accounts were active, there was limited insight collected on the effectiveness of these platforms in reaching younger aged survey
315 respondents. Recognizing that social media preferences among young people are constantly evolving, a continued understanding of forthcoming platforms
316 among the younger population is warranted (27).

317

318 *Future Research*

319 We recognize that little is known on the operation of social media algorithms. Further research is needed to understand how social media algorithms can
320 influence the capacity of social media recruitment to capture representative samples. More research is also needed to understand which social media strategies
321 and dissemination techniques are likely to be successful for research prioritization efforts, with the understanding that these strategies and techniques are likely to
322 change over time as new social media platforms and features become available.

323

324 Given the relatively nuanced role of social media in research methods, navigating the new territory for ethical approval warrants further research. Many of the
325 ethics requirements of customary recruitment techniques are difficult to translate to research using social media given the vast potential reach (16). A particular

326 ethical concern posed by social media recruitment relates to privacy. Privacy risk has been cited as a primary concern among research participants, particularly
327 for the general public with limited research background (28,29). In PSP exercises, the engagement of patients and their families are of utmost importance. Thus,
328 gaining exposure and continuing to evaluate aspects of social media from the context of privacy and users' comfort levels is critical to inform the development of
329 efficient and effective strategies to connect with the general public. In doing so, social media-based research methodologies can be placed in proper ethical
330 perspective and be utilized as a valuable recruitment tool.

331

332 **CONCLUSION**

333 The engagement of people with lived healthcare experiences in research priority-setting is critically important. However, the best methods for engaging
334 knowledge users are scanty identified in literature. Our study evaluated social media as a novel approach to engage pediatric cancer patients, survivors, their
335 family caregivers, and healthcare providers in the development of a Canadian research agenda. Diversifying recruitment across multiple platforms increased
336 response rates and improved the reach in an efficient manner. Utilizing paid advertisements, tailoring social media content to specific populations, and circulating
337 promotional material to partner organizations have proven effective in increasing engagement in our PSP. Further investigation of social media algorithms and
338 dissemination techniques is needed to understand how to increase representation among survey respondents. Consideration of the privacy implications of social
339 media use for research is also needed. Ultimately, continued evaluation of novel tools to enable inclusive priority-setting is needed to amplify the voices of those
340 with lived experience as it pertains to the next scientific efforts.
