

Supplementary file 2 to COVID-19 vaccine effectiveness against mortality and risk of death from other causes after COVID-19 vaccination, the Netherlands, January 2021- January 2022

Medical risk groups

Dutch national healthcare registry data were used to define underlying medical conditions that are associated with medical risk requiring prioritization in vaccination programmes. The national registry data comprised data from an all-payer claims database of (hospital-based) outpatient specialist care utilization, and data regarding medication prescriptions at ATC-4 code level in the Netherlands. Vektis Health Care Information Center manages the all-payer claims database to inform policy decisions and for risk equalization (i.e., to prevent risk selection in the healthcare system) (Geurten, 2022; Hasaart, 2011). In the Dutch funding system of 'Diagnosis Treatment Combination' (DTC), the reimbursement per case is fixed and based on the medical cost of the bundle of healthcare services ('care activities') associated with the diagnosis classification within a set period (CBS, 2022a; Hasaart, 2011). The medication dispense database is managed by the National Health Care Institute (CBS, 2022b).

This supplementary file lists the specific conditions that fall under two types of medical risk groups (i.e., high and intermediate medical risk), and lists the definitions that were made within the registry datasets to approximate these conditions. The medical high-risk group was defined based on conditions associated with high risk for severe COVID-19. These patients were prioritized for primary series vaccination in 2021. The medical intermediate-risk group was based on the eligibility criteria for influenza vaccination in the Netherlands. Both groups are described in the COVID-19 vaccination guideline of the Dutch National Public Health Institute (RIVM, 2022). For both groups, age and long-term care use are part of the criteria, but these variables were excluded from the definition of medical risk in the current study, as they were already included as time-varying variables.

Within the two data sources either one, or, a combination of three variables (DTC codes, care activity codes, and dispensed medications) were used to identify individuals within the medical risk groups. The individual-level, pseudonymized data were available within the secured working environment of Statistics Netherlands.

1) Outpatient specialist care utilization – Vektis

In the DTC data, we used the codes of the DTC product (7- or 8-digit codes) and care activities (6-digit codes) that were registered by medical specialists for the purpose of health insurance claims. The DTC product code relates to a (diagnosis) classification within a specific medical specialty (i.e., classifications are not uniform between medical specialties) and range from broad to narrow definitions. A care activity is more narrow-defined and is not (necessarily) specific to one type of DTC product.

With these DTC and care activity codes, we were able to identify individuals that visited a medical specialist in a given year for the treatment of relevant medical conditions. 2) Medication dispensing data – National Health Care Institute

Data on medication included all medication dispensed and covered by the statutory basic health insurance in the Netherlands. Medication received in hospitals and nursing homes are not included in the database. Dispensed medication is classified into ATC-4 codes according to the WHO drug classification system.
