Table S5a Significant differences were found between diagnostic and characterization groups $\left(\mu_{\mathrm{d}}=\right.$ 2.713, $\mathrm{U}=-9.215, \mathrm{n}_{1}=370, \mathrm{n}_{2}=224$, Wilcoxin Rank-Sum test, $\mathrm{p}<0.01$ ), and between diagnostic and treatment groups ( $\mu_{\mathrm{d}}=4.811, \mathrm{U}=-11.041, \mathrm{n}_{1}=370, \mathrm{n}_{2}=174, \mathrm{p}<0.01$ ). Characterization and treatment groups did not differ significantly ( $\mu_{\mathrm{d}}=2.098, \mathrm{U}=1.695, \mathrm{n}_{1}=224, \mathrm{n}_{2}=174, \mathrm{p}=0.09$ ).
