

Survey of Trainee Experiences and Attitudes Toward Anaesthesia Associates in the UK

For all doctors currently in a UK anaesthetic training programme, we are keen to hear your views whether you have or have not directly worked with Anaesthesia Associates (AAs). We understand that many anaesthetists might consider themselves as trainees whether or not they are on a formal training programme, e.g. Trust-employed CT3 top-up fellows, we welcome your input in this survey as well.

Formal professional regulation for Anaesthesia Associates is currently being formulated by the General Medical Council. Numbers are expected to increase over the next three years. This has raised a number of important questions with regard to the potential impact on anaesthetic training.

AAs have been in clinical practice in the UK for many years. A number of departments anecdotally report positive experiences with regard to management of clinical workload and the effect on anaesthetic training. To clear the waiting list backlog, the current workforce situation must be improved. However, given reductions in elective operating and the significant lack of training numbers for doctors wanting to enter or continue in anaesthesia, there is no clear evidence on the impact of an increase in AA practice on anaesthetic training.

There is currently one UK paper, published June 2022 (available here: <https://onlinelibrary.wiley.com/doi/epdf/10.1002/hpm.3502>) which interviewed 7 trainees (6 of whom had worked directly with AAs) and found the impact to be generally positive. To this end, there remains no robust evidence base that centres the trainee voice.

We are a group of UK anaesthetists who are keen to gain a clear idea of trainee views or experiences of working with AAs in order that this feedback can influence the direction of AA regulation and integration into the workforce.
