# Small-molecule functional rescue of PIEZO1 channel variants associated with generalised lymphatic dysplasia

#### Abstract

Generalised Lymphatic Dysplasia (GLD) is characterised by widespread lymphoedema, with at least one of the following: fetal hydrops, intestinal or pulmonary lymphangiectasia, pleural effusions, pericardial effusions and ascites. Satisfactory medical therapies are lacking. A genetic association has been identified that prevents expression or surface trafficking of PIEZO1, a subunit of mechanically activated calcium-permeable channels. However, PIEZO1 is a large and highly polymorphic gene and interpretation of variants identified in this gene can be challenging. PIEZO1-related GLD with non-immune fetal hydrops is autosomal recessive, however, heterozygous variants in PIEZO1 (often gain-of-function) causing Dehydrated Hereditary Stomatocytosis (DHS) (a relative mild anaemia), may also present with perinatal non-immune hydrops (not caused by anaemia).

Here we sought to develop methods to confirm pathogenicity of missense variants of uncertain significance in PIEZO1, to gain deeper understanding and pharmacological solutions. Four


novel GLD-associated missense variants in PIEZO1 are identified that express and surface localise as full-length protein but with reduced or abolished mechanically activated channel function. Yoda1, a small-molecule agonist, functionally rescues the channels and their physiological regulation by mechanical force and hypo-osmolality. The GLD-associated variants mediate intracellular calcium release as well as calcium entry, suggesting two pools of channels and opportunity for increased rescue through access to the intracellular pool. New Yoda1 analogues are also identified that improve rescue.

The functional assays have assisted the interpretation of the variants of uncertain significance as the data suggest loss of PIEZO1 force sensing as a cause of the GLD observed in the patients. The potential to pharmacologically overcome the loss of force sensing was demonstrated and supports the concept of stimulation of PIEZO1 with an agonist to address wide-ranging problems of lymphatic insufficiency.

## HIGHLIGHTS

1. Previously unrecognised variants in PIEZO1 that associate with GLD are identified and characterised and pathogenicity confirmed
2. The variants encode single amino acid changes that inhibit PIEZO1 channel activation by physiological mechanical forces
3. A small-molecule agonist rescues the channels and their physiological regulation
4. Variants are partly intracellular, suggesting an opportunity for improved rescue through the use of intracellular-acting agonists
5. New agonists are identified that improve rescue, suggesting routes to medical therapies for GLD and potentially other disorders of lymphatic insufficiency

## INTRODUCTION

The lymphatic system is required for fluid homeostasis, dietary fat absorption and immune function ${ }^{1-3}$. It is a uni-directional system which begins as blind-ended lymphatic capillaries that converge into peristaltic collecting vessels, passing contents through lymph nodes to the thoracic duct and draining into the subclavian vein ${ }^{2,4}$. Lymphoedema results from imbalances between lymph formation and its absorption into lymphatic vessels, leading to excess interstitial fluid ${ }^{3}$. Lymphoedema is a common condition that affects at least 120 million people globally and for which therapeutic options are limited ${ }^{4}$. Most frequent is secondary lymphoedema (often caused by tissue damage e.g. infection, surgery, cancer) but primary disease (often caused by heritable defects) is a significant problem and one that has led to important insight into the molecular mechanisms of the human lymphatic system.

Generalised Lymphatic Dysplasia (GLD) is a form of primary lymphoedema estimated to affect about 1 in 6000 people ${ }^{5}$. It presents with oedema of multiple segments (limbs, face, genitalia) and includes internal lymphatic problems such as pulmonary or intestinal lymphangiectasia, pleural effusions, chylothoraces, pericardial effusions, ascites and non-immune fetal hydrops (NIFH) in the second trimester ${ }^{5}$. Patients with this condition frequently experience recurrent cellulitis particularly facial cellulitis which can be life-threatening, and there can be serious psychological consequences such as depression ${ }^{5,6}$. There are currently no cures or medical therapies; instead, symptoms are managed through diet and techniques that minimize fluid build-up and stimulate fluid flow, such as the wearing of compression garments, massage, skin care, and exercise ${ }^{5}$.

Pathogenic genetic variants in at least 16 genes have been associated with GLD ${ }^{3}$. One of the genes encodes PIEZO1 ${ }^{7,8}$, which is a large membrane protein of 38 membrane-spanning segments that assembles as a trimer to form a calcium ion $\left(\mathrm{Ca}^{2+}\right)$-permeable non-selective cationic channel ${ }^{9-12}$. A striking feature of the channel is its exquisite sensitivity to activation by mechanical forces, leading to the hypothesis that its primary biological purpose is the detection of such forces and the coupling of them to cell function ${ }^{9,13-16}$. Although PIEZO1 is widely expressed, murine gene disruption studies suggest particular importance in endothelial biology where it has a role in detecting shear stress, a force arising from the flow of blood or lymph abutting the endothelial surface ${ }^{17-24}$. Essential roles for PIEZO1 in lymphatic development, maintenance and regeneration have been previously described ${ }^{21,25,26}$. Studies
on GLD patients suggest that the lymphatic endothelium is especially vulnerable to disruption of PIEZO1. GLD-associated PIEZO1 variants have been identified and characterised that act by disrupting protein expression or localisation of PIEZO1 to the surface membrane ${ }^{7,27}$.

NIFH carries a high mortality rate. It is a non-specific, heterogeneous presentation, thus understanding the underlying cause can improve prognostication for the pregnancy. Fetal hydrops related to PIEZO1 may result in the baby's demise but if the baby survives the neonatal period and the hydrops resolved, it can be associated with a reasonably good outlook. As PIEZO1 is a large, highly polymorphic gene, variants of uncertain significance (VUS) are frequently identified. Interpretation of these variants can be challenging particularly in a fetus presenting with just hydrops. Developing a robust functional assay will assist in the interpretation of these VUS and improve patient management. Therefore, tools for interpretation of VUS are extremely important if identified during pregnancy.

Here we expand the depth of information about PIEZO1 in GLD. We identify novel, missense, variants in the PIEZO1 gene. We characterise their effects, provide new mechanistic perspectives and suggest possible routes to a medical therapy.

## RESULTS

Clinical cases with Generalised Lymphatic Dysplasia (GLD) Since the report of 6 families with PIEZO1 variants associated with NIFH and GLD ${ }^{7}$, several additional probands with an overlapping phenotype have come to our attention. For this study, 3 probands and their families with missense variants were selected for further characterisation of the variants, initially to assist in evaluation of pathogenicity.

The clinical features of affected individuals are summarised in Table 1 and described in the SI. Pedigrees are presented in SI Figure S1. The proband (II.1) in family GLD07 had a typical presentation with antenatal NIFH, polyhydramnios and congenital oedema of the lower limbs, face and intermittent swelling of the scrotum with chylothoraces and some ascites (SI Figure S2).

A father (I.2) and two sons (II. 1 and II.2) from family GLD08 presented with a pseudo-dominant mode of inheritance due to a high level of consanguinity. An affected aunt had died of chylothoraces. I. 2 had bilateral chylothoraces and chylopericardium with onset in his 30 s. He developed bilateral lower limb lymphoedema in his 40s. II. 1 also had bilateral chylothoraces and chylopericardium in young adulthood (SI Figure S2). He developed bilateral lower limb lymphoedema with scrotal oedema some years later in his 30 s. II. 2 developed bilateral chylothoraces aged 10-14 years with mild lower limb lymphoedema and bilateral hydrocoeles.

The proband (II.1) from family GLD09 presented with bilateral hydrothoraces at 19 weeks gestation and polyhydramnios (SI Figure S2). He had congenital oedema of both lower limbs and the penile shaft and foreskin with intermittent scrotal oedema. His problems also included autistic spectrum disorder, metopic craniosynostosis and severe gastro-oesophageal reflux. His father (I.1) had congenital oedema of the lower limbs and developed swelling of both hands in his 20s but no systemic involvement.

Variant identification, interpretation and classification All coding exons of PIEZO1 were screened in the 3 probands using Sanger sequencing, identifying 4 novel or rare missense variants in PIEZO1 (SI Table S1). The variants encode the amino acid changes G1978D and R2335Q in trans in the proband of family GLD07, a homozygous I2270T variant in two generations of the second family GLD08 (pseudo-dominant inheritance), and E829V and I2270T in trans in the proband of the third family GLD09 (Table 1, SI Figure S1; single-letter amino acid codes are used).

Wild-type (WT) amino acids at these positions are conserved across diverse species and in the only related channel protein, PIEZO2, except for isoleucine's replacement by leucine in the case of I 2270 (SI Figure S3). The variants are predicted to be pathogenic by most in silico tools (SI Table S1). One variant, G1978D, is not observed in gnomAD, the other 3 variants are extremely rare (MAF $=0.0000197-0.00000654$ ) and none is observed in homozygous carriers. However, classification of the variants using the ACMG guidelines ${ }^{28}$ places all 4 in class 3, which indicates a VUS because there is not enough evidence for scoring it as pathogenic (SI Table S1). Therefore, we used laboratory methods to investigate the variants.

Inhibitory effects of variants on channel function WT human PIEZO1 (hPIEZO1) and variant forms of it were transiently overexpressed in a modified HEK 293 cell line. Intracellular $\mathrm{Ca}^{2+}$ was quantified by measuring fluorescence (F) from a ratiometric $\mathrm{Ca}^{2+}$ indicator fura-2 ${ }^{29}$, since PIEZO1 channels are $\mathrm{Ca}^{2+}$ permeable and usually cause elevation in intracellular [Ca ${ }^{2+}$ ] when activated ${ }^{13}$. Yoda1, a synthetic PIEZO1 agonist, was applied at a concentration of $1 \mu \mathrm{M}$ to induce about $30 \%$ of its maximum effect in WT hPIEZO1 ${ }^{30}$. WT channels respond with a peak ratio change ( $\Delta \mathrm{F}_{\text {ratio }}$ ) of about 0.2 compared with $<0.05$ in empty vector-transfected control cells (Figure 1a). hPIEZO1 mutants that mimic the GLD-associated variants (G1978D, R2335Q, E829V and I2270T) lead to signals above the background of control cells but 65$90 \%$ less than those of WT (Figure 1a, b). Similar effects occur when the variants are recapitulated in mouse PIEZO1 (mPIEZO1) (G1994D, R2351Q, E824V and I2286T) (Figure 1b, c). Patch-clamp technique provided an orthogonal assay, enabling recording of electric current through the channels and determination of responses to membrane stretch (instead of Yoda1) induced by pressure applied to the patch pipette. The membrane patches contain multiple channels, so macroscopic (i.e., multiple unitary) currents are seen (Figure 1d). Increasing current is shown as downward deflection (i.e., negative values) based on convention for ionic current arising from inward flux of cations. WT channel currents were compared with currents through channels containing I2270T, which occurs in 2 of the families (SI Figure S1). WT channel shows the expected ${ }^{13}$ rapid activation (i.e., initial fast rise in inward current) followed by inactivation (i.e., progressive loss of inward current despite sustained pressure) whereas I2270T shows no current (Figure 1d). Overall, the data suggest inhibitory effects of the GLD-associated variants; i.e., loss-of-function phenotypes.

Suppressed but not abolished expression Potential explanations for loss-of-function are failed expression or surface localisation ${ }^{7,27}$. We investigated changes in protein expression and localization for the 4 novel variants by expressing hemagglutinin (HA)-tagged WT and variant hPIEZO1 or mPIEZO1 in the HEK 293 cell line. We performed biochemical analysis including protein surface biotinylation, using anti-HA antibody to specifically recognise
exogenously-expressed channels. Importantly, the variants express and localise to surface membrane (Figure 2a-c). The variants are detected in lower amounts than WT but for 3 of them the reductions are relatively small (Figure 2a-c) compared with the large effects on their function (Figure 1a-d). The E829V and E824V variants (hPIEZO1 and mPIEZO1 respectively) are an exception, showing strongly reducing protein expression relative to WT and reducing expression of WT when it is coexpressed, suggesting dominant negative effect of the E829V variant (Figure 2a-d). Overexpression of WT did not rescue this variant (Figure 2d). The data suggest that all variants express as intact proteins at the surface membrane. There are reductions in protein amounts relative to WT but not sufficient to explain the strong loss-offunction seen with variants such as I2270T (e.g., Figure 2a compared with Figure 1d).

Diverse structural loci To generate hypotheses for how channel function is lost and might be regained, we generated molecular models of hPIEZO1 and mPIEZO1 channels (SI Figure S4) based on experimentally-derived high resolution structural data for mPIEZO1 ${ }^{11,31-33}$. I2270T/I2286T (hPIEZO1/mPIEZO1) and R2335Q/R2351Q are at opposite corners of the Cterminal extracellular domain (CED), G1978D/G1994D is in the central membrane-spanning region (but outside the pore-lining helices and inactivation gate) and E829V/E824V is distal from the central core, far out in the blade structures that determine mechanical sensitivity and are linked to the ion pore region via the beam structure (SI Figure S4). The putative interaction site for Yoda1 ${ }^{34}$ does not overlap with the affected amino acids (SI Figure S4). Comparisons of hPIEZO1 and mPIEZO1 suggest strong conservation of structure, including at the loci of the 4 variant residues (SI Figure S4), which is consistent with the similar functional results for hPIEZO1 and mPIEZO1 (Figure 1b). The data suggest diverse structural locations of the affected amino acids, previously unrecognised functional domains of PIEZO1 and crossspecies conservation of the affected sites.

Suppressed glycosylation To investigate variant channels in detail, we focused on mPIEZO1 because it is the basis of PIEZO1 structural data and generates larger and more robust functional signals than hPIEZO1, facilitating quantitative analysis (e.g., Figure 1c compared with Figure 1a). As shown in SI Figure S4, I2286T and R2351Q are in the CED. This is the site of functionally important N -linked glycosylation ${ }^{35}$. Both residues are close to the glycosylated asparagine ( N ) residues (Figure 2e, SI Figure S5). Consistent with mPIEZO1 being glycosylated at these residues, it migrates at two molecular masses (Figure 2f). Mutation of the asparagine residues to alanine (N2310A and N2347A) abolishes the upper mass band (Figure 2f). I2286T and R2351Q reduce the density of the upper relative to the lower mass (Figure 2f), suggesting impaired glycosylation. Similarly, I2270T reduces the intensity of the upper mass in hPIEZO1 (Figure 2a). N2310A_N2347A double mutation reduces Yoda1evoked $\mathrm{Ca}^{2+}$ signals by about $30 \%$, consistent with there being importance of glycosylation in channel function (Figure 2g). The data suggest loss of glycosylation as a contributor to the loss-of-function seen in I2270T and R2335Q variants, but that it is not a large enough functional effect to explain their major impact.

Suppressed or abolished mechanical activation The I2270T variant shows loss of mechanical sensitivity (Figure 1d) and the location of 2 of the variant residues is the blade structure (SI Figure S4), which is a region that determines mechanical sensitivity of the channels ${ }^{16}$. We therefore hypothesised that some variants affect the mechanical sensitivity of
the channels. We sought to test this idea experimentally. Low endogenous expression of hPIEZO1 sometimes occurs in HEK 293 cell lines ${ }^{36}$, but no pressure-evoked currents are detected in cells transfected with vector alone (Figure 3a, SI Figure S6). By contrast, in cells transfected with WT mPIEZO1 there are inward currents that increase and gradually saturate as the maximum pressure step is approached (Figure 3b-d, SI Figure S6). WT currents exhibit three kinetic types: fast activation and inactivation; fast activation and non-inactivation; and slow activation and non-inactivation (Figure 3b, c). Native PIEZO1 channels similarly show variable inactivation ${ }^{33,37,38}$, possibly due to variable lipid regulation ${ }^{33}$. Pressure required for $50 \%$ activation ( $\mathrm{P}_{50}$ ) of peak WT current is 47.8 mmHg (Figure 3c, d). This is similar for currents of the three types or current measured at the end of the 200-ms pressure pulse (SI Figure S6). Like I2270T in hPIEZO1 (Figure 1d), I2286T in mPIEZO1 prevents mechanical activation of current (Figure 3e, f). R2351Q similarly prevents mechanical activation (Figure 3e, f). G1994D and E824V do not prevent current but shift the pressure curve to the right and reduce the activation rate and inactivation (Figure 3e, g, h). G1994D currents do not reach a maximum (Figure 3h). E824V channels activate at a similar or lower threshold compared with WT except there is a biphasic pressure-response relationship, with the second phase requiring high pressures (Fig 3 h ). $\mathrm{P}_{50}$ for the first phase is 38.9 mmHg but the second $\mathrm{P}_{50}$ could not be determined because saturating responses did not occur (Figure 3h). Pressure pulses larger than 105 mmHg often damaged patches, making them leaky to non-specific current, so no data are shown past this pressure. The data suggest that the variants inhibit the ability of the channels to respond to mechanical force.

Pharmacological rescue Although R2351Q and I2286T channels do not activate in response to mechanical force (Figure 3e, f), they show small responses to $1 \mu \mathrm{M}$ Yoda1 (Figure 1b, c). Moreover, the structural models place all variant residues away from the putative Yoda1 interaction site ${ }^{34,39}$ (SI Figure S4), suggesting that Yoda1 activity might be retained. We investigated this further by constructing Yoda1 concentration response curves in $\mathrm{Ca}^{2+}$ assays for empty vector- and mPIEZO1-transfected HEK 293 cells (Figure 4a-c). Empty vectortransfected cells show small or no response to Yoda1 (Figure 4a) whereas overexpressed WT channels show robust responses; a sigmoidal concentration-response curve with an approximate threshold for activation at about $0.03 \mu \mathrm{M}$, saturating maximum response between 1 and $10 \mu \mathrm{M}$ and concentration for $50 \%$ activation ( $\mathrm{EC}_{50}$ ) at $0.24 \mu \mathrm{M}$ (Figure 4b, c). All of the variant channels show robust $\mathrm{Ca}^{2+}$ responses (Figure $4 \mathrm{c}-\mathrm{g}$ ). Concentrations of Yoda1 above $1 \mu \mathrm{M}$ greatly amplify their responses but thresholds for activation are to the right of WT (above $0.1 \mu \mathrm{M}$ ) and saturating curves and $\mathrm{EC}_{50}$ S are not obtained (Figure 4c). Concentrations of Yoda1 above $10 \mu \mathrm{M}$ are not reliably investigated because Yoda1 has poor aqueous solubility at such concentrations ${ }^{40}$. Similar results occur in independent stable cell lines for WT and variant channels (SI Figure S7). Coexpressed G1994D and R2351Q channels aimed at mimicking the compound heterozygous state of patient GLD07 II. 1 (SI Figure S1) are also activated by Yoda1 (Figure 4h, i). The data suggest potential for pharmacological rescue of variant channels.

Improved rescue with long agonist exposure Responses of variant channels are slow compared with WT channels (Figure 4d-g compared with Figure 4b) and so we recorded $\mathrm{Ca}^{2+}$ for longer, should short recordings underestimate variant channel responses. WT channel
responses to high concentrations of Yoda1 peak rapidly and decay but there is still $\mathrm{Ca}^{2+}$ elevation at 10 min (Figure 4j). Responses to low concentrations of Yoda1 are mostly sustained (Figure 4j). We extended exposure to at least 20 min and constructed concentrationresponses curves. The Yoda1 $\mathrm{EC}_{50}$ for WT channels is now 2.2 -fold improved at $0.11 \mu \mathrm{M}$ (Figure 4 k compared with Figure 4c). A second phase of effect occurs at $10 \mu \mathrm{M}$, which is not seen in the short recordings (Figure 4k). Long exposure enables full concentration-responses curves for all variant channels, revealing $\mathrm{EC}_{50}$ s closer to those of WT channels at $0.31 \mu \mathrm{M}$ (G1994D), $0.42 \mu \mathrm{M}$ (R2351Q), $0.29 \mu \mathrm{M}$ (E824V) and $0.41 \mu \mathrm{M}$ (I2286T) (Figure 4I). The data suggest that long exposure enhances Yoda1 potency and rescue.

Involvement of intracellular PIEZO1 channels Long exposure to Yoda1 could activate downstream mechanisms that amplify the $\mathrm{Ca}^{2+}$ signal, such as ATP release activating P2Y2 receptors that lead to $\mathrm{Ca}^{2+}$ release via inositol $1,4,5$-triphosphate signalling ${ }^{23}$ and arachidonic acid metabolism activating $\mathrm{Ca}^{2+}$ permeable TRPV4 channels ${ }^{41}$. However, inhibiting ATP and TRPV4 responses has no effect on Yoda1 responses (SI Figure S8). Alternatively, there could be PIEZO1 in intracellular membranes mediating $\mathrm{Ca}^{2+}$ release ${ }^{42}$ in addition to PIEZO1 in surface membrane mediating $\mathrm{Ca}^{2+}$ entry, each with different Yoda1 sensitivity due to different accessibility. Lowering of the extracellular $\mathrm{Ca}^{2+}$ concentration only partly inhibits the Yoda1 response (Figure 5a), consistent with $\mathrm{Ca}^{2+}$ release occurring as well as $\mathrm{Ca}^{2+}$ entry. In support of a $\mathrm{Ca}^{2+}$ release contribution, predepletion of $\mathrm{Ca}^{2+}$ stores by thapsigargin ${ }^{43}$ also partly inhibits the Yoda1 response (Figure 5b). As expected because of limited $\mathrm{Ca}^{2+}$ storage capacity, extracellular $\mathrm{Ca}^{2+}$ becomes critical when Yoda1 exposure is long (Figure 5c). Yoda1 responses of G1994D channels are relatively little affected by thapsigargin but R2351Q, E824V and I2286T channel responses are strongly inhibited (Figure 5d-f). The data suggest a contribution of intracellular $\mathrm{Ca}^{2+}$ release mediated by PIEZO1 channels in the functional rescue by Yoda1.

Rescued mechanical force sensitivity Yoda1 synergises with mechanical force in PIEZO1 activation ${ }^{44}$ and this could be important in vivo because of the presence of endogenous forces such as lymphatic pressure. Pressure pulses were therefore again used to increase membrane tension and activate the WT and variant channels. Pressure-activated WT currents in outside-out patches are enhanced by Yoda1 (Figure 6a). G1994D channels were investigated next because they express robustly at the surface membrane (Figure 2b, c) and reduce without abolishing pressure responses (Figure 3h). Similar to WT, G1994D currents are enhanced by Yoda1 (Figure 6b). Yoda1 protected these channels from spontaneous rundown (Figure 6b). Basal activation by Yoda1 is minimal in the absence of the pressure pulse, consistent with Yoda1 synergising with force (Figure 6a, b). In the absence of Yoda1, G1994D channel currents do not reach a maximum even at 105 mmHg (Figure 3h) but Yoda1 increases the pressure sensitivity so that a full curve can be constructed, revealing a $P_{50}$ of 64.6 mmHg (Figure 6c), which is an improvement, although still to the right of WT in the absence of Yoda1. R2351Q and I2386T variant channels are pressure insensitive without Yoda1 (Figure 3f) but respond to pressure in Yoda1's presence (Figure 6d), showing greater fold-change response to Yoda1 than WT channels (SI Figure S9). E824V channels were not investigated in this assay because their pressure sensitivity is only modestly different from that of WT channels
(Figure 3h). The data suggest that pharmacologically rescued variant channels become sensitive to mechanical force, thus with the potential to respond to physiological stimuli.

Synergy with hypo-osmolality Hypo-osmolality may occur in oedema, affecting lymphatic function and enhancing PIEZO1 activity ${ }^{45,46}$. In empty-vector transfected HEK 293 cells, there are small $\mathrm{Ca}^{2+}$ elevations in response to hypo-osmolality and these signals are enhanced when WT channels are transfected in (Figure 7a), consistent with the suggestion that PIEZO1 activity is stimulated by hypo-osmolality ${ }^{46}$. In the presence of Yoda1, hypo-osmolality responses are larger, despite the elevated baseline signal caused by Yoda1 (Figure 7b). All 4 variant channels show hypo-osmolality responses in Yoda1's presence (Figure 7c) but not in its absence (SI Figure S10). The Yoda1 concentration-response curve for WT channels does not reach a maximum in the hypo-osmolality condition and the curves for variant channels are now similar to those for WT channels except for the modest right-shifts of R2351Q and I2286T channels (Figure 7d, SI Figure S10). The data suggest that pharmacologically rescued variant channels are sensitive to hypo-osmolality as well as mechanical force, which could enable their preferential activation in oedema.

Thiazole modification of Yoda1 improves rescue Seven novel Yoda1 analogues (SI Figure S11) and Dooku1 (KC41) ${ }^{30}$ were tested for their ability to enhance the hypo-osmolality and sustained $\mathrm{Ca}^{2+}$ responses beyond those of Yoda1 (SI Figure S12). The thiazole analogue, CHR-1871-032, shows similar or sometimes larger sustained activation and increased hypoosmolality responses (SI Figure S12). Short-duration exposure to CHR-1871-032 generates an $\mathrm{EC}_{50}$ of $0.14 \mu \mathrm{M}$ at WT channels (Figure 8a, b), which is better than that of Yoda1 (Figure 4c). Construction of complete concentration-response curves is enabled for 3 of the variant channels, revealing $\mathrm{EC}_{50} \mathrm{~S}$ of $0.71,0.76$ and $1.0 \mu \mathrm{M}$ for I2286T, E824V and G1994D channels respectively (Figure 8a, b). The I2286T channel is now the most potently activated variant channel. R2351Q channel activates but the curve does not saturate, preventing EC ${ }_{50}$ determination (Figure 8a, b). Side-by-side comparison of the effects of Yoda1 and CHR-1871032 further supports the suggestion that CHR-1871-032 improves rescue of variant channels (Figure 8c). Five of the other analogues were tested for effectiveness at variant channels (SI Figure S12). None shows better rescue than Yoda1 but analogue KC183 has similar effect to Yoda1 at the G1994D variant channel (SI Figure S12). The KC183 response is slow (SI Figure S12), a feature that may be useful for generating prolonged responses in vivo. The data suggest opportunities for improved rescue of variant channels through Yoda1 modification.

Similar channel properties in lymph node endothelial cells To investigate if endogenous channels have characteristics comparable to those of overexpressed channels, an endothelial cell line derived from lymph nodes (SVEC4-10 cells) was studied. These cells show transient and sustained $\mathrm{Ca}^{2+}$ elevations in response to Yoda1, the concentration-dependence of which shifts to the left with prolonged exposure (Figure 9a, b). There is partial dependence on extracellular $\mathrm{Ca}^{2+}$ and partial inhibition by thapsigargin (Figure 9c, d). Yoda1 responses are not inhibited by ATP or TRPV4 inhibitors (SI Figure S13) but enhanced by hypo-osmolality (Figure 9e). KC183 causes a slower and more sustained response than Yoda1 (Figure 9f, g). The data suggest that characteristics seen for channels overexpressed in the HEK 293 cell line exist also for endogenous channels of lymph node endothelial cells.

## DISCUSSION

Autosomal recessive pathogenic variants in PIEZO1 have been described in patients with NIFH and/or generalised lymphatic dysplasia (GLD). Interpretation of the variants in this large, highly polymorphic gene has been consistently difficult particularly if there is a missense variant. Accurate genetic diagnosis is important for prognostication and recurrence risks. With many of the variants in this gene (and other genes), a tool to assess pathogenicity is critical for interpretation. Furthermore, little was previously understood about the underlying mechanism resulting in lymphatic failure in this condition.

This study reveals four previously unreported missense variations in the PIEZO1 gene that associate with GLD. Full-length PIEZO1 expression is still possible with these variants, but the single amino acid changes lead to less or abolished PIEZO1 channel activation by mechanical force as the possible disease mechanism.

Similar clinical presentations in the two generations of the GLD08 family is suggestive of autosomal dominant inheritance. However, sequencing identified that both generations are biallelic for I2270T, which is shown here to cause PIEZO1 loss-of-function. This confirms a pseudo-dominant mode of inheritance which is due to a high level of consanguinity, although the genotype of the parents of GLD08 I. 2 could not be confirmed.

In the GLD09 family, the proband presents with a typical GLD phenotype and a biallelic genotype (compound heterozygous for E829V and I2270T). The I2270T variant is maternally inherited and the mother (GLD09 I.2) is unaffected. However, the father (GLD09 I.1) who is monoallelic for the E829V variant has a history of congenital onset primary lymphoedema. If the lymphoedema symptoms in the father are related to PIEZO1 defects, the paternally inherited variant E829V must exert a different disease mechanism, which would most likely be dominant negative. Results of our co-expression studies of E829V with WT PIEZO1 support this idea (Figure 2d). This type of gain-of-function (i.e., dominant negative effect) is antimorphic and thus different to the hypermorphic gain-of-function observed in individuals with autosomal dominant PIEZO1-associated DHS ${ }^{47}$.

Co-inheritance of a loss-of-function variant with a dominant negative gain-of-function variant in trans in the ITGB3 gene has been reported as a cause of Glanzmann thrombasthenia ${ }^{48}$, where family members carrying the dominant negative variant also present with symptoms, although milder than proband. While the symptoms appear milder in the GLD09 father, we do not have enough evidence to make firm conclusions, but this study suggests that primary lymphoedema can be caused by monoallelic PIEZO1 variants, while a more severe GLD phenotype is caused by biallelic inheritance of variants, which can be either two loss-offunction variants or a compound of co-inherited loss-of-function and dominant negative gain-of-function variants. Our study will enable clinicians in reclassifying the PIEZO1 VUS. It has also opened our eyes to the complexity of PIEZO1 variant-associated disease. The possibility of antimorphic acting PIEZO1 missense variants leading to autosomal dominant primary lymphoedema without DHS symptoms is going to make the decision-making more difficult in the clinical genetic setting when there are also hypermorphic acting PIEZO1 missense variants
that can lead to DHS, which recently was also reported to associate with primary lymphoedema ${ }^{49}$.

We show that PIEZO1 channel activity can be rescued by Yoda1 and Yoda1-related smallmolecule agonists, and that these rescued channels show mechanical and hypo-osmolality sensitivities, suggesting their potential for physiological regulation once stimulated by an agonist. Some of these faulty proteins are partly intracellular $\mathrm{Ca}^{2+}$ release channels, suggesting that increased membrane permeability of an agonist can enhance rescue by its ability to also access these channels. Improved rescue by new Yoda1 analogues is shown, suggesting foundations for new pharmacology aimed at overcoming problems of GLD and potentially addressing lymphatic insufficiency in other types of lymphoedema because of the widespread importance of PIEZO1 generally in lymphatic biology.

Yoda1 accelerates lymphatic valve formation in newborn mice ${ }^{26}$ and suppresses postsurgical lymphoedema in mice ${ }^{25}$, encouraging the idea that PIEZO1 agonism could be a therapeutic strategy for problems of lymphatic function beyond rare cases of GLD. Effectiveness of PIEZO1 agonists is likely to depend on factors such as the availability of PIEZO1 channels and lymphatic structures for modulation. Assays that determine or predict these factors will inform the tailoring of therapies to patients who are most likely to benefit. We anticipate that therapies of this type are likely to be safe to administer at an appropriate dose because PIEZO1 gain-of-function variants are common in some human populations and without major adverse effect ${ }^{50-52}$. Safety of administering agonists will, however, depend on the specific chemistry and any off-target (i.e., non-PIEZO1) effects. Understanding of PIEZO1 agonist structure-activity relationships is emerging but the field is still in its infancy. As shown elsewhere ${ }^{30,40,53,54}$ and here, better agonism and improved physicochemical properties of agonists are possible based on the Yoda1 template.

Understanding of the molecular mechanisms of PIEZO1 channels is also in its infancy ${ }^{16}$. The variants we identified are in regions of the channel that are particularly poorly understood. The CED-located variants have the most damaging effects on mechanical activation, yet mechanical sensitivity is thought to arise in the blades. The CED is attached to and sits above the ion pore but also projects feet-like structures to the blades ${ }^{11}$. We speculate that the CED variants somehow stiffen the CED and its associated blade regions, thereby right-shifting mechanical sensitivity out of the physiological range. Yoda1 left-shifts mechanical-response curves ${ }^{44}$, so Yoda1 and Yoda1-related agonists may act by bringing the channels back into range for physiological regulation. The variants in the blades may similarly cause stiffening of the channels. However, we need new structural data to test such hypotheses and specific structural information for GLD variants and their modulation. If atomic resolution can be achieved in relevant parts of the channel, it may inform the design of new modulators.

Various mechanical and Yoda1 sensitivities are reported for PIEZO1 channels, with the vast majority of data being for mouse PIEZO1 ${ }^{13,14,30,33,40,44}$. In part, such variability may arise due to the recording technique and experimental conditions, which may affect, for example, the number of PIEZO1 channels per unit area of membrane and the membrane properties, which are likely to affect mechanical sensitivity because of PIEZO1's lipid modulation ${ }^{33,55-57}$. The patch-clamp technique has several configurations ${ }^{58}$ and presents multiple opportunities for
force application ${ }^{16}$, all of which may affect the estimates of mechanical sensitivity and in turn the sensitivity to Yoda1 ${ }^{44}$. Comparisons in a single study showed that pressure sensitivity and inactivation in outside-out patch recordings are much less than those recorded in other patchclamp configurations ${ }^{14}$. We used the outside-out patch for our experiments and similarly observed absence of inactivation and apparently low pressure sensitivity. We chose this configuration because the channels are studied in relative isolation, in the absence of the main body of the cell and with reduced cytoskeletal interference. In this way, a potentially simpler perspective on the mechanical sensitivity should be achieved. The absolute values obtained may, however, be different from those in more physiological conditions. Our hypo-osmolality studies provide independent perspective on this situation because they were performed on intact cells without the invasive impact of the patch pipette. The mechanism of action of hypoosmolality on the PIEZO1 channels is unclear, but cell-swelling may be caused by hypoosmolality as water moves into the cells, increasing membrane tension. Even in the relatively non-invasive situation of the calcium assays, variabilities in the membrane properties and mechanical condition of the cells may impact the absolute values obtained. We observed Yoda1 sensitivity to vary even between similar $\mathrm{Ca}^{2+}$ assays and using the same cell line; this is evident when the exact Yoda1 $\mathrm{EC}_{50}$ values are compared across our studies here and published elsewhere ${ }^{30,40}$. Therefore, we emphasize the importance of internal controls within the same study, as we did here.

In summary, we have shown clear pathogenicity in these four missense variants initially classed as VUS, demonstrating the clinical utility of our methods. We suggest these variants express and surface localise as full-length protein but with reduced mechanically activated channel function which is the primary cause of the GLD and NIFH observed in the families under study. We also show for the first time a dominant negative disease-causing variant. Thus, caution must be exercised in interpretation of variants in this gene when disease presentation in a family does not conform to the expected inheritance pattern. We also show that small-molecule agonists can functionally rescue these dysfunctional channels, revealing channels that are physiologically regulated. Intracellular $\mathrm{Ca}^{2+}$ release by some of the variants suggests value in membrane-permeable agonists that access this internal pool of channels as well as those at the surface membrane. It is possible to improve on the Yoda1 agonist through chemical modification. Therefore, the cases presented here are examples of GLD in which the underlying molecular defect could be overcome by small-molecule modulators, and thus potentially therapeutic drugs based on such modulators. However, GLD is a rare disease and not all cases are caused by such PIEZO1 variants, but the principles of functional PIEZO1 rescue presented here could potentially have a broader relevance as a way to overcome suboptimal functionality in the lymphatic system not just in PIEZO1 variant-associated GLD, but other types of lymphoedema.

## METHODS

Patient ascertainment Three individuals with a GLD phenotype not previously reported and available family members were included in the study. Genomic DNA was analysed for sequence variants in all exons of PIEZO1 by Sanger sequencing as described previously ${ }^{7}$. Samples of available family members were subsequently analysed by Sanger sequencing for
the variants identified in their respective proband. Findings were subsequently confirmed in a molecular diagnostics laboratory.

PIEZO1 variants in silico analysis All the relative genomic and protein positions of PIEZO1 reported here correspond to the transcript PIEZO1-001 (RefSeq: NM_001142864, Ensembl: ENST00000301015.9) and Q92508 Uniprot protein accession ID, respectively. The reported genomic coordinates refer to the GRCh38/hg38 human genome reference. Changes in the gene structure and/or amino acid sequence, due to the reported variants, were retrieved by the Refgene database of UCSC ${ }^{59}$. The Allele Frequencies (AF) of the reported variants were checked in gnomAD databases ${ }^{60}$ and their pathogenicity was predicted by the Combined Annotation Dependent Depletion (CADD) tool ${ }^{61}$, Mutation Taster ${ }^{62}$, SIFT ${ }^{63}$ and PolyPhen2 64.

PIEZO1 constructs Human PIEZO1_AcGFP ${ }^{38}$ was used as a template to clone the human PIEZO1 (hPIEZO1) sequence with a C-terminal HA-epitope. Overlapping hPIEZO1 (forward primer 5' GGTCTACCTGCTCTTCCTGCTG 3' and reverse primer incorporating a 'ASA' linker and the HA sequence a CCCATACGATGTTCCAGATTACGCTTAGGCGACTCTAGATCATAATCAGCCATACC 3') and vector (forward primer 5' CCCATACGATGTTCCAGATTACGCTTAGGCGACTCTAGATCATAATCAGCCATACC 3' and reverse primer 5' CAGCAGGAAGAGCAGGTAGACC 3') PCR products were assembled using Gibson Assembly. Missense variants were introduced by site-directed mutagenesis (PCR primer sequences are provided in SI Table S2). pcDNA3_mouse PIEZO1_IRES_GFP, a gift from A Patapoutian, was used as a template to clone the mouse PIEZO1 (mPIEZO1) coding sequence with a C-terminal HA-epitope, into $\mathrm{pcDNA}^{\text {TM }} 4 / \mathrm{TO}$. Overlapping mPIEZO1 (forward primer 5' GTAACAACTCCGCCCCATTG 3' and reverse primers 5' CTAAGCGTAATCTGGAACATCGTATGGGTACTCCCTCTCACGT 3') and pcDNA™ $4 /$ TO (forward primer 5' CATACGATGTTCCAGATTACGCTTAGCCGCTGATCAGCCTCG 3' and reverse primer 5' CAATGGGGCGGAGTTGTTAC 3') PCR products (PrimeSTAR HS DNA Polymerase, TaKaRa) were assembled using Gibson Assembly (NEB). Missense variants were introduced into mPIEZO1 with and without HA-epitope by site-directed mutagenesis (PCR primer sequences are in SI Table S2).

Cell culture HEK 293 cell line was transiently transfected at $90 \%$ confluence with 500 ng DNA using Lipofectamine 2000 (Invitrogen) in OptiMEM (Gibco) according to the manufacturer's instructions. For co-expression experiments, cells were transfected with only 75 ng of each construct for submaximal expression of each subunit. Medium was replaced after 5 hours and cells were used for experimentation 48 hours after transfection. T-REx-293 cell line was transfected with pcDNA4/TO-mPIEZO1 constructs using Lipofectamine 2000 (Invitrogen) and treated with $200 \mu \mathrm{~g} \cdot \mathrm{~mL}^{-1}$ zeocin (InvivoGen) to select for stably transfected cells. At least two strongly expressing clonal cell lines were established and tested for each variant. All cell lines were maintained in Dulbecco's Modified Eagle's medium (Invitrogen) supplemented with 10\% foetal calf serum (Sigma-Aldrich), penicillin ( 50 units. $\mathrm{mL}^{-1}$ ) and streptomycin ( $0.5 \mathrm{mg} \cdot \mathrm{mL}^{-1}$ ) (Sigma-Aldrich) and grown at $37^{\circ} \mathrm{C}$ in a $5 \% \mathrm{CO}_{2}$ incubator.

Western blotting and cell surface biotinylation For western blotting, cells were harvested in lysis buffer ( 10 mM Tris, $\mathrm{pH} 7.4,150 \mathrm{mM} \mathrm{NaCl}, 0.5 \mathrm{mM}$ EDTA, $0.5 \%$ Nonidet P40 substitute) containing protease inhibitor cocktail (Sigma). Equal protein amounts were loaded on 7\% polyacrylamide gels and resolved by electrophoresis. Samples were transferred to PVDF membranes and labelled overnight with anti-HA ( $0.01 \mu \mathrm{~g} . \mathrm{mL}^{-1}$, Roche clone 3 F 10 ), anti- $\beta-$ actin (200 ng. $\mathrm{mL}^{-1}$, Santa Cruz) or anti-CD71 (1:5000, Cell Signaling Technology clone D7S5Z). Horseradish peroxidase donkey anti-mouse/rabbit/rat secondary antibodies (1:10000, Jackson ImmunoResearch) and SuperSignal Femto detection reagents (Pierce) were used for visualisation. For cell surface biotinylation, cells were grown in 6-well plates to confluency, washed twice with ice-cold PBS containing 1 mM CaCl 2 and 1 mM MgCl 2 and biotinylated on ice for 30 minutes using $0.22 \mathrm{mg}_{\mathrm{mL}}{ }^{-1}$ EZ-Link Sulfo-NHS-Biotin (Pierce) in $\mathrm{PBS} / 1 \mathrm{mM} \mathrm{CaCl} / 2 \mathrm{mM} \mathrm{MgCl} 2$. Subsequently, cells were washed three times with ice-cold $\mathrm{PBS} / 1 \mathrm{mM} \mathrm{CaCl} / 2 \mathrm{mM} \mathrm{MgCl} 2$ containing 50 mM glycine to quench excess biotin, and finally once with ice-cold $\mathrm{PBS} / 1 \mathrm{mM} \mathrm{CaCl} / 1 \mathrm{mM} \mathrm{MgCl} 2$. Cells were harvested in lysis buffer ( 10 mM Tris, pH $7.4,150 \mathrm{mM} \mathrm{NaCl}, 0.5 \mathrm{mM}$ EDTA, $0.5 \%$ Nonidet P40 substitute) containing protease inhibitor cocktail (Sigma). Biotinylated proteins were concentrated from $300 \mu \mathrm{~g}$ total protein using streptavidin-agarose (Pierce) overnight at $4{ }^{\circ} \mathrm{C}$. Agarose beads were washed three times with ice-cold lysis buffer and bound proteins eluted using sample buffer ( 4 x SB: 250 mM Tris pH 6.8, $8 \%$ SDS, $40 \%$ glycerol, $8 \% \beta$ mercaptoethanol) and heating at $70^{\circ} \mathrm{C}$ (higher temperatures resulted in PIEZO1 protein aggregation).

Intracellular $\mathrm{Ca}^{2+}$ measurement For intracellular $\mathrm{Ca}^{2+}$ assays, cells were plated at $80-90 \%$ confluence in 96 -well plates 24 hours prior to recordings ( $6-8 \times 10^{4}$ cells per well). To measure intracellular $\mathrm{Ca}^{2+}$, cells were incubated for 1 hour at $37{ }^{\circ} \mathrm{C}$ in standard bath solution (SBS) of composition $135 \mathrm{mM} \mathrm{NaCl}, 5 \mathrm{mM} \mathrm{KCl}, 1.2 \mathrm{mM} \mathrm{MgCl} 2,1.5 \mathrm{mM} \mathrm{CaCl}, ~ 8 \mathrm{mM}$ glucose and 10 mM HEPES ( pH titrated to 7.4 using NaOH ) containing $2 \mu \mathrm{M}$ fura-2 acetoxymethyl ester (fura-2-AM, Molecular Probes) with $0.01 \%$ weight/volume pluronic acid. Cells were washed with SBS and incubated at room temperature for 20 minutes prior to recordings. Equal volumes of $2 x$ concentrated compounds were injected to test for acute channel activation. Pre-incubation with compounds occurred during the 20 minutes prior to recordings. To expose cell membranes to increased hypo-osmolality, an equal volume of hypotonic SBS (containing only $5-110 \mathrm{mM} \mathrm{NaCl}$ ) was injected onto the cells. Measurements were made on a fluorescence plate reader (Flexstation III, Molecular Devices) at room temperature ( $21 \pm 2^{\circ} \mathrm{C}$ ). Fura-2 was excited at 340 nm and 380 nm and emitted light collected at 510 nm , with measurements shown as the change in fluorescence $(\mathrm{F})$ ratio $\left(\Delta \mathrm{F}_{340 / 380}\right)$.

Electrophysiology and mechanical stimulation lonic currents were recorded through outside-out patches from cells using standard patch-clamp techniques in voltage-clamp mode. Patch pipettes were fire-polished and had resistance of $4-7 \mathrm{M} \Omega$ when filled with pipette solution. Ionic solution of composition (mM) NaCl 140, HEPES 10 and EGTA 5 (titrated to pH 7.4 using NaOH ) was used in both the pipette and bath. Recordings were at a constant holding potential of -80 mV . 200-ms pressure steps were applied to the patch pipette with an interval of 12 s using High Speed Pressure Clamp HSPC-1 System (ALA Scientific Instruments, USA). All recordings were made with an Axopatch-200B amplifier (Axon Instruments, Inc., USA) equipped with Digidata 1550B and pClamp 10.6 software (Molecular Devices, USA) at room temperature ( $21 \pm 2{ }^{\circ} \mathrm{C}$ ). Currents were filtered at $2-5 \mathrm{kHz}$ and digitally sampled at $5-20 \mathrm{kHz}$.

Molecular modelling Structural data for mPIEZO1 were obtained at Protein Data Bank (PDB:6B3R). Missing loop regions were modelled using MODELER (v9.19). Large intracellular loops (located at residues 718-781, 1366-1492, 1579-1654 and 1808-1951) remained unstructured following modelling and were removed from the final model. A structural model of hPIEZO1 was generated based on the mPIEZO1 model.

Chemistry KC41 (Dooku1) was prepared as described ${ }^{30}$. All purchased chemicals and solvents were used without further purification unless otherwise stated. All compounds were at least $95 \%$ pure by 1H NMR. 1H Nuclear Magnetic Resonance spectra were recorded at 500 MHz using a Bruker DRX 500 instrument or at 400 MHz using a Bruker DPX 400. 1H spectra are referenced based on the residual proton in the solvent (e.g., the $\mathrm{CHCl}_{3}, 0.01 \%$ in $99.99 \% \mathrm{CDCl}_{3}$ ). Coupling constants (J) are reported to the nearest 0.1 Hz . 13C NMR spectra were recorded at 125 MHz on 500 MHz spectrometers or at 100 MHz on 400 MHz spectrometers. LC-MS was performed on a Bruker Daltronics running a gradient of increasing acetonitrile ( 5 to $95 \%$ ) in $\mathrm{H}_{2} \mathrm{O}$ both containing $0.1 \%$ formic acid at $1 \mathrm{ml} . \mathrm{min}^{-1}$, on a short path C18 reverse phase column, detecting compounds with both a diode array detector and a Bruker mass spectrum analyser. HRMS was performed on a Bruker Daltonics micrOTOF using positive electrospray ionisation (ES+). Automated column chromatograph was carried out using a Biotage Isolera Four, using either Sfär Silica D or KP-Silica cartridges. HPLC was performed on an Agilent 1290 Infinity Series equipped with a UV detector and Hyperprep C18 reverse phase column. Key to NMR abbreviations: s (singlet), br s (broad singlet) d (doublet), dd (doublet of doublets), ddd (doublet of doublets of doublets), t (triplet), dt (doublet of triples), q (quartet), m (multiplet), ap. t (apparent triplet). Chemistry details for each novel analogue are provided in the SI Chemistry section.

Statistical data analysis Averaged data are shown as mean $\pm$ standard error of the mean (s.e.m.) or standard deviation (s.d.), as specified in the figure legends. Data were produced in pairs and analysed statistically with Student's t-test or in groups and analysed by one-way ANOVA using Origin ${ }^{\mathrm{R}} 2018$ software (OriginLab). Statistically significant difference is indicated by ${ }^{*} P<0.05,{ }^{* *} P<0.01$ or ${ }^{* * *} P<0.001$. n.s., indicates not significantly different. "n" is used to denote the number of independent data points. Representative traces contain " N " technical replicates from within a single experiment. For patch-clamp studies, data were analysed using pClamp 10.6, MicroCal Origin 2018 (OriginLab Corporation, USA) and GraphPad Prism (GraphPad Software, Inc., USA) software packages.

(a) Upper: Schematic of the pressure pulse protocol in which a $200-\mathrm{ms}$ pressure pulse was applied to 15 mmHg and then, every 12 s , incremented $(\Delta)$ in steps of 15 mmHg up to a maximum of 105 mmHg . Lower: Example ionic currents from a patch excised from an empty vector-transfected cell. No currents were evoked by the pressure pulses (current traces superimpose).

## SI FURTHER CLINICAL INFORMATION ON THE GLD PATIENTS

GLD07 Proband (GLD07 II.1) is a male in his teens born to non-consanguineous parents. First trimester nuchal translucency was normal. Antenatal imaging (gestational date not noted) identified NIFH and polyhydramnios. The baby was hydropic at birth, which resolved spontaneously. However, over a period of 6-12 months, he developed symmetrical lower limb lymphoedema with intermittent upper limb, facial (eyelid) and genital (scrotal) lymphoedema. At the age of 1-2 years his peripheral oedema had stabilised mainly affecting the feet, with persistent pleural effusions and minimal perihepatic ascites, diagnosed on MR imaging. Apart from a maldescended left testis, he has no other structural malformations. He has micrognathia and slight facial swelling but is otherwise non-dysmorphic. There are no concerns about his neurodevelopment. At the age of $3-4$ years he developed cellulitis (followed by rheumatic fever) which was probably lymphoedema-related and he has been on penicillin prophylaxis since.

GLD08 The proband (GLD08 II.1) is a male in his 30s, born to consanguineous parents. His antenatal and neonatal period was uneventful. He was born at term with a normal birth weight. From age 10-14 years he developed progressive breathlessness and reduced exercise tolerance and was found to have bilateral chylous pleural effusions (triglycerides $19.42 \mathrm{mmol} / \mathrm{L}$ with moderate lymphocytosis). Treatment has proved very difficult and has involved pleurodesis, ligation of the thoracic duct and pleuro-peritoneal shunting. He was also found to have a hydrocele (likely due to a patent ductus vaginalis) and ascites. At 15-19 years old he developed a pericardial effusion that rapidly progressed to cardiac tamponade. Pericardiocentesis confirmed chylous pericardial fluid, and this was repeated less than 3 weeks later due to recurrence of the pericardial effusion and tamponade (SI Figure S2). He was subsequently treated with octreotide and medium chain triglyceride diet for two years. He has residual, significant and symptomatic restrictive lung disease requiring nocturnal noninvasive ventilation. He developed bilateral lower limb lymphoedema with scrotal oedema in his 30s. Additional clinical features include mild microcephaly, short stature, and generalised osteopenia. He has a normal male karyotype and a 12-gene Ras-MAPK pathway disorders panel identified no causal variants. Lymphoscintigraphy has not been performed.

GLD08 I. 2 is the proband's father. His parents are not known to be consanguineous. He was diagnosed with spontaneous bilateral chylous effusions in his 30s. Despite pleurodesis, his effusions are persistent resulting in a restrictive lung defect and nocturnal hypoventilation requiring non-invasive ventilation (NIV). He also has a mild-moderate pericardial effusion, which has been stable and has not required pericardiocentesis. He has bilateral lower limb pitting oedema to the knees (onset at the age of 45-49 years) and varicose veins with varicose eczema at the ankles. He has no further complications and is developmentally normal. Venous duplex and lymphoscintigraphy not performed.

Recently, proband's brother, GLD08 II.2, was found to have bilateral pleural effusions at the age of 10-14 years. A left drain was placed and chyle confirmed (triglycerides $21 \mathrm{mmol} / \mathrm{L}$ in pleural fluid). He also presented with mild peripheral oedema of the lower limbs, and tense bilateral hydrocoeles.

Proband's maternal aunt (GLD08 I.1) had progressive pleural and pericardial effusions (with pleural and pericardial thickening) that first started aged 15-19 years. She died from chylothoraces and pleural disease in her 30s and was not formally assessed in clinic.

GLD09 GLD09 II. 1 is the first child of non-consanguineous Caucasian parents, conceived by in vitro fertilisation. The first trimester nuchal translucency measurement was normal. At 19weeks' gestation the baby was noted to have bilateral hydrothoraces. Amniocentesis at this time revealed a $46, \mathrm{XY}$ karyotype. The pregnancy was complicated by polyhydramnios requiring amnio-drainage thrice during early third trimester at 3-weekly intervals. A male infant was born at 34 -weeks' gestation with significant facial swelling and bilateral chylothoraces requiring bilateral chest drains. He was intubated and ventilated for one month and remained in neonatal intensive care for a total of three months. During this period, he had laryngomalacia and severe gastro-oesophageal reflux that required a fundoplication at 6-12 months of age. A gastrostomy was inserted owing to an oral aversion, with a low fat MCT diet instituted in the setting of the bilateral chylothoraces. A lymphoscintigram at 6-12 months demonstrated extensive subdermal flow of lymphatics in the lower limbs, chest wall and scrotum. Upon review at 1-2 years of age, he had oedema of the lower limbs to the thighs, and genitalia, as well as intermittent facial swelling (SI Figure S2). He had metopic synostosis and a facial haemangioma over the glabella. He had a circumcision at 1-2 years of age for significant scrotal/genital oedema. By 5-9 years of age he had contracted pneumonia on three occasions and was hospitalised with invasive group A Streptococcal septicaemia. He also began to exhibit bilateral periorbital and conjunctival vascular changes with small punctate haemorrhages. He had obstructive sleep apnoea from age 5-9 years treated with nocturnal CPAP. Orthodontic treatment with an upper jaw expander has resulted in clinical improvement of sleep apnoea symptoms. Early concerns regarding speech and language delay were resolved by the commencement of primary school. He was diagnosed with Asperger syndrome at 3-4 years of age. There is a bilineal family history of autism spectrum disorder.

GLD09 I. 1 is the proband's father. He has four limb lymphoedema, with swelling of the lower limbs at birth, followed by swelling of the hands from his 20 s. The cause of this is unknown. He has had no episodes of cellulitis and no history of pleural effusions. He also has a diagnosis of Asperger syndrome. He only has one variant in PIEZO1 [c.2486A>T; p.(E829V)].

## General Procedure A

The desired aromatic halide (1.0 eq.) the desired boronic acid/ester (1-3.5 eq.) and $\mathrm{K}_{2} \mathrm{CO}_{3}$ (4.0 eq.) were dissolved in anhydrous 1,4-dioxane ( 2 mL ) and $\mathrm{H}_{2} \mathrm{O}(2 \mathrm{~mL})$ then degassed with $\mathrm{N}_{2}$ for 30 minutes. $\mathrm{Pd}\left(\mathrm{PPh}_{3}\right)_{4}(0.15$ eq.) was then added and the reaction was then heated to $90^{\circ} \mathrm{C}$ for 2-24 h .
