INTRODUCTION

Allogeneic haematopoietic stem cell transplantation (HSCT) is a life-saving treatment for haematological and solid-organ malignancies and most commonly uses stem cells (CD34⁺ cells) from peripheral blood obtained through a two-stage process: i. Mobilisation of CD34⁺

Despite standardised mobilisation and PBSC protocols, there is marked inter-individual variation in the number of CD34+ cells mobilised and collected (1, 2). Although most allogeneic donors achieve target CD34⁺ cell yield (typically 4-5 x10⁶/kg CD34⁺ cells/recipient weight), only 60% do this with one PBSC. The remaining 40% of donors usually achieve target yield after repeat PBSC, although 2-5% are poor mobilisers and never achieve target. For recipients, suboptimal CD34⁺ cell yields from donors result in prolonged engraftment times and increased risk of adverse events such as graft failure, infection, or bleeding (3, 4).

Numerous donor characteristic and collection factors have been postulated to impact on successful CD34+ cell donation, these can be broadly divided into *donor*, *mobilisation*, *collection* and *laboratory* factors. However, the existing literature contains abundant inconclusive and sometimes contradictory findings, often resulting from limitations such as small sample sizes, retrospective cohort designs and heterogenous outcome definitions. The objective of this scoping review is to answer the research question *What are the donor*, *mobilisation*, *collection and laboratory factors that are associated with blood CD34⁺ cell concentration and/or CD34⁺ cell yield in allogenic donors after standard G-CSF mobilisation?* Standard G-CSF mobilisation is defined here as treatment of donors with short-acting recombinant human G-CSF for four or five-days duration. Although the CD34+ cell concentration and yield outcomes are anticipated to be closely correlated, they have been separated in this review as blood CD34⁺ cell concentration is potentially influenced only by donor and mobilisation factors whereas CD34+ cell yield may also be influenced by collection factors.

previously investigated candidate predictors and because of the retrospective design and heterogeneity of most previous studies. A scoping review was anticipated to enable better mapping of key concepts and identification of knowledge gaps without the constraints imposed by the requirement of homogenous eligibility criteria needed for systematic review. The Preferred Reporting Items for Systematic reviews and Meta-Analyses extension for Scoping review (PRISMA-ScR) checklist was used to ensure best practice (5). The review protocol is available on request to the corresponding author.

Search Strategy

Electronic databases (MEDLINE, Embase, PubMed and Stem Cell Evidence) were searched for studies published between January 1 2000 and November 1 2023 by a review author (CD) who is part of the Systematic Review Initiative team. The search strategy is documented in Supplementary Data.

Eligibility criteria

Studies were eligible for analysis if they reported data from allogeneic stem cell donors who underwent G-CSF mobilisation and PBSC and if they reported at least one of *blood CD34+ cell concentration* after 4 or 5 days of G-CSF or *CD34⁺ cell yield* at the first PBSC. Studies were included if they evaluated associations between these outcomes and candidate variables in the following groups: i. *donor factors* (eg age, sex, weight, ethnicity); ii. *mobilisation factors* (eg G-CSF scheduling or dose); iii. PBSC *collection factors* (eg venous access, processed blood volume), or, iv. Donor *laboratory characteristics* at baseline or after mobilisation. Studies were excluded if they reported data from donors aged <16 years, or if they were case reports, reviews with no new data, non-English language publications, animal studies or pre-2000 studies.

Study selection

After duplicate removal, two authors (RP and AKW) used the Rayyan© platform to screen
titles and abstracts before resolving conflicts through discussion. Full article texts were then
obtained for eligibility review by RP. The references of included studies and review articles
were searched to ensure capture of all relevant studies.

Data charting and analysis

Data was extracted into a standardised form which was piloted by and subsequently refined by RP and KB. The following data was extracted by RP: Authors, publication year, sample size, funding, country of study, donor demographic data, G-CSF protocol, make of apheresis machine, processed blood volume, anticoagulant, venous access, duration of collection, flow rate, and outcomes assessed.

RESULTS

Literature search

After duplicates were removed, 3355 articles were screened by the title and abstract. The remaining 118 articles were then screened by inspection of full text to yield 51 eligible studies for analysis (Figure 1). Studies were divided according to whether the reported outcome was only blood CD34⁺ cell concentration after G-CSF mobilisation (n = 14 Table 1), only CD34⁺ cell yield from first PBSC (n =18; Table 2) or if they reported both outcomes (n=19 listed in both Tables 1 and 2). Excluded studies are listed with explanatory notes in Supplementary Data.

Study characteristics

Forty-one (80%) of the 51 eligible studies were retrospective cohort design. Seven (14%) of the remaining studies used prospective data collection but only three (6%) were prospective randomised trials that evaluated the effects of alternative G-CSF dose and/or scheduling. The eligible studies included at total of 44,759 doors but individual studies ranged in size

donors. The median donor ages ranged from 29 to 59 years. 72% of all donors were male.

1. Donor factors that influence blood CD34+ concentration or yield

Age

Donor age was the most frequently assessed factor in the eligible studies. Of the 25 studies that reported the relationship between age and CD34⁺ cell yield 16 (64%) reported an association between age > 40 years and lower CD34⁺ cell yield (6-21). Four further studies identified a non-significant trend towards this association (22-25) whereas five studies reported no association (26-30). Of the 25 studies that assessed the relationship between age and blood CD34⁺ cell concentration, 13 (52%) reported an association between older age and lower blood CD34⁺ cell concentration (8-10, 13, 16, 17, 21, 31-36). Eight further studies reported a similar trend but without statistical significance (6, 22, 23, 37-41) whereas in three studies, there was no association (26, 27, 42). The final study reported that older age was associated with higher blood CD34⁺ cell concentration (30). Analysis of the significance of donor age was hampered by the variation between the studies in whether age was considered as a continuous or categorical factor and in the categorical definitions of 'older age' (range >30 to >60 years). The median and range of included donors varied considerably between studies (Table 1 and 2).

Gender

Of the 17 studies that assessed the association between CD34⁺ cell yield and donor gender 12 (71%) reported higher CD34⁺ cell yields in males (9, 10, 12, 14, 17-19, 25, 28, 30, 43, 44) but the remaining five studies (29%) found no association (6, 15, 16, 24, 29). Of the 20 studies that assessed blood CD34⁺ cell concentration, eight (42%) reported higher concentrations in males (9, 30, 32, 34, 36, 37, 39, 45) whereas 12 (59%) reported no significant effect of gender (6, 17, 21, 22, 31, 33, 35, 38, 40-42, 46).

Ethnicity

Only four studies assessed associations between donor ethnicity and CD34+ cell yield from PBSC or blood CD34+ cell concentration. Three of these reported that compared to European ancestry donors, African ancestry (AA) donors had higher CD34+ cell yields (12, 44) and blood CD34+ cell concentrations (35, 36, 44). In one of these studies that included >10,000 donors, the effect of AA was most pronounced in male donors with higher body mass index (BMI) (44). The remaining study reported a trend of a higher blood CD34+ cell concentrations in AA donors but contained only 16 subjects with this ancestry (35).

Anthropometric characteristics

Of the nine studies that assessed the association between BMI and CD34+ cell yield, four reported that high BMI was associated with higher yield (6, 12, 19, 46). Seven of nine studies reported an association between high BMI and higher blood CD34+ concentration (6, 26, 30, 32, 37, 42, 46). None of the seven studies that assessed donor height reported an association with either CD34+ cell yield (20, 25, 29), or blood CD34+ cell concentration (36, 38, 40, 41). All four of the studies that assessed the differences in weight between donor and recipients reported an association between donors having greater positive weight differences and higher CD34⁺ cell yield (6, 8, 14, 28). Higher donor blood volume estimated using the Nader method was associated with higher blood CD34+ cell concentration in one study (41), but not in another (40).

Other donor factors

One of two studies that assessed the effect of donor smoking reported an association with lower CD34+ cell yield (20), whereas the other found no effect (43). Two studies found no association between smoking and CD34+ cell concentration (30, 39) but in one retrospective study, there was an association between smoking and lower concentration (32). Single studies reported no associations between donor comorbidity expressed as the Charlson Comorbidity Index and CD34⁺ cell concentration (35) and between previous blood donation

Or physical activity and CD34⁺ cell yield (43). One study reported no association between

self-reported health-related quality of life and CD34⁺ cell yield (47).

2. Mobilisation factors that influence blood CD34+ concentration or yield

G-CSF dose

Seven studies assessed the impact of G-CSF dose on CD34⁺ cell yield. In an open label randomised split dose escalating study in 36 donors, CD34+ cell yield was the same between three G-CSF dose groups (8, 11 or 15 μ g/kg/day split into two doses) , although the $15\mu g$ group had PBSC on day 4 of G-CSF treatment whilst the $8\mu g$ and $11\mu g$ groups had PBSC on day 5 (11). In a second trial, 150 donors were randomised to receive either 10µg/kg/day G-CSF once daily or 8µg/kg/day split into two doses. The donors receiving $10\mu g/kg/day$ once daily were more likely to achieve a target CD34+ cell yield of >5x10⁶/kg recipient weight. The frequency of adverse events was similar between groups (29). Of the five remaining studies that were retrospective, one reported that treatment with 8µg/kg twice per day G-CSF resulted in higher CD34+ cell yields compared to 5µg/kg twice per day but was associated with more frequent bone pain, headache and fatique (48). In a second study, all donors received G-CSF doses of 10µg/kg/day administered either as a single dose or split between two doses. Amongst the donors who achieved a satisfactory CD34+ cell yield (>5x10⁶ cells/Kg), a higher total G-CSF dose was reported in donors receiving twice daily G-CSF but not once daily G-CSF (6). In the three remaining retrospective studies, all the donors were prescribed the same 10µg/kg/day yet received different actual doses because of nearest whole vial dosing. None of these studies showed a relationship between actual G-CSF dose received and CD34+ cell yield (16, 19, 44).

Eight studies assessed the impact of G-CSF dose on blood CD34⁺ concentration, all of which were retrospective. In one study, 16µg/kg/day G-CSF resulted in higher blood CD34⁺ cell concentrations than 10µg/kg/day (36). In two studies, higher blood CD34⁺

No reuse allowed without permission. concentrations were associated with higher total G-CSF doses received by donors prescribed 10µg/kg/day G-CSF rounded to the nearest whole vial size (6, 38).The remaining five studies found no association between blood CD34+ cell concentration and higher G-CSF doses (16, 31, 34, 37, 39). One of these studies found an increased frequency of bone pain, headaches, and chills with G-CSF doses >10µg/kg/day (37).

G-CSF scheduling

The effect once daily (OD) vs twice daily (BD) G-CSF dosing on CD34⁺ cell yield was assessed in five studies. In one prospective study in 72 donors, G-CSF 400 μ g/m² OD and 200 μ g/m² BD resulted in similar CD34+ cell yields (24). Comparison of CD34+ cell yields in 75 donors receiving G-CSF 10 μ g/kg OD to a historical control group who received G-CSF 5 μ g/kg BD also found no difference between the groups (49). By contrast, in 50 donors receiving either 10 μ g/kg OD or 5 μ g/kg BD, there was a higher CD34+ cell yield in the BD group (50). The remaining two retrospective studies found no differences in CD34+ cell yields in donors who received OD or BD G-CSF scheduling (51, 52). There were no reported associations between G-CSF scheduling and blood CD34⁺ cell concentration in two retrospective studies (16, 52) and one prospective study (49).

The impact of PBSC on day four compared to day five of G-CSF treatment on CD34+ cell yield was assessed in three retrospective studies. In one study, day 4 PBSC, resulted in insufficient CD34+ cell yield in most donors whereas this was not the case for day 5 PBSC (6). In contrast, a second study reported no difference between day 4 and day 5 PBSC (7). In the final retrospective study of 840 donors, the CD34+ cell yield was lower in donors undergoing day 4 PBSC compared to day 5 PBSC, although both groups were equally likely to reach a target CD34+ cell yield of >4x10⁶/kg recipient weight (27). This same study also reported that CD34⁺ cell concentration was higher at the day 5 PBSC compared to day 4

No reuse allowed without permission. (27). In one retrospective study, lymphapheresis prior to G-CSF mobilisation increased

CD34⁺ cell concentration after five days of G-CSF mobilisation (36).

3. Collection factors that influence blood CD34+ concentration and yield

Amongst the eligible studies that reported collection factors, there was wide variation in collection process. The most frequently used apheresis machine was the COBE spectra. Although the total reported processed blood volume (PBV) was typically 2.5 to 3 total blood volume some studies reported up to 5 blood volumes in a single PBSC (30). ACD-A was the anticoagulant used in all studies which reported this data.

The use of a central line for PBSC venous access was reported to increase CD34+ cell yield in one retrospective study (19) but was found to have no effect in a second study except in a sub-group of female donors where a central line increased yield compared to peripheral venous access (44). The PBV was assessed in six studies, of which two were prospective (24, 29). In one of these, a PBV of >200mls/kg was associated with higher CD34+ cell yield compared with lower PBVs. In contrast, the second prospective study of donors who had a PBV in the range 150-200mls/kg, reported there was no relationship between the exact PBV and CD34+ cell yield. Three of the remaining four retrospective studies, reported that a higher PBV was associated with higher CD34⁺ cell yield (20, 28, 46). In contrast, the remaining retrospective study of 20,884 donors found that higher PBV was associated with a lower CD34⁺ yield (12). This was attributed to declining collection efficacy with larger collection volumes. In one retrospective study, faster flow rate during PBSC was associated with a lower CD34⁺ cell yield (19).

4. Laboratory factors

Amongst the eligible studies, the most commonly reported laboratory factors were full blood count (FBC) parameters and blood CD34+ cell concentration in blood samples collected before the start of G-CSF mobilisation (baseline) or after mobilisation but before PBSC (pre-

 PBSC). In all 16 studies that assessed the pre-PBSC blood CD34+ concentration, there was a consistent association with the subsequent CD34⁺ cell yield from the first PBSC collection (7-9, 11, 14, 15, 18-21, 24-26, 45, 46).

Pre-PBSC full blood count parameters

The association between pre-PBSC white cell count (WCC) and CD34⁺ cell yield was inconsistent amongst the eight studies that evaluated this parameter (7-10,12,14,16,41) with only three reporting a significant positive association (12,14,41). Five studies found that higher WBC was associated with higher CD34+ cell concentrations in the same pre-PBSC blood sample (8, 31, 34, 53, 54), whereas two reported no association (17, 33). Higher pre-PBSC platelet (PLT) count was associated with higher CD34+ cell yield in four out of ten studies that assessed yield (12, 15, 16, 21). In four studies, higher PLT was associated with higher CD34+ cell concentrations in the same pre-PBSC blood sample (8, 31, 33, 54), whereas there was no association in one further study (17). Higher pre-PBSC haemoglobin concentration (HB) was associated with higher CD34+ cell yield in two of the four studies that evaluated yield (8, 25). Pre-PBSC HB was not associated with CD34+ cell concentration in two studies (17, 33).

Higher pre-PBSC haematocrit (HCT) (17, 21), neutrophil (NEUT) count (12, 17) and nucleated red cells (nRBC) counts (17) were also associated with increased CD34+ cell yield, but not with higher CD34+ cell concentration in the pre-PBSC blood sample (17).

Baseline full blood count parameters

Fewer studies have assessed baseline FBC parameters. Of four studies that assessed CD34+ cell yield, two studies reported an association between higher baseline WCC and higher yield (8, 24), including a randomised control trial in which baseline WCC was the strongest predictor of being a 'poor mobiliser' (defined as CD34+ cell yield < $2x10^6$ /kg donor weight). Two studies found no association (20, 25). Higher baseline WCC was associated

(31) whereas there was no association in the other studies MARTINO 2006, (32, 34, 40, 41).

Higher baseline NEUT count and CD34+ cell count were associated with higher CD34+ cell yield in two studies (12, 18). Higher baseline CD34+ count was associated with higher CD34+ cell concentration in the pre-PBSC blood sample (40, 41). Higher baseline PLT count was associated with higher CD34+ cell yield in one retrospective study (12), but not in another (25). Higher basline PLT count was also associated with higher CD34+ concentration in the pre-PBSC sample in three retrospective and one prospective study (32, 36, 39, 40), but not in other studies (17, 41).

Higher baseline HB (8, 25), and mean red cell volume (MCV) (55) were associated with higher CD34+ cell yield in two retrospective studies. Baseline HB was also associated with CD34+ cell concentration in the pre-PBSC sample in one retrospective study (39) but was there was no association in three other studies (32, 41, 49). Higher baseline MCV was not associated with CD34+ concentration in the pre-PBSC sample in two retrospective studies (21, 39). Amongst a range of other FBC parameters evaluated in a retrospective study of 333 donors, only higher baseline mononuclear count was associated with CD34+ cell concentration in the pre-PBSC sample (36).

Other factors

Possible associations between CD34+ cell concentration in the pre-PBSC sample and baseline tests for clotting, liver, and renal function, and with baseline CRP, cholinesterase (CHE), lactate dehydrogenase (LDH), ferritin and immunoglobulin concentrations were assessed by a single retrospective study. Only higher CHE and higher LDH were significantly associated with higher CD34+ cell concentration in the pre-PBSC sample (39)

Neither other cell surface markers on CD34+ cells nor baseline inflammatory cytokine concentrations were associated with CD34+ cell yield in one study (14) whereas in a different retrospective study higher CD11a expression on CD34+ cells in the collected cells was associated with lower CD34+ concentration in the pre-PBSC sample (45). There was a non-significant trend towards lower CD44 expression on CD34+ cells from donors with a lower CD34+ concentrations (45). In two studies that investigated the relationship between baseline inflammatory cytokine concentrations and CD34+ concentration in the pre-PBSC sample (42, 45), both reported that higher TNFα concentration was associated with higher CD34+ cell concentration. Higher IFNγ and IL-22 were also associated in one study (42) but not in another (45).

The seasonal timing of mobilisation and cell collection was assessed in a single retrospective study but was not associated with CD34+ cell yield (56). The effects of the a common haplotype in *CXCL12* on both CD34+ concentration and yield were assessed in a single retrospective study of 463 healthy donors but no significant associations were identified (30, 57).

DISCUSSION

This scoping review offers a comprehensive overview of the donor, mobilisation, collection and laboratory factors that are associated with favourable donation outcomes from standard G-CSF mobilisation and PBSC in allogeneic stem cell donors. The review identifies factors associated with CD34+ cell concentration in donor blood immediately before PRBC and also the yield of CD34+ cells from the subsequent collection procedure. These alternative endpoints are closely related as multiple previous studies found that blood CD34+ cell concentration before PBSC was consistently associated with the subsequent yield. One striking observation from this analysis was that previously performed association studies are heterogeneous

Despite this, there are sufficient data to identify several important association trends with these donation outcomes.

The long-known association between younger donor age and higher stem cell yield (29), was confirmed in multiple studies assessed in this review irrespective of whether the outcome was higher CD34+ cell concentration or yield. This finding aligns with the conclusion of a recent review of clinical and mobilisation factors (29) although some uncertainty remains because of the inconsistent definitions of 'older age' in prior studies and whether age was considered as a continuous or categorical variable. In the context of expanding demand for allogeneic stem cell donations, there is an increasing requirement to consider older donors. Although evidence from most previous studies raises concern about reduced yield, some studies showed that despite reduced absolute yields from older donors, this did not commonly result in inadequate or failed donations (10, 22, 25). However, safety concerns about using older donors have been raised elsewhere, particularly concerning diminishing telomere length, clonal haematopoiesis risk, and regenerative potential decline in stem cell from older donors (58, 59). CD34+ yield alone may not be the only relevant marker of successful stem cell collection from older donors, suggesting a need for more sophisticated selection algorithms.

In the studies that assessed donor gender, being male was generally associated with higher stem cell yield possibly because of higher donor weight and therefore G-CSF dosing in male compared to female donors (36). Our review also identified that being male was more frequently associated with higher CD34+ cell yield than with higher CD34+ concentration in blood before PBSC. This suggests that part of the effect of being male is at stem cell collection, possibly because male donors typically having higher circulating blood volume enabling higher processed blood volumes during PBSC which was associated with high yield in multiple studies (20, 24, 28, 29, 46). Donor African ancestry was associated with

Associations with ethnicity were sometimes inferred indirectly from studies not primarily designed to examine the effect of this donor factor (35), raising the possibility of bystander effect or bias. The strongest evidence of an effect from ethnicity comes from a retrospective study of 10,776 donors which demonstrated higher CD34+ cell yields in African compared to European ancestry donors, particularly in donors with high BMI (44). This effect was not explained by the higher G-CSF doses received by high BMI donors (44).

Laboratory factors were assessed less frequently than donor clinical factors in the eligible studies included in this review. Our finding of a consistent association between CD34+ concentration in blood before PBSC and subsequent CD34+ cell yield is an important finding as it confirms the importance of measuring CD34+ cell concentration after mobilisation to inform decision making about whether to proceed with PBSC or whether to extend or escalate mobilisation. The two studies identified that identified an association between baseline blood CD34+ cell concentration and CD34+ cell concentration after mobilisation (40, 41) are of particular interest since these suggest that laboratory prediction of stem cell yield could even occur before the start of mobilisation potentially enabling greater personalisation of mobilisation protocols by the addition of other agents such as Plerixafor (60).

Other laboratory factors often associated with CD34+ cell concentration or yield included baseline or pre-PBSC WCC, PLT count and HB concentration. In contrast to analysis of blood CD34+ cell concentration, these are widely and rapidly accessible as part of the FBC test. Mechanistically, these associations may reflect commonality between cellular pathways that mediate CD34+ cell mobilisation and those which regulate the maturation of stem cell into mature blood cells, as has been suggested previously for blood PLT (36). Although our review has identified promising signals for the use of pre-PBSC or even baseline FBC parameters in predicting favourable donation outcomes, the most consistent evidence was

This apparent discrepancy could be explained by the comparatively small number of studies examining associations with CD34+ cell yield, possibly hampering identification of significant associations with this outcome. Further evidence from larger, prospective study particularly of the CD34+ cell yield outcome is required to confirm clinical utility.

Mobilisation and collection factors associated with higher stem cell yields are attractive to identify since these are readily implementable into modified donor protocols. However, amongst the studies evaluated in this review, there were inconsistent findings about the impact of G-CSF dose or dose scheduling on yield but some evidence of an adverse safety signal with higher G-GSF doses (29). G-CSF has a rapid bioavailability resulting in peak plasma levels four hours after administration (61) and a short plasma half-life. Although this suggests a potential advantage of twice daily G-CSF dosing, the pharmacodynamic effect of G-CSF on circulating cell counts is frequently longer than 48 hours, suggesting that twice daily dosing may not be necessary. Moreover, twice daily G-CSF dosing is less tolerable to donors because of injection frequency. Unfortunately, we cannot confirm from existing literature whether once or twice daily dosing is superior for stem cell yield. There was greater consensus indicating superiority of five rather than four days of G-CSF treatment which is in keeping with longitudinal measurement studies of blood CD34+ cell concentrations which suggest that peak cell concentrations are reached by day 5 (27). Despite multiple previous studies, it is difficult to reach robust conclusions about the relationship between collection factors and CD34+ cell yield.

Potentially informative donor factors associated with donation outcomes in adults that are conspicuously absent from the literature are genetic factors, with only a single study examining a potential association with the *CXCL12* gene (30). This is surprising since there is abundant evidence elsewhere of a significant genetic component to CD34+ cell yield. This includes the murine models with strain specific variation in CD34+ yield after mobilisation

No reuse allowed without permission. associated with loci on chromosomes 2 and 11 (62). Several human candidate gene

association studies have also been performed in paediatric or autologous donor populations that implicate multiple loci implicated biologically in the mechanism of G-CSF-induced stem cell mobilisation. These include variants in *VCAM1* (62), *CSF3R* (63, 64), *VLA4* (65), *CD44* (66), and *CXCL12* (57, 67). The importance of variation at these and other potential loci for stem cell mobilisation in adult allogeneic donors remains uncertain but is likely to be an area of future research study.

The strengths of this scoping review are its comprehensiveness and that we have considered two different outcomes of stem cell collection. These include CD34+ cell concentration before PBSC which could potentially be influenced by donor and mobilisation factors. The other outcome, CD34+ cell yield may be influenced by these factors, but also by collection factors and is also the outcome that is directly relevant for recipient outcomes. The main limitation of this review is that even though we have used a scoping strategy, inferences about many candidate factors remain uncertain because of the abundance of retrospective studies with small sample sizes, and the variable definitions of candidate factors and outcomes. A separate review has recently been published that also examined factors associated with stem cell yield, although this only examined associations with CD34+ concentration before PBSC (31). The conclusions of this review largely accord with our study although since we have also examined CD34+ cell yield, we have been able to resolve additional associations with collection factors arising from the process of PBSC.

Our findings are important because they highlight the need for future research particularly focussing on factors such as donor ethnicity and the genetic predictors of yield that are incompletely resolved at present. The future discovery of genetic predictors of successful donation is particularly attractive since it potentially enables better prediction of likely good or poor donors using genetic data at the point donors join registries rather than after donors have undergone mobilisation or collection. Future prospective data collection will enable

No reuse allowed without permission. better identification of predictors of successful donation and better use of these data through approaches such as machine learning (68).

CONCLUSION

Younger age, male gender and having a blood higher CD34+ concentration immediately before PBSC are confirmed as the most robust predictors of CD34+ cell yield following G-CSF mobilisation and PBSC. Many other clinical, mobilisation, collection and laboratory factors show some evidence of association with higher CD34+ cell yield yet require stronger evidence from large, prospective studies to confirm their clinical utility.
