
Notes: This table reports effects on the peak new deaths per day per country transformed on a log scale. Slow to act refers to the number of days a country took to reach a government response index of 40 on a scale from 0 to 100. Degree of government response refers to an index on a scale from 0 to 100. We compute government response lagged at 6 weeks to capture likely effects on deaths in the future. The adjusted model controls for days since first case in a country and an early spike of cases to control for initial growth rates which define the shape of the epidemic curve and mechanically affect later growth rates regardless of policy intervention as well as timing of when a country was first affected by the epidemic. We also include country-level control variables from the World Bank in a few specifications for the dependency ratio to capture the age structure of a given country, population density, health capacity in terms of beds and physicians per capita, and GDP per capita. We further include a specification which accounts for peak deaths in per capita terms.

Notes: This table reports effects on the growth in new deaths per day computed as the log difference. Degree of government response refers to an index on a scale from 0 to 100. We run a regression with the degree of government response lagged by six weeks to more plausibly capture potential effects on deaths as a result of government action. We analyze a comprehensive database with new daily deaths and government actions per day since January 2020 to mid-April. We include time fixed effects to account for the shape of the epidemic curve and exploit country-by-country variation by day to detect the average effect of government action. We also include a specification which controls for country-specific factors to capture potential confounding variables such as population density, wealthy, co-morbidities and other country-specific factors which are correlated with both the spread of the epidemic and potential government responses. Finally, we adjust for the introduction of testing policies by day and country to account for potential bias in deaths attributed to COVID-19 due to increased testing. The adjusted model further controls for days since first case in a country and an early spike of cases to control for initial growth rates which define the shape of the epidemic curve and mechanically affect later growth rates regardless of policy intervention as well as timing of when a country was first affected by the epidemic. We cluster standard errors at the country-level in all regressions to account for autocorrelation. Observations refer to country-day observations.
